That school is on the CAMTC's list of schools they no longer accept. Mr. Zhou applied to the CAMTC and was granted his certification April 2, 2013, which was before they started denying that school. Mr. Zhou then attended Therapeutic Body Concepts from February of 2014 to July of 2014. Staff is requesting that Mr. Zhou's application be tabled pending a background check. Mr. Zhou has handed us a copy of his transcript and it has a couple of differences from the official transcript we received directly from the school.

Diane Huleva, Secretary/Treasurer – I am looking at the transcript and if we add up all the hours and it comes to 1530 hours and not 1000 hours, to me, that says fraudulent.

Ashley Perkins, Applicant – I was 18 and in my genius 18 year old brain I got into a tiff with my mom. She took my phone and I decided to take hers and try to call a cab to go to Reno. She called the cops and I was arrested. I was in jail for a day and she told me that she was dropping the charges and she picked me up.

Robin Graber, Board Member – Have you done any sort of counseling?

Ashley Perkins, Applicant – Yes, we have a good relationship now. At the time things were very heated. I had just moved back from Arkansas. She didn't like my boyfriend

at the time and things escalated quickly. I'm 21 now and I've learned to calm myself instead of rushing into anger and I've grown up.

I did look at the website and ordered books to study from Amazon but they were more geared towards law. I asked my teachers to see if they had ever heard of this test. I took the test and thought I did well, but I did not pass. The option is there to retake it but it is \$1,500. I was hoping the Board could grant me a Probation License and I could show you that my character now is different than it was in my past. I can't change my past, but I have been clean for three years now.

April Whiting, Chairperson – What have you changed?

Sonja Ramirez, Applicant – I go to meetings like Celebrate Recovery, I go to church and I spend my time with my family. I don't hang out with anyone from my past that was a bad influence.
