We have seen this school previously. We have approved licenses without restrictions. This school is not on the Nevada list of school’s we do not accept. This school is Nationally Accredited by the Commission of Massage Therapy Accreditation since 2007. This school is still in business. We did not request attendance records, nor did we request additional information, and yes there is a NCBTMB code.

- c. Review Application of Tobi Marie Lange – Present

Lisa Cooper, Executive Director – Ms. Lange’s application is before you today due to education that was obtained from Dahan. Ms. Lange is requesting to be granted a license under NRS 640C.420, which is a transfer application. We have seen this school previously and we have approved licenses. For newer Board Members, Dahan was a school that closed in the middle of the night. Some of the students were able to get their hours completed, some of the students did not complete their hours so they had to go to other schools to complete hours. There was an issue with Dahan back in, Michael what year?

Michael Smith, Vice Chairperson – 2003.

Lisa Cooper, Executive Director – Ok. They are requesting to be granted a license under NRS 640C.420.

Robin Graber, Board Member – I am sorry, we did accept this schooling before?

Lisa Cooper, Executive Director – We do accept Dahan.

Robin Garber, Board Member – It’s been awhile since we have seen it.

Lisa Cooper, Executive Director – We have not had a Dahan school in forever. She only got 250 hours. This is like a Portfolio Review.

Diane Huleva, Secretary/Treasurer – Tobi, how long have you been practicing Massage?

Tobi Lange, Applicant – I teach Massage but I am not practicing. I would like to practice, but I would like to continue teaching for European Massage School. I was a Colon Hydrotherapist and other therapies. I traveled abroad most of my life; working in South America teaching Yoga and things. I would like to stay here in Vegas and teach.

Diane Huleva, Secretary/Treasurer – When was the last time you were an active Massage Therapist?

Tobi Lange, Applicant – Back in 2000 to 2003. I worked in New Jersey. I was in a spa and worked five days a week and that is what Grandfathered me in to take the National. I passed the National Exam. I have the National Exam based on the work there that I performed in the State of New Jersey for three years. They deemed me having enough hours to make up what I did not have in school.

Walter Lopez, Board Member – I have some issues with the transcript. Especially with the I-Act. I do not know what those hours are for. I do not really see what kind of education this person has.

Diane Huleva, Secretary/Treasurer – From the Dahan School, Walter?

Walter Lopez, Board Member – The Dahan I see is very limited but it's another official I-Act transcript.

Diane Huleva, Secretary/Treasurer – Oh, I see it. From Mind Body Naturopathic Institute?

Walter Lopez, Board Member – Yeah, it says hours complete 100, but it does not indicate what kind of education she has. What is it? I do not know.

Diane Huleva, Secretary/Treasurer – Good point.

Tobi Lange, Applicant – I am a Colon Hydrotherapist. It is to become a Colonic Therapist to do water irrigation in your colon. Is that what you are asking?

Diane Huleva, Secretary/Treasurer – Mind Body Naturopathic Institute, what were those hours for?

Tobi Lange, Applicant – Yes that particular certificate is the Mind Body Naturopathic Institute and that was for the Anatomy and the Physiology. I am sorry I am not sure what you are asking. Do you not understand the transcript?

Diane Huleva, Secretary/Treasurer – We are just trying to clarify for the record. We are looking at the transcript that you gave to us from the Mind Body Naturopathic Institute and under that, it says that you completed 100 hours, and under another

course description you completed 21.30 hours, and we just wanted to get clarification. What was that course for? What kind of classes did you take?

Tobi Lange, Applicant – I understand Walter's concern as to my lack of education based on what Nevada's qualifications are but I am well qualified.

Walter Lopez, Board Member – My concern is also, for example, Anatomy and Physiology for 48 hours. That is the only knowledge according to these transcripts or paper that this person has. No Kinesiology, no Pathology. If we go with what the Board requires for the schools, then 48 hours is not enough.

Robin Graber, Board Member – Were you licensed for Massage Therapy in New Jersey?

Tobi Lange, Applicant – No.

Lisa Cooper, Executive Director – So Board, normally in the past when we have seen an application like this, you have, in the past, granted a license and then asked for a course in Anatomy and Physiology by the renewal. Are you concerned with the Anatomy and Physiology?

Walter Lopez, Board Member – Yes, that is basically my concern. We have a standard amount of hours.

Michael Smith, Vice Chairperson – What exactly do you teach at the school?

Tobi Lange, Applicant – Mostly I teach the Physical Therapy and Sports Therapy Massage. How many hours does the Board require for Anatomy and Physiology?

Lisa Cooper, Executive Director – 125.

Tobi Lange, Applicant – With my I-Act, Anatomy and Physiology is completed.

Walter Lopez, Board Member – I-Act does not specify or break down the hours, it only supplies the total completed hours. It does not state what subject was in those hours.

Lisa Cooper, Executive Director – I think the concern is that the Anatomy and Physiology from that transcript is out of the scope of practice for a Massage Therapist. I think that is what the Board is saying.

Diane Huleva, Secretary/Treasurer – Tobi, how long have you been teaching at European?

Tobi Lange, Applicant – I taught for one full year. So I was going to continue next year in March for another course.

Sandra Anderson, Board Member – Tobi, when was the last time you took a modality workshop?

Tobi Lange, Applicant – 2007-2008.

Sandra Anderson, Board Member – So you have not had any other modality workshops since 2008, is that correct? Tobi we all seek additional education in order to grow within the industry. I am not seeing any training in these transcripts since 2007. What else have you done in the past seven years towards a career in Massage?

Robin Graber, Board Member – And you are teaching students?

Tobi Lange, Applicant – I take workshops all the time.

Motion: Robin Graber made a motion to approve the license with the condition that Ms. Lange takes an Anatomy and Physiology class before her renewal.

Lisa Cooper, Executive Director – For the record, Ms. Lange will receive an unrestricted license with a condition that she will provide our office, upon renewal, with an Anatomy and Physiology 1 class. Out of that Anatomy and Physiology class, the Board will only accept 12 hours of Continuing Education and there will be no roll-over put into the bank.

d. Review Application of Amy Lyons – Present

Lisa Cooper, Executive Director – Ms. Lyons' application is before you today due to education that was obtained in California. Ms. Lyons is requesting to be granted a license under NRS 640C.420. She attended Phillips School of Massage in California. She also attended Truckee Meadow Community College. She does not have a certificate of completion from Phillips School of Massage. We have seen this school previously and we have approved applications from them before. They are not on the Nevada list of schools we do not accept. This school is not Nationally Accredited. This school is no longer in business. We called and there was no answer. We did not request attendance records. We did not ask for additional information, nor is there a NCBTMB number. Ms. Lyons is requesting to be granted a license under NRS 640C.420.

a. Section 32, Senate Bill 68 of the 2015 Legislative Session

i. Transfer Applications, Criminal History and Education Issues

Lisa Cooper, Executive Director – Section 32, Senate Bill 68, changed our law. This was the law that pertained to people that were transferring into Nevada. It requires fingerprints for everyone that transfers into Nevada. The law states we have to give them a denial or approval within 10 days of receiving their background results. We have discussed a waiver that would be included in the initial application packet. This waiver gives the Applicant two options. One option is for the Applicant to waive their right to have a decision within 10 days and have their file scheduled for the next available Board Meeting. If the applicant does not waive their right then the Application goes to the Executive Director and the Board Chairperson for a decision within 10 days of receiving the background results.

b. Request to Add ITEC Exam to NAC 640C.050

Lisa Cooper, Executive Director – ITEC, known as The ITEC Certification program, was intended to be presented at the Board Retreat. The US conversion hours are 500. This allows Licensees to work internationally; more specifically on cruise ships. Nevada would be the only state to accept this exam. Walter Lopez, Board Member – I would like more information about this program before we approve. What exactly is the purpose of this test? Change the curriculum?

Lisa Cooper, Executive Director – This is the only exam that International waters will accept.
