



**Continuing Education Hours Required Based on License Renewal Period**

The Massage Board requires 12 hours of continuing education per year of active licensing.

Initial 2 year renewals will require 12 continuing education hours.

Subsequent 2 year renewals will require 24 continuing education hours.

In other words, if your license expires between now and June 30<sup>th</sup> of 2019, you will need 12 continuing education hours.

After that, you will need 24 continuing education hours each time you renew your license.

Licenses issued for the licensing period beginning July 1, 2018 through June 30, 2020 will be the first to start the new 2 year licensing period.

Renewal Fee:  
\$295 for two years.
