Teresa Lopez motioned to accept that Ms. Zhang was properly and legally noticed, seconded by April Whiting. Motion carried unanimously.

Officer Anton Jerbic was sworn in by Chair Diane Huleva and provided testimony.

Sophia Long submitted a copy of the arrest report into evidence. Chair accepted the evidence.

Teresa Lopez motioned to find Ms. Zhang in violation of NRS.640C.700(4), seconded by Margaret Westcamp. Motion carried unanimously.

April Whiting motioned to find Ms. Zhang in violation of law and the facts have been proven, seconded by Teresa Lopez. Motion carried unanimously.

Elisabeth Barnard motioned to revoke Ms. Zhang license for ten (10) years based on NRS.640C.700(4), seconded by Teresa Lopez. Motion carried unanimously.

Deirdre Strunk recused herself as a former employer and does not feel that she can be unbiased.

April Whiting stated she worked with him in the past and felt she could remain unbiased. April did not recuse.

Teresa Lopez stated she works for an employer that Mr. Cook previously worked for and felt she could remain unbiased. Teresa did not recuse.

Teresa Lopez motioned to accept Voluntary Surrender, seconded by Elisabeth Barnard. Motion carried. Deirdre Strunk recused.

Teresa Lopez motioned to table this application until next available meeting, seconded by Elisabeth Barnard. Motion carried unanimously.

b. Review Application of Nathalie Landry. (For Discussion and Possible Action)

Nathalie Landry was present.

Executive Assistant Tereza Van Horn - Ms. Landry's application is before you today due to potential criminal history that could not be approved administratively. Ms. Landry was arrested in April of 1998 for Solicitation in Pompano Beach, Florida. Ms. Landry is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. Ms. Landry has not had any other arrests since 1998. She has been licensed in Florida since 1999 with no disciplinary actions. Staff's recommendation is to approve a two (2) year probationary license, with a background to be completed each year of renewal at Ms. Landry's expense. If the licensee is arrested for prostitution during the 2 years her license will be revoked for ten (10) years and complete a background check prior to termination of probation paid for by the licensee.

Teresa Lopez motioned to accept staff's recommendation with background check each year at Ms. Landry's expense, seconded by April Whiting. Motioned carried unanimously.

c. Review Application of Yanett Hernandez. (For Discussion and Possible Action)

Yanett Hernandez was present.

Executive Assistant Tereza Van Horn - Ms. Hernandez's application is before you today due to potential criminal history that could not be approved administratively. Ms. Hernandez was arrested in February of 2002 for embezzlement and theft, in April of 2014 for Domestic Battery in Las Vegas, Nevada. The arrest in April of 2014 was later dismissed by the District Attorney. Ms. Hernandez is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. Staff's recommendation is to approve a two (2) year probationary license with a background check annually and prior to termination of probation paid for by the licensee.

Teresa Lopez motioned to accept staff's recommendation with background checks annually at Ms. Hernandez expense, quarterly reporting from her employer to staff and no outcall, seconded by April Whiting. Motioned carried unanimously.

d. Review Application of Charn C. Lee. (For Discussion and Possible Action)

Charn C. Lee was present; Alex Young, interpreter was present.

Executive Assistant Tereza Van Horn - Ms. Lee's application is before you today due to potential criminal history that could not be approved administratively. Ms. Lee was arrested in March 2011 for domestic battery then arrested in July of 2011 for elderly abuse in Henderson, Nevada. Ms. Lee was granted probation for not more than three (3) years. Ms. Lee has completed the conditions of probation and was honorably discharged. Ms. Lee is requesting to be granted a license under NRS 640C.400 or 420

and is before you today for review under NRS 640C.700. Staff's recommendation is to approve a three (3) year probationary license with background checks every year paid for by the licensee.

Teresa Lopez motioned to deny this application under NRS.640C.700(3)(7). No second, motion fails.

April Whiting motioned to approve a three (3) year probation, no hospice or nursing care facility with quarterly reports from employer to staff and background checks annually at Ms. Lee's expense, seconded by Teresa Lopez. Motion carried unanimously.

e. Review Application of Bailing Li. (For Discussion and Possible Action)

Bailing Li was present; Weilin Chang, interpreter was present.

Executive Assistant Tereza Van Horn - Ms. Li's application is before you today due to potential criminal history that could not be approved administratively. Ms. Li was arrested in September of 2008 for prostitution in Paso Robles, California. Ms. Li attended Royal Irvin College in California. She obtained a massage license in New Mexico with education from Royal Irvin College. Royal Irvin College is on CAMTC list of unapproved programs. Ms. Li did not disclose Royal Irvin education on her application. Ms. Li attended and completed additional education at Elbe Institute prior to the school's closure. Ms. Li is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. Staff's recommendation is to deny this application based on NRS 640C.700(1)(4) and (9).

April Whiting motioned to deny the application based on NRS.640C.700(1)(4) and (9), seconded by Teresa Lopez. Margaret Westcamp opposed. Motion carried.

f. Review Application of Pik Yuk Li. (For Discussion and Possible Action)

Pik Yuk Li was present; Allison Jacobs, interpreter, was present; Fred Page, legal counsel, was present.

Executive Assistant Tereza Van Horn - Ms. Li's application is before you today due to potential criminal history that could not be approved administratively. Ms. Li was arrested in January, February and March of 2010 for solicitation or engaging in prostitution and no massage permit in Las Vegas, Nevada. Ms. Li attended East-West Institute of Hand Therapy in California in 2004 and Fuzuba in 2017. Ms. Li did not disclose East-West Institute of Hand Therapy on her application. East-West Institute of Hand Therapy is not an approved program with CAMTC. During Ms. Li's licensure period in Nevada, Ms. Li was given a 45-day suspension with fines of \$2,500.00 and finally voluntary surrendered her license in 2011. Ms. Li applied in 2017 and was denied based off NRS.640C.700(4)(6)(7) and (9). Ms. Li is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700(1)(4)(6)(7) and (9).

Teresa Lopez motioned to deny this application based on NRS.640C.700(1)(4)(6)(7) and (9), seconded by Lorna Benedict. Motion carried unanimously.

g. Review Application of Tiavera Robinson. (For Discussion and Possible Action)

Tiavera Robinson was present.

Teresa Lopez recused herself. Teresa is an instructor at the school Ms. Robinson attended and cannot be unbiased.

Executive Assistant Tereza Van Horn - Ms. Robinson's application is before you today due to potential criminal history that could not be approved administratively. Ms. Robinson was arrested in July and September of 2010 for solicitation or engaging in prostitution in Las Vegas, Nevada. Ms. Robinson is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. Staff's recommendation is to deny this application based on NRS.640C.700(4) and (9).

Margaret Westcamp motioned to discuss a probationary license. Discussion occurred.

Diane Huleva motioned to approve a probationary license for five (5) years with background checks annually at Ms. Robinson costs, no out call, must be employed, monthly reports to staff for the first two years, then go before the Board for re-evaluation, must notify the Board of any changes in employment, if she is arrested automatic revocation for ten (10) years, seconded by Lorna Benedict. Motion carried. Teresa Lopez recused.

Jiahong Yao was present; Alex Young, interpreter, was present; Kirk T. Kennedy, legal counsel, was present.

Executive Assistant Tereza Van Horn - Ms. Yao's Reflexology application is before you today due to potential criminal history that could not be approved administratively. Ms. Yao was arrested for solicitation or engaging in prostitution in Las Vegas during the practice of massage on September of 2007, February 2010 and May of 2010. Ms. Yao previously attended East-West Institute of Hand Therapy in California and Fuzuba in 2018. East-West Institute of Hand Therapy is not an approved program with CAMTC. Ms. Yao has been previously licensed in Nevada. During that licensure period Ms. Yao was given a 90-day suspension and fines of \$1,000.00 followed by a one (1) year probationary license and finally voluntary surrendered her license in 2010. Ms. Yao is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. Staff's recommendation is to deny this application based on NRS640C.700(4)(6) and (9).

Teresa Lopez motioned to deny this applicant based off NRS.640C.400(4)(6) and (9), seconded by April Whiting. Motion carried unanimously.

Elliott Reed, NVMT.3114 and owner of IMR massage – I am asking that the Board consider clarifying that the scope of practice of a licensed massage therapist in Nevada to include the use of "Dry Cupping Therapy" (No use of needles or bloodletting). The Nevada Board of Massage accepts cupping therapy CEU's as continued education by the NCBTMB but doesn't acknowledge it to be in a massage therapists' scope of practice. This technique is safe and with proper training and certification can greatly benefit clients. I am bringing this to the Boards of attention to get ahead of any future senate bill that could limit the practice of a licensed massage therapists in Nevada. Thank you for your consideration and time.
