

Establishment inspections

- * Yearly
- * We aim to inspect 100% of the establishments in the state each year
- * Status of an inspection:
 - * Satisfactory
 - * MNO
 - * OOB
 - * Unsatisfactory
- * Unsatisfactory inspection triggers a follow up inspection 15 business days later

Let's talk about the complaint and investigative process...





How do we receive complaints?

- *Directly from the victim
 - * phone
 - * email
 - * mail
- *Establishments (NAC 640C.090)
- *Law Enforcement
- *News ☺



Now we begin the investigation

- Subpoena records from prior employers and/or law enforcement
- Interview victim(s), licensee, witnesses, managers, etc.

Review the case with legal counsel

- Send a detailed report along with all information to Zi.
- If there is sufficient evidence to prosecute the case, we will receive a Complaint Notice of Hearing to send to the licensee.
- If there is not sufficient evidence to prosecute the case, it will be closed with no action taken.

Why would a case not be heard by the Board?

- The person that committed the offense is not licensed by the NSBMT - citation
- The victim declines to testify
- It is a criminal case that is proceeding through the justice system
- A voluntary surrender is offered/accepted

Confidentiality

NRS 640C.760

Confidentiality of certain records of Board; exceptions.

- 1. Except as otherwise provided in this section and NRS 239.0115, a complaint filed with the Board, all documents and other information filed with the complaint and all documents and other information compiled as a result of an investigation conducted to determine whether to initiate disciplinary action against a person are confidential, unless the person submits a written statement to the Board requesting that such documents and information be made public records.
- 2. The charging documents filed with the Board to initiate disciplinary action and all documents and information considered by the Board when determining whether to impose discipline are public records.
- 3. The provisions of this section do not prohibit the Board from communicating or cooperating with or providing any documents or other information to any other licensing board or any other federal, state or local agency that is investigating a person, including, without limitation, a law enforcement agency. (Added to NRS by 2005, 1133; A 2007, 2144)
