





In response to your decision I have taken the proper time needed to adjust to this result carefully. As I have attempted to explain pre-existing complications due to the event we are in question of. Your decision has thrown me into dangerous territory mentally & physically. Triggering emotional distresses furthering danger and financial damage and difficulty, forcing me into an overwhelming position unfairly but repairable.

Intimidation was not what I expected to happen and how can my life be railroaded in such fashion without proper handling? I did give notification of suspected use of public officials unlawfully. If individuals do not or cannot form mens rea they cannot choose or accuse acts on others. I now can see why the information did not fit or make sense. It was all to plot the whole planned confusion presented, the result is "Preponderance of evidence is Preposterous". To classify me to be disrespectful is assassination of my true character & exploiting my identity is furthering abuse of authority.

I will not assume you are willing participants. Falsified investigation efforts conducted by the North Las Vegas police department was not a well thought plan. I have been harassed and followed constantly for years. My life is in danger more than I could even imagine unknowingly and this is clearly cruel. I apologize if you feel that my interruptions were intended. I felt the misguided information was causing confusion and it was clear to me that you had obtained paperwork I had no knowledge of, falsifying reports, facts being ignored, and using poser's to warp my identity to avoid my defense to this extent is unbelievable. I was only attempting to clear the confusion that looks to me strategically intentional. How am I to defend myself from an investigation I have no knowledge of? I do not & have not any aliases nor do I use social media to exploit anything about myself?

- My rights have been violated to ruthless measures, unfavorable opinions have been formed from fraudulent actions & extortion of my name. Unexplainable clerical errors only contribute to the distorted view & humiliation. To unreasonably form a preconceived notion to be against one person to bombard prejudice is not quite a coincidence and an abnormal reaction. Being that this is a poisonous tree case, I have since then found the reason for the systematic ambush formed to silence my defense and provoke psychological damage. I have a right to prove myself innocent in this situation and I am clearly the only victim of this circumstance unfortunately on purpose. You have based your decision on fraudulently orchestrated information to conclude on a closed case and/or no charged scenario in which also states the deviance was not my act nor did I intend to want any parts of it.
- I am very concerned about public service ethics and until this I was once looked at as professional I would not and have not jeopardized my title in any way. It is actually a part of my life that I take much pride in with all the effort & money I have, to master my skills to a healing level. Using what I say to explain the event nor in confidence when I called with warning to the

I feel it is wrong to punish me for something I did not do at the same time, disabling me physically, mentally, & financially is not a good cause of effort. I was told it was standard procedure to apply as a new applicant instead of original renewal as usual. I agreed because I have nothing to hide. I do not have any aliases nor do I exploit myself on social media. I do have a Facebook page for therapy purposes, all else is exaggerated.

Did anyone check my education background? 20 + years of hardwork and dedication, no lawsuits, violations, or complaints I feel should not be ignored. This is my life to be treated as if non-existent & extinguished by others that are strangers to me. I have done everything needed to comply, to take my livelihood with rushed judgment is cruel punishment and falls in line with double jeopardy. Massage therapy is my main source of income, I take my career very seriously and I am now requesting my title back and deserve to restore my future. This imbalance needs to be evened out and I have realized my codependency on the justice system and was a victim to the prey unexpectedly and will proceed forward more prepared. This cover-up tactic has grown out of proportion, the corruption level exposed is terrifying, but searching for the answers on why and how so many mistakes can be overlooked, excused, fraudulently created and accepted to this extent of court is gross negligence at this point. Counsel, Administrations, Clerks, Secretaries, Norieties,@ City & State level this is way too many people at risk knowingly or not.

(In my defense I have valid proof with no doubt that this cover-up will be exposed with due process. I will continue to seek justice and uphold honor & integrity I have acquired through my parents hardworking and dedicated example Respectably. To be equipped for adversary operations and a stand up for my moral right to be a value.

When this event occurred I was hoping for the right things to happen and wrong things endured resulting with the excessive force. Truly without wasted effort my focus has been on continued education, work experiences, & progress until this collaborative effort to destroy and warp my identity. These treacherous accusations with intent to conspire private party contracts with guilty parties while falsifying special relations is also violation contributing to the dysfunction).

\*[Does anyone know if this case is open?]

(That answer was not on the menu that day & I was blindsided and oblivious to what was happening to me. How am I to protect myself from an investigation unknown to myself but it does explain the strange behaviors not to mention the false statement I paid for that doesn't exist to be printed out. When a public officer willfully submits false reports it is not just a paperwork issue and providing inaccurate information in any capacity while serving the public can and has become more serious in this situation but coupled with dangers of prejudice & distortion. Rule 404 character evidence prohibits use of a person's character or character traits is not admissible to prove that on a particular occasion the person acted in accordance with rumor or stereotype.) Which also includes Digital entrapment.

-(In my defense. It is a must for prosecutor's to provide reasonable notice of such accusations to meet fair opportunity. Let it be clear I am not coming from an instigational standpoint, I am merely in defense of myself.

Workplace bias is real and is a part of continuing education for collateral damage will be reviewed. Let us not contribute to the distorted intention by creating positive outcomes to come. I am hoping to lessen the confusion and casualty account in jeopardy unknowingly. There seems to be a strange hate towards women & children which qualifies as hate crimes against humanity and should be addressed as urgent. It is worse to convict an innocent person than to let criminals go free. In this situation the opposite is displayed and has relentlessly gone too far to the point of unlawfully entering my home and disabling my livelihood. To know that authority figures would go to this extent is frightening.

My importance is not to win or lose, it is who may I help in a damaged nation finding its way back to a United creation referred from common sense living and sharing prayers. I operate in a more structured standpoint with truth to guide my result and start with feedback from the hearing to right these wrongs. This persistence to damage my reputation is opinion in disguise of due process, wasted time & resources with bribery is not justice for all. We did have a conflict but it was resolved before the police showed up. His confusion was clear to me that he had me confused with others that he was a custom to as of IQ. Intervention or mediation was not conducted as stated and medical attention was waved irresponsibly. I did not give any statement, I was not in a relationship to be a jealous girlfriend, nor did he hit me as they insinuated.

When the police arrived I was tackled and held down. The passenger was placed in the police car and the officer came back and joined the others. They then picked me up, walked me to the trash can and busted my face on it and it seemed to me as if they were putting me in it. 2014- Barber Shop, Chair Massage, Server, Home Renovations.

2015- Mobile Massage, Server, Caretaker, Housekeeping, Renovations.

2016- Mobile Massage, Property Management training, Server, Caretaker, & Reiki therapies.

2017- Server, Caretaker, Reiki Therapies. Miscarriage, Pain Management, Acupressure. 2018- Mobile Massage, Server, Caretaker,

Then the occurrence happened with this passenger, certainly an accident not meant to happen. Inmate reform therapies started and ended abrupt. That's when the paid trackers, bribery, court clerk errors, staged events, extortion, false charges, identity theft, & post office violations, using protective services & institutions unlawfully, with Stolen property & Home association fraud. Leaving me with the effects of absence due to excessive force.

2022- Server, Temporary agencies, housekeeping, landscaping, revised future plan while in pursuit to save my career due to the slander for financial ruin campaign.
