2. Introduction of new Board members Bob Oliver from Washoe County and Lorna Benedict representing Structural Integration Practitioners statewide.

Bob Oliver and Lorna Benedict were introduced.

Motioned by Elisabeth Barnard to accept the stipulation that the facts and liabilities have been proven, seconded by Teresa Lopez. Motion carried unanimously.

Motioned by Teresa Lopez for costs not to exceed \$500 payable within 1 year, license suspension of 6 months, ethics course to be taken within 6 months at a school not previously attended, two-year probation with a background check each year, if arrested for solicitation during that 2 years, automatic revocation of license for 10 years. Seconded by Diane Huleva. Bob Oliver opposed. Motion carried.

Tereza VanHorn, Executive Assistant - Ms. Phillip's application is before you today due to education that could not be approved administratively. Ms. Phillips received her education in Ohio. Ms. Phillips attended Heritage College. Heritage College in Columbus, OH closed abruptly citing financial problems on 11/1/2016. Ms. Phillips is requesting to be granted a license under NRS 640C.400 or 420. A background check has been completed.

Motioned by Elisabeth Barnard motioned to accept school and approve application, seconded by Teresa Lopez. Motion carried unanimously.

- c. Review documentation for University of Western California based out of Los Angeles, California. (For Discussion and Possible Action)

- d. Review application for Yubo Wang. (For Discussion and Possible Action)

Yubo Wang was present.

Tereza VanHorn, Executive Assistant – Ms. Wang’s application is before you today due to education that cannot be approved administratively. Ms. Wang attended University of Western California. Ms. Wang is requesting to be granted a license under NRS 640C.400 or 420. A background check was completed. According to NCBTMB University of Western California was denied in 2011 as the Massage program was not approved through the Bureau of Post-Secondary Education. In 2013 their application was considered incomplete. As of today’s date NCBTMB has not received a completed application. CAMTC has issued a corrective action letter for the school, as of the date of this meeting, nothing has been corrected.

Sandy Anderson noted Ms. Wang’s transcripts list 540 hours when the catalog lists 650 hours.

Motioned by Teresa Lopez to deny the school and application, seconded by Lorna Benedict. Bob Oliver opposed. Motion carried.

- e. Review documentation for Marinello School of Beauty based out of Redding, California. (For Discussion and Possible Action)

Items e and f were combined for discussion.

- f. Review application for Nijie Zou. (For Discussion and Possible Action)

Nijie Zou was not present.

Tereza VanHorn, Executive Assistant – Ms. Zou’s application is before you today due to education that cannot be approved administratively. Ms. Zou received her education in Redding, California. Ms. Zou attended Marinello School of Beauty. There is an issue with this application Ms. Zou’s transcript lists her as withdrawn, and states that she completed 546 out of 552 hours. Ms. Wang is requesting to be granted a license under NRS 640C.400 or 420. A background check was completed.

Sandy Anderson noted Ms. Zou’s transcripts states she completed 546 out of 552 hours. She has been unable to obtain a diploma.

Motioned by Teresa Lopez to request to deny the school and the application, motion failed for lack of a second

Motioned by Teresa Lopez to request to deny the application, seconded by Elisabeth Barnard. Motion carried unanimously.

Theresa Taylor was present.

Tereza VanHorn, Executive Assistant – Ms. Taylor’s application is before you today due to education that could not be approved administratively. Ms. Taylor received her education in California. Ms. Taylor attended Concorde Career College. Concorde Career College has not submitted an application for CAMTC approval as they no longer offer a massage program as of January 2011. Ms. Taylor is requesting to be granted a license under NRS 640C.400 or 420. A background check has been completed

Motioned by Elisabeth Barnard to approve the school and application, seconded by Margaret Westcamp. Motion carried unanimously.

- i. Review documentation for Center Point Massage and Shiatsu Therapy School and Clinique based out of Saint Louis Park, Minnesota. (For Discussion and Possible Action)

Ryan Huffman was present.

Tereza VanHorn, Executive Assistant – Mr. Huffman’s application is before you today due to education that could not be approved administratively. Mr. Huffman received his education in Minnesota. Mr. Huffman attended Center Point in St. Louis Park, Minnesota. Mr. Huffman is requesting to be granted a license under NRS 640C.400 or 420. A background check has been completed.

Motioned by Teresa Lopez to approve Center Point Massage and Shiatsu Therapy School and application, seconded by Elisabeth Barnard. Motion carried unanimously.

Ms. Ainsworth is requesting to be granted a license under NRS 640C.400 or 420. A background check has been completed.

Motioned by Diane Huleva to approve the school and application, seconded by Lorna Benedict. Motion carried unanimously.

a. Review Application of Freeman M. McWilliams. (For Discussion and Possible Action)

Freeman M. McWilliams was not present.

Sandy Anderson, Executive Director – Mr. McWilliams application is before you today due to potential criminal history that could not be approved administratively. Mr. McWilliams is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. It is my recommendation to deny this application. Mr. McWilliams was arrested in 2009 for threat to commit a crime and terrorism, pled down to vandalism. He received 24 months of probation. In 2011 he got one count of gang activity which was also pled down, and he got 36 months of probation. His most recent arrest was November 8<sup>th</sup> of 2016 it was one count of domestic battery, he pled down to 120 days in jail, a fine of \$200 and 250 hours of community service.

Motioned by Teresa Lopez to deny this application pursuant to NRS 640C.700(3)(9), seconded by Diane Huleva. Motion carried unanimously.

Sandy Anderson, Executive Director - Ms. Pinta's application is before you today due to potential criminal history that could not be approved administratively. Ms. Pinta is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700.

Motioned by Teresa Lopez to deny this application pursuant to NRS 640C.700(4)(6)(7)(9), seconded by Lorna Benedict. Motion carries unanimously.

c. Review Application of Pik Yuk Li. (For Discussion and Possible Action)

Pik Yuk Li, Chester NG, Interpreter, Aaron Aquino, Legal Counsel. Pik Yuk Li and Chester NG was sworn in by April Whiting.

Sandy Anderson, Executive Director – Ms. Li's application is before you today due to potential criminal history that could not be approved administratively. Ms. Li is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700. It is my recommendation to deny this application based on the failure to disclose prior disciplinary action.

Aaron Aquino, Legal Counsel – Ms. Li was under the belief that having her records sealed meant that she did not have to disclose that information. Previous criminal history was 7 years ago ended with trespassing.

Motioned by Teresa Lopez to deny this application pursuant to NRS 640C.700 (4)(6)(7)(9), seconded by Elisabeth Barnard. Motion carried unanimously.

d. Review Application of Yuxia Li. (For Discussion and Possible Action)

Yuxia Li was not present.

Sandy Anderson, Executive Director - Ms. Li's application is before you today due to potential criminal history that could not be approved administratively. Ms. Li is requesting to be granted a license under NRS 640C.400 or 420 and is before you today for review under NRS 640C.700.

Motioned by Teresa Lopez to deny this application pursuant to NRS 640C.700(1)(9)(10), seconded by Elisabeth Barnard. Motion carried unanimously.

Motioned by Teresa Lopez to approve \$20,000.00 to investigate illegal activity within the establishments across Nevada, seconded by Elisabeth Barnard. Motion carried unanimously.
