ORDER FOR PROBATION

Licensed Massage Therapist
License No. NVMT.10452

IT APPEARING on June 10, 2020, Raeann M. Rigiroszi (“Rigiroszi”) appeared before the Nevada Board of Massage Therapy (“Board”) for an application review.

The Board granted Rigiroszi a license to practice massage therapy and immediately placed Rigiroszi’s license on probation for a period of four (4) years.

ORDER


IT IS HEREBY ORDERED:

1. Rigiroszi will attend probation orientation.
2. Rigiroszi shall submit to a background check within one year of the date of this Order, within two years of the date of this Order, within three years of the date of this Order and within four years of the date of this Order at Rigiroszi’s expense.
3. Rigiroszi must refrain from providing outcall services.
4. Rigiroszi must complete an ethics course within 90 calendar days of licensure.
5. Rigiroszi must report all contact with law enforcement personnel within forty-eight (48) hours after such contact occurs.
6. Rigiroszi must notify the Board of any changes in her employment within 10 calendar days.
7. Rigiroszi must provide any changes in address or phone number to the Board office within 10 calendar days.
8. Rigiroszi will submit employment offers to the staff of the Board for review and approval.
9. Rigiroszi must cooperate fully with the Board staff to administrate terms of her probation.
10. Rigiroszi is responsible for all administrative fees incurred by the Board as a result of her probation compliance.
11. Rigiroszi is to comply with all laws governing massage therapy.

- 1 12. This order shall not be construed as excluding or reducing any criminal or civil penalties or
2 sanction or other remedies that may be applicable under federal, state or local laws.
- 3 13. Rigiroszi's license shall be marked "Restricted" throughout the probationary period.
- 4 14. Rigiroszi shall meet with the Board or its representatives upon request and shall cooperate
5 with representatives of the Board in her supervision and investigation of Rigiroszi's
6 compliance with the terms and conditions of this Order.
- 7 15. This Order will become part of Rigiroszi's permanent record, will become public
8 information, will be published with the list of disciplinary actions the Board has taken,
9 and may be reported to any national repository which records disciplinary action taken
10 against licensees or holders of certificates or any agency or another state, which regulates
11 the practice of massage therapy. The Board may use the Order in any subsequent hearings.
- 12 16. Rigiroszi acknowledges that if she violates one or more of the terms of this Order, the
13 Board may revoke or invoke other appropriate discipline against her license to practice
14 massage therapy; subject only to the requirement that the Board shall, prior to such
15 disciplinary action, conduct a hearing in accordance with Chapters 233B, 622A, and 640C
16 of the Nevada Revised Statutes for the limited purpose of establishing that there has, in
17 fact, been a violation of the requirements of this Order. In the event that a violation of this
18 Order is alleged, Rigiroszi agrees to surrender her license to the Executive Director, if so
19 requested, and refrain from practicing as a massage therapist until an entry of a final order
20 of the Board or a court of competent jurisdiction, whichever last occurs, regarding the
21 potential violation. Rigiroszi agrees to waive her right to appeal the substantive legal
22 basis of the disciplinary action. In the event an alleged violation of this Order is taken to
23 hearing and the facts which constitute the violation are determined to be not proven, no
24 disciplinary action shall be taken by the Board.
- 25 17. In the event other misconduct is reported to the Board, this Order may be used as evidence
26 against Rigiroszi to establish a pattern of behavior and for the purpose of proving
27 additional acts of misconduct.
- 28 18. Nevada State Board of Massage Therapy retains jurisdiction in this case until all conditions
have been met to the satisfaction of the Board.

Management Analyst Tereza Van Horn - Ms. Rigiroszi's massage application is before you today due to potential criminal history that could not be approved administratively. Ms. Rigiroszi was arrested on September 28, 1997 by Pueblo Police Department for DUI/DWAI; April 11, 1999 by Pueblo Police Department for Assault; June 13, 2000 by Pueblo Police Department for DUI; May 26, 2011 by Henderson Police Department for Battery/Domestic Violence and April 9, 2015 by Las Vegas Metro Police Department for DUI. Ms. Rigiroszi is requesting to be granted a license under NRS 640C.580 or 420 and is before you today for review under NRS 640C.700. Staff's recommendation is to deny this application or approve a probationary license for four (4) years with restrictions.
