Dear Mr. Wilson:

As discussed at probation orientation on November 19, 2019; you are to submit to a background check every twelve (12) months at your expense.

On August 27, 2020; you were noticed by mail to have your fingerprints completed with an invoice included in the envelope.

On September 5, 2020; You requested to delay payment for the required background check. Approved by the Executive Director, she allowed for a payment due in 30 days.
