Mr. Edmonds' massage application is before you today for review that could not be approved administratively. Mr. Edmonds applied for licensure in June of 2018 and was denied in 20019 for not responding within 60 days to staff's requests. Mr. Edmonds was arrested on July 11, 1999 for aggravated battery by Aurora Police Department (APD) and September 5, 2012 for domestic battery by Rolling Meadows Police Department (RMPD). Mr. Edmonds is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Board Meeting Application review:

Summary of Gregory N. Edmonds arrests/charges:

9/5/2012 – Arrested for domestic battery by Rolling Meadows PD. No disposition listed on background report.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. No written narrative or court disposition items were received.

Written narrative from Rolling Meadows PD. Officers were dispatched to incident location reference a domestic battery that occurred. The subject was identified as Mr. Edmonds. We noticed him walking outside near the location. He had blood on the bock of his shirt. I asked him what had happened inside the apartment. He stated his roommate (XXXX) and he used to date. They ended their relationship, but they still reside together. Today they got into an argument about cleaning the apartment. XXXX became upset because Edmonds didn't clean up the kitchen table. XXXX then grabbed Edmonds cell phone and wouldn't give it back. Edmonds then tried to grab the phone from XXXX and accidently struck him in the nose. XXXX dropped the phone so Edmonds pick it up. Edmonds started walking out of the apartment when XXXX jumped on his back trying to keep Edmonds from leaving. Edmonds then pushed him away and walked out of the apartment.

Once officer stayed with Edmonds while the other went to the apartment to speak with XXXX. XXXX had a cut on his nose and his nose was bloody and swollen. The paramedics were called to the scene and were treating him. XXXX refused to go to the hospital, the paramedics gave him an ice pack for his swollen nose. XXXX stated Edmonds and he were arguing over the cleaning of the apartment. Edmonds wasn't doing anything so XXXX took his phone. Edmonds became upset and punched him twice in the nose with a closed fist. Edmonds grabbed the phone with XXXX dropped it and started waking out of the apartment. XXXX not thinking jumped on Edmonds back, but was pushed off. Edmonds then left the apartment. XXXX stated he would like to sign a complaint against Edmonds for battery.

At the station Edmonds was read his Miranda warning. He stated he understood them and was willing to talk. He replied, "I told you before, I hit him, but it was an accident." I advised him that he will be processed for domestic battery and will be placed in a cell.

1/13/2011 — Arrested for possession of cannabis, insurance — operate uninsured and speeding over statutory limit by Montgomery PD. Disposition documents received from Edmonds, indicates a guilty plea was entered. Fines and/or fees of \$685.00 were assessed. Disposition on background report indicates charge was amended or reduced.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. Court disposition is included in packet. No written narrative was received.

2/6/2010 - Arrested for possession of cannabis/paraphernalla by Naperville Police Department. Disposition documents received from Edmonds, indicates a guilty plea was entered. Fines and/or fees of \$500.00 were assessed.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. Court disposition is included in packet. No written narrative was received. Arrest not listed on background.

3/26/2006 - Arrested for Driving on a susp/revoked license and insurance – operate uninsured by Aurora PD. Disposition on background report indicates sentencing to fine and/or cost of \$150.00 supervision for 3 months; supervision dismissed.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. No written narrative or court disposition items were received.

3/10/2006 – Arrested for Driving on a susp/revoked license by Yorkville Sheriff's office. Disposition on background report indicates sentencing to fine and/or cost of \$90.00 supervision for 6 months; supervision dismissed.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. No written narrative or court disposition items were received.

3/11/2004 - Arrested for man/del control substance by Stateville Corr Center Joliet, IL. No disposition listed on background report.

4/23/2003 – Arrested for man/del control substance by Stateville Corr Center Joliet, IL. Disposition on background report indicates released on parole on 12/22/2004 – discharge date.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. No written narrative or court disposition items were received.

7/19/2001 – Arrested for man/del control substances/cocaine by Naperville Police Department.
Disposition documents received from Edmonds, indicates a guilty plea was entered. Fines and/or fees of \$4,517.00 were assessed. Disposition on background report indicates charge was amended or reduced.

*Staff requested disposition and written narrative on July 17, 2018, March 6, 2019 and May 14, 2021. Court disposition is included in packet. No written narrative was received.

7/11/1999 – Arrested for aggravated Battery and possession of cannabis (less than 2.5 grams) by Aurora Police Department. Disposition on background report indicates nolle was plead on both charges. 2nd arrest for aggravated battery was amended or reduced.

Received documents from Aurora Police department indicate Mr. Edmonds was guilty of aggravated battery/resisting arrest on two peace officers during a traffic stop.

Narrative from Aurora PD: On 7/11/1999 at 0055 hours, I Ofc. XXX made a stop on a vehicle driven by the offender Edmonds for driving without lights when required. Upon meeting with the offender Edmonds, I asked him for his license and proof of insurance, which he could not provide. I then ran the name that he gave me (Phillips, XXX.X). which came back clear and valid. I then re-approached the

vehicle and asked the offender to step out of the vehicle and step to the rear of the vehicle. I then attempted to place the offender under arrest for the above charges, I placed a hand cuff on the right wrist and asked him to remove a bracelet from his left wrist to avoid injury to his wrist. At this point, the offender looked into the vehicle while another officer was doing an inventory search, incident to a tow. When the offender noticed another officer looking into, the center console, he attempted to escape with me holding one of the cuffs and the other still on his right wrist. I then called the other officer for help and he ran to my aid. It took several minutes to subdue the offender and both me and the other officer sustained minor cuts and abrasions which we had to be treated at Mercy Center Hospital. The items that the other officer found in the center console was a small plastic bag containing a green leafy substance which later tested positive for the presence of marijuana, using the Duquenois Levine Reagent test kit. The Marijuana weighed approximately 2.9 grams.

10/30/1997 – Arrested for Possession of Cannabis by Aurora Police Department. Disposition on background report indicates Guiltye-sentenced to fine and/or costs of \$2970.00 with probation of 30 months. Terminated unsatisfied. Disposition document in packet indicates Mr. Edmonds plead nolle to the arrest and was given probation.




