BACKGROUND INFORMATION:

Ms. Ferguson's massage application is before you today for review that could not be approved administratively. Ms. Ferguson was arrested on July 14, 2009 for DUI by Riverside Sheriff's Office; July 18, 2010 forælriving on a suspended license with an unrestrained child by San Bernardino Sheriff's office; October 15, 2011 for disorderly conduct by Riverside Sheriff's office; March 11, 2015 for domestic battery and battery by Las Vegas Metropolitan Police Department (LVMPD). Ms. Ferguson is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Board Meeting Application review:

Summary of Bobi L. Ferguson arrests/charges:

5/1/2017 (arrest 7/14/2009) - Balance paid by Ms. Ferguson of \$962.97.

03/11/2015 – Arrest by Las Vegas Metropolitan Police Department (LVMPD) fortDomestic Battery andtBattery. Received written statement from Ms. Ferguson. We did not receive court disposition or fee information from Ms. Ferguson.

Statement provided by LVMPD. Victim and Ferguson live together. Victim contacted police to report a battery. Investigation revealed the following: On 3/11/2015 at about 1235 hours, Ferguson was at home on her lunch break from work. An argument begantbetween the two over an incident that had occurred the night before.tVictim states thatshe was on the phone with a friend while this was going on. Victim states that she was seated on the couch, andtFerguson wastyelling in her face.tVictim states that she tried to get up and go outside to get away from Ferguson. Victim states that when she tried to go outside, Ferguson grabbed her by the face and neck andttried to keep her from leaving. Victim states that during this struggle Ferguson scratched her on the right upper breast area, leaving a red mark. Victim then made it out the door, and Ferguson grabbed her hair and tried to pull her back inside. Victim states that she yelled for help several times, tbut nobody came to help her. Victim states that Ferguson then left and went back to work at the Ace Hardware store across the street from the apartment.

Victim filled out a voluntarytstatement and digital photos were taken of victim's injuries. Offers went to the Ace Hardware to try to locate Ferguson but she was not there.

Once contact was made and probable cause does exist for the arrest oftBobi Ferguson. Bobi was placed into custody andt transported for Battery Domestic Violence.

Victim and Ferguson have a mother/daughter relationship.

5/7/2012 (arrest 7/18/2010) – Hearing held. Judge issues warrant for probation violation. Defendant admits to violation of probation as to count 1. Court finds defendant in violation of probation. Court orders 10 days service in lieu of jail imposed on 9/8/2010 vacated as to count 1; Court orders defendant committed to 10 days in jail imposed on 9/8/2010 as to count 1. Defendant remanded to the custody of the sheriff.tArrested for probation violation by Santa Ana Sheriff's office.

4/19/2012 (arrest 7/14/2009) – Judge issues updated probation terms to include Committed to Custody of Riverside Sheriff for an additional term of 30 days. Sentenced to Riverside County Jail for the termtof#1 days. Defendant to surrender to commence jail sentence of 41 days. Background indicates: Arrested for DUI by Riverside Sheriff's office.

3/6/2012 (arrestt7/14/2009) - Warrant issued for Ms. Ferguson.

3/1/2012 (arrest 7/14/2009) – Probation Violation Hearing held. Bench warrant to be issued.

1/26/2012 (arrest 7/14/2009) – Program termination – Failure to Appear. Did not report to Sheriff's Labor Program on or prior to deadline.

12/8/2011 (arrest 7/14/2009) – Judge issues updated probation terms: Committed to custodytoftRiverside Sherifffortan additional term of 5 days and 11 days to be served in the Sheriff's Labor Program.tReport on or before 12/29/2011.tHard Labor/ Outtof County Program terminated.

12/6/2011 (arrest 7/18/2010) – Probation order revoked; Probation violation warrant issued.

11/14/2011 (review 7/18/2010) – Arrested fortdriving on suspended license by San Bernardino Sheriff's office. Court documents were requested on August 30, 2021. No documents were received regarding this request. 11/2/2011 (arrest 7/14/2009) – Allegation of violation of probation.

10/15/2011 – Arrested for Disorderly conduct by Riverside Sheriff's office. Court documents were requested on August 30, 2021. No documents were received regarding this request.

7/27/2011 (arrest 7/18/2010) – Judge issues updated terms of probation. Complete 2-day(s) Cal Trans as directed by OneOC as Count 1; Court stays completion of 2 days CalTrans/Physical Labor pending no further violations of probation; Community Service in lieu of jail further stayed to 10/27/2011 for proof of completion.

7/7/2011 (arrest 7/18/2010) – Hearing held. Judge issues warrant for failure to complete Cal Trans/Physical Labor and sets bail at \$15,000.00.

6/28/2011 (arrest 7/18/2010) - Notice of failure to complete Cal Trans/Physical Labor filed.

3/28/2011 (arrest 7/14/2009) – Judge issues updated probation terms: Community service of 283 hours must be completed on or before 10/11/2011; Proof of Hard Labor completion on or before 10/11/2011, submit completion of 1^{st} offender DUI program; report to Enhanced Collection Division within 2 business days.

1/4/2011 (arrest 7/14/2009) – Probation arraignment hearing. Violation for not receiving of payment as previously ordered, failure to complete community service and failure to appear. Warrant issued and bail set at \$5,000.00.

12/2/2010 (arrest 7/14/2009) – allegation of violation of probation.

9/8/2010 (arrest 7/18/2010) – Hearing held. Defendant present. Defendant pleads guilty to count 1 and placed on 3 year informal probation with the following terms: Violate no law; do not drive without a valid drivers license in your possession; Do not drive without proofoof valid auto liability insurance or financial responsibility as required by law; fines of \$300.00 plus penalty assessments as to count 1; pay \$295.00 in additional fee's; Ordered to report to the Harbor-Newport Beach Facility Collections while cooperating with and pay as directed by Collections department: serve 10 days in Orange County Jail as to count 1 (Credit for time served); Complete 10 days Cal Trans/physical Labor in lieu of 10 days jail as directed by Volunteer Center as to count 1; install Ignition interlock device as to count 1 on any vehicle defendant owns, operates or drives for 1 year; defendant notified to submit proof of installation of certified Ignition Interlock device; Defendant ordered to report to volunteer center forthwith; count 2 dismissed.

8/27/2010 (arrest 7/18/2010) – Hearing held – Defendant did not attend. Bench warrant issued.

7/18/2010 (Record not on background) – Driving on a suspended license and parent of guardian permitting child to be transported without seatbelt.

5/12/2010 (arrest 7/14/2009) - The remainder balance of \$1582.00 was converted to community service hours.

3/25/2010 (arrest 7/14/2009) - Probation violation issued. Violation for failing to complete First Offender DUI program for 4 months and to pay program fees. Probation to continue with additional terms. Add: Re-enroll in 1st offender DUI program, ordered to report to financial services for an evaluation and ordered to return on any and all future hearing dates.

10/16/2009 (arrest 7/14/2009) - Judge ordered Ms. Ferguson probation for a period of 36 months with the following terms: payment arrangement of \$75.00 per month due on the 15th until paid in full; obey all laws, ordinances and court orders; be committed to custody for 6 days; RSO weekender program (Community service); Credit for time served; pay fines and other fees for a total \$1,582.00; Do not drive with alcohol in your blood within 6 hours of consuming alcohol; do not drive unless properly licensed nor without insurance or valid registration; attend and satisfactorily complete a

First Offender DUI program for 4 months; submit to chemical test of blood, saliva, breath or urine or any reasonable physical test upon request of any probation or law enforcement officer.

7/14/2009 - DUI by Riverside Sheriff's office.

6/27/2005 - Report by LVMPD was taken for Battery/Domestic Violence. No arrest.

Statement provided by LVMPD. Upon arriving and after talking to both parties it was not determined who was primary aggressor. One female has a 7-month-old, and one female has a one-year-old. Both parties are driving back to California and due to the above a report was taken. Both females with young children. No TPO, no temporary housing, no photos, no suspect, no primary aggressor.



FINGERPRINT BACKGROUND WAIVER

As an applicant who is the subject of a Federal Bureau of Investigation (FBI) fingerprint-based criminal history record check for a noncriminal justice purpose you have certain rights which are discussed below.

1. You must be notified by the Nevada State Board of Massage Therapy that your fingerprints will be used to check the criminal history records of the FBI and the State of Nevada.

2. If you have a criminal history record, the officials making a determination of your suitability for the job, license or other benefit for which you are applying must provide you the opportunity to complete or challenge the accuracy of the information in the record. You may review and challenge the accuracy of any and all criminal history records which are returned to the submitting agency. The proper forms and procedures will be furnished to you by the Nevada Department of Public Safety, Records Bureau upon request. If you decide to challenge the accuracy or completeness of you FBI criminal history record, Title 28 of the Code of Federal Regulations Section 16.34 provides for the proper procedure to do so:

16.34 - **Procedure to obtain change, correction or updating of identification records.** If, after reviewing his/her identification record, the subject thereof believes that it is incorrect or incomplete in any respect and wishes changes, corrections or updating of the alleged deficiency, he/she should make application directly to the agency which contributed the questioned information. The subject of a record may also direct his/her challenge as to the accuracy or completeness of any entry on his/her record to the FBI, Criminal Justice Information Services (CJIS) Division ATTN: SCU, Mod. D-2, 1000 Custer Hollow Road, Clarksburg, WV 26306. The FBI will then forward the challenge to the agency which submitted the data requesting that agency to verify or correct the challenged entry. Upon the receipt of an official communication directly from the agency which contributed the original information, the FBI CJIS Division will make any changes necessary in accordance with the information supplied by that agency.

3. Based on 28 CFR § 50.12 (b), officials making such determinations should not deny the license or employment based on information in the record until the applicant has been afforded a reasonable time to correct or complete the record or has declined to do so.

4. You have the right to expect that officials receiving the results of the fingerprint-based criminal history record check will use it only for authorized purposes and will not retain or disseminate it in violation of federal or state statute, regulation or executive order, or rule, procedure or standard established by the National Crime Prevention and Privacy Compact Council.

5. I hereby authorize **Nevada State Board of Massage Therapy**, to submit a set of my fingerprints to the Nevada Department Public Safety, Records Bureau for the purpose of accessing and reviewing State of Nevada and FBI criminal history records that may pertain to me.

In giving this authorization, I expressly understand that the records may include information pertaining to notations of arrest, detainments, indictments, information or other charges for which the final court disposition is pending or is unknown to the above referenced agency. For records containing final court disposition information, I understand that the release may include information pertaining to dismissals, acquittals, convictions, sentences, correctional supervision information and information concerning the status of my parole or probation when applicable.

6. I hereby release from liability and promise to hold harmless under any and all causes of legal action the State of Nevada, tis officer(s), agent(s) and/or employee(s) who conducted my criminal history records search and provided information to the submitting agency for any statement(s), omission(s), or infringement(s) upon my current legal rights. I further release and promise to hold harmless and covenant not to sue any persons, firms, institutions or agencies providing such information to the State of Nevada on the basis of their disclosures. I have signed this release voluntarily and of my own free will.


