## Narrative

Body camera recording available:

On September 2nd 2019 I, Officer W. McLain P#16833, was operating as marked/uniform patrol unit 2M34TV. At approximately 1300 hours I was dispatched to a sexual assault call at Treasure Island 3300 S. Las Vegas Blvd. Las Vegas, NV 89109. Details stated a female was touched inappropriately during a massage she received at the Treasure Island spa.

I arrived and made contact with the victim, [REDACTED]. [REDACTED] stated that at approximately 1200 hours she went to the Treasure Island spa to get a massage. [REDACTED] stated she has received massages at this spa before, and has received dozens of massages in the past as she used to work at Message Envy for 5 years. Her masseuse giving the massage is the suspect, Carnell Upchurch. [REDACTED] stated that while receiving her massage, she was wearing only underwear and was covered by a towel. [REDACTED] stated that during the first portion of the massage, she was on her stomach facing down, and Upchurch was massaging her legs and back. [REDACTED] first complaint was that during this part of the massage, Upchurch slipped his finger tips under her underline while massaging her legs. She stated it might have been on accident, as only Upchurch finger tips barely went under her underwear on the sides, and by her butt cheeks. [REDACTED] stated she did not say anything, and the massage continued as normal. During the next part of the massage, [REDACTED] was laying on her back and facing up. Towards the end of the massage, Upchurch was massaging [REDACTED] upper chest and pec area. [REDACTED] stated that Upchurch was standing behind her, and then used his right hand to touch the outer portion of her left breast. She stated that he touched her breast, but did not grab it or the nipple. The massage continued and a short time later Upchurch did the same to [REDACTED] right breast, using his left hand. [REDACTED] stated that the massage ended shortly after. [REDACTED] said she did not stop the massage because she was in disbelief and scared to say anything. After the massage ended [REDACTED] made a complaint to the front desk of the spa. The spa contacted security to investigate the complaint. When [REDACTED] returned to her hotel room she contacted metro police directly.

The suspect, Carnell Upchurch was sent home by management and not on scene to interview.

I contacted the spa front desk who stated Upchurch has been a masseuse for several years, and has been employed with Treasure Island since mid 2017 and has not had any complaints in that time.

CCAC Patrol detectives responded to the scene and interviewed [REDACTED].

Crime scene analyst Laura Cornell P#13576 responded to the scene to attempt to get DNA from [REDACTED] breast.

Due to the fact Upchurch allegedly touched [REDACTED] breast in a sexual manner without her consent, a report was taken for "Open / Gross Lewdness". CCAC Patrol Detectives are on scene and continuing the investigation at this time.
