**COMPLAINT AND
NOTICE OF HEARING**

The Nevada State Board of Massage Therapy (Board), by and through its Executive Director, Sandra Anderson, hereby notifies Maurice A. Wilson (“Respondent”) of an administrative hearing, which is to be held pursuant to Chapters 233B, 622, 622A of the Nevada Revised Statutes (NRS) and 640C of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC). The purpose of the hearing is to consider the allegations stated below and to determine if the Respondent should be subject to an administrative penalty as set forth in NRS 640C.710, if the stated allegations are proven at the hearing by the evidence presented.

Respondent is currently and at all times mentioned herein, licensed as a massage therapist in the State of Nevada and is therefore, subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C.

IT IS HEREBY ALLEGED AND CHARGED AS FOLLOWS:

ALLEGED FACTS

1. On or about October 30, 2019, Respondent appeared before the Board for regarding his license application that by Board policy, could not be administratively approved.
2. The Board approved a three-year probationary license that included:
 - a. No outcall services;
 - b. That he submit to annual background checks at his own expense;
 - c. Must complete an ethics course within ninety (90) days of the licensure; and
 - d. That he cooperate with Board staff during probation.
3. As of today, Respondent:
 - a. Has not paid for the costs associated with a background check; and
 - b. Has not cooperated with Board staff.

1 **VIOLATIONS OF LAW**

2 **COUNT ONE**

3 4. By not providing payment for the cost associated with the background check, Respondent
4 has not complied with the terms of his probation, and therefore, Respondent violated the
5 provision of NRS 640C.700(13) and/or (9). This is grounds for discipline pursuant to NRS
6 640C.700(2).

7 **COUNT TWO**

8 5. By failing to respond to the Board's request for information within 60 days, Respondent
9 violated the provision of NRS 640C.700(8) and/or (9). This is grounds for discipline
10 pursuant to NRS 640C.700(2).

11 **PRAYER FOR RELIEF**

12 WHEREFORE, Executive Director, Sandra Anderson, prays as follows:

13 6. That the Board conduct a hearing on this complaint as provided by statute, and after such
14 hearing, that the Board impose upon Respondent the discipline permitted by NRS
15 640C.710, which may include the following, (a) the imposition of an administrative fine of
16 not more than \$5,000.00 per violation, (b) recovery of reasonable investigative fees and costs
17 incurred, (c) recovery of attorney fees pursuant to NRS 622.400, (d) licensee be publicly
18 reprimanded, (e) suspend, revoke or place conditions on the licensee's license, (f) place the
19 licensee on probation, and/or (g) such other impositions as may be permitted by Nevada law.

21 PLEASE TAKE NOTICE that a disciplinary hearing has been set to consider this
22 Administrative Complaint against the above-named Respondent in accordance with Chapters
23 233B 622, 622A and 640C of the Nevada Revised Statutes.

24 THE HEARING WILL TAKE PLACE on **Tuesday, August 17, 2021, commencing at 9:00**
25 **a.m.** or as soon thereafter as the Board is able to hear the matter with video conferencing by Zoom.

3 PURSUANT TO NRS 622A.320, Respondent may, but is not required to, file an answer to
4 this Complaint with the Board.

5 PURSUANT TO NRS 622A.330, Respondent may seek limited discovery from the Board.

6 As the Respondents, you are specifically informed that you have the right to appear and be
7 heard in your defense, either personally or through counsel of your choice. You have the right to
8 respond and to present relevant evidence and argument on all issues involved. You have the right to
9 call and examine witnesses, introduce exhibits, and cross-examine opposing witnesses on any matter
10 relevant to the issues involved.

11 You have the right to request that the Board issue subpoenas to compel witnesses to testify
12 and/or evidence to be offered on your behalf. In making this request, you may be required to
13 demonstrate the relevancy of the witnesses' testimony and/or evidence.

14 The purpose of the hearing is to determine if the Respondent has violated the provisions of
15 Chapter 640C of NRS and if the allegations contained herein are substantially proven by the evidence
16 presented to further determine what administrative penalty is to be assessed against the Respondent,
17 if any, pursuant to NRS 640C.710.

18 Should the Respondent fail to appear at the hearing, a decision may still be reached by the
19 Board. As the Respondent, you are further advised that you may be charged with the attorney's fees
20 and/or costs associated with the hearing pursuant to NRS 622.400.


21 Pursuant to NRS 233B.121(5), informal disposition of this case may be made by stipulation,
22 agreed settlement, consent order, or default. Any attempt to negotiate this case should be made by

24 Pursuant to NRS 241.033(2)(b), the Nevada State Board of Massage Therapy may, without
25 further notice, take administrative action against your license and/or certificate to practice within the
26 State of Nevada if the Board determines that such administrative action is warranted after considering
27 your character, alleged misconduct, professional competence, or physical or mental health.
