### BACKGROUND INFORMATION:

Ms. Song's massage application is before you today due to potential criminal history that could not be approved administratively. Ms. Song was arrested on February 4, 2003 and October 11, 2002 by Las Vegas Metropolitan Police Department for Soliciting or Engaging in Prostitution. Ms. Song was cited on June 5, 2001 for soliciting prostitution and practicing without a massage permit; May 4, 2006 for practicing massage without a health card by Las Vegas Metropolitan Police Department. Ms. Song is requesting to be granted a license under NRS 640C.580 or 420 and is before you today for review under NRS 640C.700. Staff's recommendation is to deny this application based on NRS 640C.700(1)(4)(6) & (9).

Board Meeting Application review:

Summary of Guoli Song/Wachholder arrests/charges:

5/4/2006 – Ms. Song was cited by LVMPD. Ms. Song was performing massage at 5000 W. Oakey at Fantasy Massage on 5/4/2006 at 10:50 pm. Ms. Song was cited for not having a health card to perform massage. Previous card expired on 10/30/2004.

2/4/2003 – Ms. Song was arrested by LVMPD for solicitation of prostitution and for no massage permit to perform massage. Officers were investigating prostitution at Paradise Spa Asian Massage on Paradise road.

*While working in an undercover capacity the vice section entered the Paradise Spa. The front door to the business had a metal security gate, which was locked and a note stating, ring bell for service. I rang the bell, subsequently greeted by an Asian female later identified as Guoli Song. Song unlocked the door, invited me in the front office area of the business and asked me if I wanted a half hour or hour massage. I told her I wanted an hour massage and she told me it would be \$60.00. I then paid her \$60.00 for one hour full body massage with LVMPD furnished money.*

*Song then escorted me down a long hallway towards the east center of the building then stopped and told me to turn around. She then walked me back through the lobby area or office area and took me to the west end of the building to room eight. This room is situated on the west end of the building and is a room by itself. She then told me to disrobe and lay on the table and she exited the room.*

*I then completely disrobed and got on the massage table face down. There was a small bath towel at the bottom of the massage table, which I used to cover my buttocks. Song then entered the room and began the massage. She started to get the massage oil, which I told her that I didn't like oil, because it made me break out. She seemed frustrated but started the massage without oil. She began to rub my upper back, lower back, arms, buttocks and legs. I asked her how long she'd been giving massages and she told me two years. During the massage, while face down, Song removed the towel that was covering my buttocks and continued to massage my buttocks. At one point, she told me that it was too difficult to do the massage without the oil. I told her that she could use a little bit. She then got the massage oil and began rubbing my back, legs and buttocks again still with the towel exposing my buttocks. When she finished my legs, she began to tickle my buttocks and the crack of my buttocks, and she asked me if it felt good. I told her that she was going to get me hard and she laughed. While still tickling my buttocks, she asked me to turn over at which time I turned over on my back and took the towel from the base of the table and again covered my penis. She began to massage my stomach and pulled the towel away from my penis and again placed it back at the bottom of the table. She then put her left hand on my penis and my genitals at which time I asked her if she was going to give me a hand job. I also made a manual masturbation motion with my right hand at which time she nodded her head up and down in the affirmative. I then asked her if she would give me a "blow job" (fellatio). At the same time, I made a gesture with my right hand up to my mouth to simulate oral sex. This time, Song nodded her head in the negative and said, "NO." She again placed her left hand on my penis at which time I asked her if it was going to be extra or if it was included. She asked me what I meant by extra. I asked her if it was free. She then stated, "what do you mean free?" I asked her if it was included in the massage or if it was extra and how much. She then took her right pointer finger and drew 60 on my chest. I told her that I didn't understand, and she replied, "you tip me sixty." I told her that the \$60.00 was too much and how about \$40.00. She then stated, "no." I told her that sixty was too much and that I would go fifty. But again, she*

*stated, "no." I then told her that I wasn't going to pay \$60 for a hand job. That was too much. Song then asked me, "are you police?" I told her that I wasn't, and she asked me to touch her. She then pointed to her right breasts and asked me to touch her there. I told her that her dress was too tight, and she stated, "No, you police." I again told her I wasn't. Prostitutes typically have a customer touch them in private area to verify they are no undercover officer or not. This is common tactic.*

*She then walked over to the base of the massage table and grabbed the bottle of oil, walked over to the right side of the table and squirted a large amount of oil into her hand. She then reached her hand down toward my penis again at which time I moved her hand and told her that I wasn't interested and that I was going to get dressed. She told me that I had 10 minutes left on my message and I told her that I was finished. I then exited the table and began to get dressed.*

*At this point, fellow detectives assigned to the vice squad entered the business and placed Ms. Song under arrest.*

Ms. Song plead not guilty to both charges and was convicted. Ms. Song appealed the conviction – sufficient evidence was not introduced at trial. Based upon the lack of evidence presented at trial, the judgment of conviction from the lower court is reversed.

10/11/2002 - Ms. Song was arrested by LVMPD for solicitation of prostitution. Officers visited to investigate prostitution at Paradise Spa Asian Massage on Paradise road.

*I had visited the Paradise Spa Asian Massage and made contact with an Asian female adult at the door. She was later identified as Wachholder, Guoli. Wachholder asked me if she could help me. I said, "yes, I'm here for a massage." She said, "come in," and closed and locked the door behind me. She asked me if I'd like a 30 minute or 60-minute massage. I told her that I was looking for a 30-minute massage, and she said that would be \$40.00. I took the \$40.00 from my pants pocket and handed it to Wachholder, who then put the money inside of a desk drawer. Wachholder said to follow her and we started walking down the hall where all the massage rooms were located at. She stopped in front of room #6 and said come on in. I went in and she closed the door behind me. She said, "okay, go ahead and get comfortable." At that time, I disrobed and laid down on the massage bed. She asked me if I'd like it to soft or hard, referring to the type of massage. I said that I'd like it medium. She said, "okay." She then took oil from a table that was inside the room and started to apply oil to my back. She rubbed my neck, back and my arms. She then said, "Turn over on your back," and I turned over on my back, and covered my penis with a towel that was provided inside the room. She started rubbing my leg first and then my right leg with oil. After approx. five minutes, she said, "would you like me to," and using her right hand and going in an up and down motion referring to masturbating my penis, I said, "yes." She said, "how much do you have?" I said, "well, how much do you charge?" Wachholder said, "how much do you want to spend?" I told Wachholder, \$20. She said, "No, it will cost more than that." I said, "just jerk me off?" (Jerk off referring to masturbating my penis). She said, "yes." I said, "Well, how much more?" She said, "\$60.00." I said, "okay, that fine." She then went to the table that was located inside the room and retrieved additional oil and Kleenexes. She then applied oil to my stomach area. She removed the towel, exposing my penis and poured oil on my penis and then grabbed my penis with her right hand. At that time, I immediately grabbed her hand and any further contact with my penis, and said, "wait, let me use the restroom before we start." She said, "are you a cop?" I said, "No." and she became very suspicious at this time, and said, "you're a cop, aren't you?" I said, "no." She then started crying and said, "I'm sorry. I didn't mean to do this. I apologize." I then identified myself as a police officer and Ms. Wachholder was transported to city jail.*

Ms. Song was found guilty, imposed fines. Case closed on 12/16/2003.

06/05/2001 - Ms. Song was cited by LVMPD for solicitation of prostitution and no massage permit. Officers visited to investigate prostitution at Lucky Massage on W. Sahara in Las Vegas. Ms. Song, did solicit detectives for the act of prostitution for \$200.00 for a hand job (masturbation), perform massage on detectives while topless and anal penetration.

NSBMT – Timeline:

Ms. Song was previously before the Board on May 18, 2007. Her application was denied due previous arrests listed above. Denied based on NRS.640C.700(4)(9).

Ms. Song was previously before the Board on April 11, 2008. Her application was approved for a two-year probationary license. Ms. Song was issued NVMT.4891. She was licensed from April 11, 2008 to April 30, 2011.

Basis for NRS.640C.700(1) - Ms. Song provided incorrect information on her application regarding her last name or previous last name and question 4 of the application screening questions.

## Fingerprint Background Waiver

### NOTICE OF NONCRIMINAL JUSTICE APPLICANT'S RIGHTS

As an applicant who is the subject of a Federal Bureau of Investigation (FBI) fingerprint-based criminal history record check for a noncriminal justice purpose you have certain rights which are discussed below.



The following is the order in the case involving Guoli Song (Respondent) by the Nevada State Board of Massage Therapists. (Board)

**ORDER**

It is hereby ordered that Nevada Licensed Massage Therapists License No. NVMT. issued in the name of Guoli Song is placed on probation (restricted Licensure) for a minimum of two (2) years with the following terms and conditions:

1. If, after notice and hearing, Respondent is found to have violated any of the following terms and conditions, the Board may revoke probation for Respondent and carry out any appropriate disciplinary action pursuant to NRS 640C.710. The Board shall have continuing jurisdiction over any complaint filed against Respondent to revoke probation until such matter is final.
2. This order shall not be construed as excluding or reducing any criminal or civil penalties or sanction or other remedies that may be applicable under federal, state or local laws.

**PROBATION CONDITIONS**

1. Respondent must report all contact with law enforcement within 48 hours to The Board.
2. Respondent may not provide outcall service.
3. Respondent must obtain job site approval prior to employment and/or practice as a massage therapist.
4. Respondent must notify The Board of any change in employment within 24 hours
5. Respondent must complete 6 hours of ethics education within 90 days

6. Respondent must have adequate supervision while at work: Supervisor must be approved by The Board prior to taking employment.
7. Respondent must notify any Change in address to The Board office within 15 business days.
8. Respondent must report any inappropriate behavior from a client during a massage to The Board within 24 hours.
9. Respondent must submit to a FBI/Local fingerprint background check for two renewal period submitted with \$100.00 for administrative fees.
10. Respondent must comply with all laws governing massage therapy.

#### **7. LICENSE MARKED "RESTRICTED"**

**RESPONDENT** shall, have her license marked "Restricted" throughout the probationary period.

#### **8. TIME EARNED OFF PROBATION**

**RESPONDENT** shall only receive credit toward service of her probation period while employed in a capacity for which a Massage Therapist is required and subject to adequate supervision approved by the Board

#### **9. WRITTEN NOTIFICATION OF TERMINATION OF EMPLOYMENT TO BOARD**

**RESPONDENT** is required to notify the Board in writing within seventy-two (72) hours after commencement or termination of any Massage Therapist's employment, as that license is now void and must be reissued with new supervisor. Any notification regarding termination shall contain a full explanation of the circumstances surrounding it.

#### **10. SUBMISSION OF ORDER TO IMMEDIATE SUPERVISOR**

**RESPONDENT** shall provide a copy of this Order to her employer and immediate supervisor.

#### **11. REQUIREMENT TO MEET WITH THE BOARD OR STAFF UPON REQUEST**

RESPONDENT shall meet with the Board or its representatives upon request and shall cooperate with representatives of the Board in their supervision and investigation of Respondent's compliance with the terms and conditions of this Order.

#### **12. TERMINATION OF PROBATION**

Upon completion of the requirements of this Order, Respondent shall apply for termination of probation on forms supplied by the Board. Respondent shall meet with The Board's Executive Director regarding a probation period. The probation shall continue until terminated by the Board. The Board will determine whether or not probation will be terminated.

#### **13. REPORTING TO NATIONAL DISCIPLINARY DATA BANKS**

This Order will become part of the Respondent's permanent record, will become public information, will be published with the list of disciplinary actions the Board has taken, and may be reported to any national repository which records disciplinary action taken against licensees or holders of certificates; or any agency or another state, which regulates the practice of Massage Therapy. The Board may use the Order in any subsequent hearings.

#### **14. CONSEQUENCES OF FURTHER VIOLATIONS INCLUDING VIOLATIONS OF THIS ORDER; ORDER TO SURRENDER LICENSE**

RESPONDENT acknowledges that if she should violate one or more of the terms of this Order, the Board may revoke, or invoke other appropriate discipline against her license to practice Massage Therapy, subject only to the requirement that the Board shall, prior to such disciplinary action, conduct a hearing in accordance with Chapters 640C.622A and 233B of the Nevada Revised Statutes for the limited purpose of establishing that there has, in fact, been a violation of the requirements of this Order. In the event that a violation of the requirements is alleged, Respondent agrees to surrender her license to the Executive Director, if they so request, and refrain from practicing as a Massage Therapist until entry of a final order of the Board or a court of competent jurisdiction, whichever last occurs, regarding a potential violation. Respondent agrees to waive her right to appeal the substantive legal basis of the disciplinary action. In the event an alleged violation of this

Order is taken to hearing and the facts which constitute the violation are determined to be not proven, no disciplinary action shall be taken by the Board and the probationary licensure previously ordered by the Board shall again be operative and in full force and effect.

#### 15. CONSEQUENCES OF OTHER MISCONDUCT

In the event other misconduct is reported to the Board, this Order may be used as evidence against the Respondent to establish a pattern of behavior and for the purpose of proving additional acts of misconduct.

NEVADA STATE BOARD OF MASSAGE THERAPISTS retains jurisdiction in this case until all conditions have been met to the satisfaction of the Board.
