

II. 1 **JURISDICTION** 2 7. Respondent is currently and at all times mentioned herein, licensed as a massage therapis 3 in the State of Nevada and is therefore, subject to the jurisdiction of the Board and th 4 provisions of NRS Chapter 640C. 5 6 III. 7 FINDINGS OF FACT 8. The Board, having considered all the evidence presented, the testimony of witnesses, an 8 the arguments of counsel, for good cause appearing, finds sufficient quantity and/or quality 9 of evidence sufficient to meet the preponderance of the evidence standard of proof as set 10 forth by NRS 622A.370 and by Nassiri v. Chiropractic Physicians' Board of Nevada, 130 11 Nev. Adv. Op, 27, at 8-9 (April 3, 2014). 12 9. Via Complaint and Notice of Hearing dated February 2, 2022, Respondent was notified o 13 the administrative hearing scheduled for Wednesday, March 30, 2022. (Exhibit 1) 14 The Complaint and Notice of Hearing included a certificate of service signed by Board staff. 15 Tereza Van Horn, that she certified mailed and regular mailed a copy of the Complaint and 16 Notice to Respondent's address. 17 Ms. Van Horn testified that she served Respondent at his address on file with the Board and that a continuance has not been requested in this matter. 18 12. Following this testimony, the Board found pursuant to NRS 622A.350(1), that notice of the 19 scheduled hearing was properly served on Respondent, and that Respondent did not request 20 a continuance and that Respondent failed to appear at this scheduled hearing. 21 13. Pursuant to NRS 622A.350(1), the Board proceeded to consider this matter without the 22 participation of Respondent. 23 14. Senior Deputy Attorney General, Sophia G. Long provided the following: 24 a. Pursuant to NRS 622A.350(2), the Board may accept the allegations against th 25 licensee in the charging document as true. 26 b. The allegations in the charging document were read into the record. Specifically that, "On or about October 20, 2021, Respondent, while working at S&R Spa located 27 at 2550 S. Rainbow Blvd., Las Vegas, Nevada 89146, was arrested for soliciting 28

3	15. The Board reviewed the LVMPD arrest and Investigation Report in this matter. (Exhibit 2
4	16. Any of the Findings of Fact that are or can be construed as Conclusions of Law is hereb

7	CONCLUSIONS OF LAW
8	17. Having made the aforementioned findings, the Board decides that there is sufficient quanti
9	and/or quality of evidence sufficient to meet the preponderance of the evidence standard o
10	proof as set forth by NRS 622A.370 and by Nassiri v. Chiropractic Physicians' Board o
11	Nevada, 130 Nev. Adv. Op, 27, at 8-9 (April 3, 2014) to make the following conclusions o
12	law:
13	18. Pursuant to NRS 622A.350, Respondent was given sufficient legal notice of the scheduled
14	hearing and that Respondent failed to appear and did not request a continuance.
15	19. By touching soliciting sexual activity during the course of a massage, Respondent violated
16	the provisions of NRC 640C.700(4) and NRS 640C.700(9).
	20. Any Conclusions of Law that are or can be construed as Findings of Fact is hereby
17	incorporated as such to the extent as if originally so designated.

11. Formal Hearing Hongyan Chen License Number NVMT.9946 – Case Number NVMT-C-21073. (For Discussion and Possible Action)

Senior Deputy Attorney General Sophia Long presented the case regarding Hongyan Chen NVMT.9946 to the Board. Ms. Chen was not present.

Ms. Long advised the board regarding NRS 622A.350 and the requirements for notification. Ms. Long requested that the Chair accept Exhibit 1 be admitted into the record.

The Chair reminded Ms. VanHorn that she was under oath. Ms. VanHorn provided testimony that Ms. Chen was provided sufficient legal notice per NRS 622A.350 and was served notice at the address that was on file with the Board.

Motioned by Chair Barnard that Ms. Chen had been properly noticed, seconded by Bianca Smith. Motion carried.

Ms. Long presented the Complaint Notice of Hearing regarding sexual misconduct. Ms. Long requested that exhibit 2 be submitted into evidence. Chair Barnard accepted the exhibits.

Motioned by Chair Barnard to accept the alleged facts as true and that the violation of law count 1 did occur, seconded by Richard Fields. Motion carried unanimously.

Motioned by Chair Barnard to revoke for ten (10) years, seconded by Bianca Smith. Motion carried unanimously.

On or about October 20, 2021, Respondent, while working at S&R Spa located at 2550 S Rainbow Blvd., Las Vegas, Nevada 89146, was arrested for soliciting sexual activity to 21 undercover police officer during the course of practicing massage. 22 23 **VIOLATIONS OF LAW** 24 **COUNT ONE** 25 2. By soliciting sexual activity during the course of practicing a massage, Responden 26 violated the provisions of NRS 640C.700(4) and/or (9). This is grounds for disciplin 27 pursuant to NRS 640C.700(2).

2	WHEREFORE, Executive Director, Sandra Anderson, prays as follows:
3	3. That the Board conduct a hearing on this complaint as provided by statute, and after sucl
4	hearing, that the Board impose upon Respondent the discipline permitted by NRS
5	640C.710, which may include the following, (a) the imposition of an administrative fine o
6	not more than \$5,000.00 per violation, (b) recovery of reasonable investigative fees and cost
7	incurred, (c) recovery of attorney fees pursuant to NRS 622.400, (d) licensee be publicly
8	
9	reprimanded, (e) suspend, revoke or place conditions on the licensee's license, (f) place the
10	licensee on probation, and/or (g) such other impositions as may be permitted by Nevada law.
11	PLEASE TAKE NOTICE that a disciplinary hearing has been set to consider thi
12	Administrative Complaint against the above-named Respondent in accordance with Chapters 233B
13	622, 622A and 640C of the Nevada Revised Statutes.

As the Respondent, you are further advised that you may be charged with the attorney's fee and/or costs associated with the hearing pursuant to NRS 622.400. 9 Pursuant to NRS 233B.121(5), informal disposition of this case may be made by stipulation 10 agreed settlement, consent order, or default.
