COMPLAINT AND NOTICE OF HEARING

The Nevada State Board of Massage Therapy (Board), by and through its Executive Director, Sandra Anderson, hereby notifies Yolonda C. Johnson ("Respondent") of an administrative hearing, which is to be held pursuant to Chapters 233B, 622, 622A of the Nevada Revised Statutes (NRS) and 640C of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC). The purpose of the hearing is to consider the allegations stated below and to determine if the Respondent should be subject to an administrative penalty as set forth in NRS 640C.710, if the stated allegations are proven at the hearing by the evidence presented.

Respondent is currently and at all times mentioned herein, licensed as a massage therapist in the State of Nevada and is therefore, subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C.

IT IS HEREBY ALLEGED AND CHARGED AS FOLLOWS:

ALLEGED FACTS

- 1. On or about July 7, 2022, Respondent submitted a renewal application. Respondent indicated that she was arrested for Battery on October 20, 2021.
- 2. On July 21, 2022, the Board approved Respondent's renewal application.
- On or about July 25, 2022, the Board sent Respondent a request for information regarding her arrest and court case.

4. Justice court documents in case number 21-CR-022832 shows that on or about September 28, 2021, Respondent pled guilty in Las Vegas Justice Court to Battery and ordered to a 30-day suspended jail sentence, pay a two hundred and fifty dollar (\$250.00) fine (or 25 hours of community service), stay out of trouble for six months, stay away from victim,

and to complete impulse control counseling. All requirements were completed on 1 November 10, 2021, wherein the matter was dismissed after the requirements were met. 2 3 **VIOLATIONS OF LAW** 4 **COUNT ONE** 5 5. By being convicted of a crime involving violence, Respondent violated NRS 640C.700(3) 6 and/or (9). This is grounds for discipline pursuant to NRS 640C.700(2). 7 8 PRAYER FOR RELIEF 9 WHEREFORE, Executive Director, Sandra Anderson, prays as follows: 10 6. That the Board conduct a hearing on this complaint as provided by statute, and after such 11 hearing, that the Board impose upon Respondent the discipline permitted by NRS 12 640C.710, which may include the following, (a) the imposition of an administrative fine of 13 not more than \$5,000.00 per violation, (b) recovery of reasonable investigative fees and costs 14 incurred, (c) recovery of attorney fecs pursuant to NRS 622.400, (d) licensee be publicly 15 reprimanded, (e) suspend, revoke or place conditions on the licensee's license, (f) place the 16 licensee on probation, and/or (g) such other impositions as may be permitted by Nevada law. 17 18 PLEASE TAKE NOTICE that a disciplinary hearing has been set to consider this 19 Administrative Complaint against the above-named Respondent in accordance with Chapters 233B. 2.0 622, 622A and 640C of the Nevada Revised Statutes. 21 THE HEARING WILL TAKE PLACE on Wednesday, October 26, 2022. commencing at 9:00 a.m. or as soon thereafter as the Board is able to hear the matter with video 22 conferencing by Zoom. 23 Zoom sign-in available at 8:30 a.m. 24 Register in advance: https://us06web.zoom.us/j/89023133843?pwd=MIp1SFYwT3FMdTlGSk93c0JlMHRHZz09 25 Meeting ID: 890 2313 3843 26 Password: 649868 27 Dial by your location 28 +1 253 215 8782 US (Tacoma)

PURSUANT TO NRS 622A.330, Respondent may seek limited discovery from the Board.

As the Respondents, you are specifically informed that you have the right to appear and be heard in your defense, either personally or through counsel of your choice. You have the right to respond and to present relevant evidence and argument on all issues involved. You have the right to call and examine witnesses, introduce exhibits, and cross-examine opposing witnesses on any matter relevant to the issues involved.

You have the right to request that the Board issue subpoenas to compel witnesses to testify and/or evidence to be offered on your behalf. In making this request, you may be required to demonstrate the relevancy of the witnesses' testimony and/or evidence.

The purpose of the hearing is to determine if the Respondent has violated the provisions of Chapter 640C of NRS and if the allegations contained herein are substantially proven by the evidence presented to further determine what administrative penalty is to be assessed against the Respondent, if any, pursuant to NRS 640C.710.

Should the Respondent fail to appear at the hearing, a decision may still be reached by the Board. As the Respondent, you are further advised that you may be charged with the attorney's fees and/or costs associated with the hearing pursuant to NRS 622.400.

Pursuant to NRS 233B.121(5), informal disposition of this case may be made by stipulation, agreed settlement, consent order, or default. Any attempt to negotiate this case should be made by contacting Sandra Anderson, (775) 687-9951 or sjanderson@lmt.nv.gov.

Pursuant to NRS 241.033(2)(b), the Nevada State Board of Massage Therapy may, without further notice, take administrative action against your license and/or certificate to practice within the State of Nevada if the Board determines that such administrative action is warranted after considering your character, alleged misconduct, professional competence, or physical or mental health.
