**COMPLAINT AND
NOTICE OF HEARING**

The Nevada State Board of Massage Therapy (Board), by and through its Executive Director, Sandra Anderson, hereby notifies Shekiara D. Pettway (“Respondent”) of an administrative hearing, which is to be held pursuant to Chapters 233B, 622, 622A of the Nevada Revised Statutes (NRS) and 640C of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC). The purpose of the hearing is to consider the allegations stated below and to determine if the Respondent should be subject to an administrative penalty as set forth in NRS 640C.710, if the stated allegations are proven at the hearing by the evidence presented.

Respondent is currently and at all times mentioned herein, licensed as a massage therapist in the State of Nevada and is therefore, subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C.

IT IS HEREBY ALLEGED AND CHARGED AS FOLLOWS:

ALLEGED FACTS

1. On or about July 8, 2021, the Board issued Respondent an administrative citation in the amount of one thousand dollars (\$1,000.00) for “prohibitive activities without license” under NRS 640C.910, and an administrative fee of one hundred fifty dollars (\$150.00), totaling one thousand one hundred and fifty dollars (\$1,150.00) owed to the Board.
2. On or about July 19, 2021, Respondent contacted the Board and requested a payment plan. The Board approved Respondent’s request and the Board mailed Respondent an invoice with a payment due date of August 3, 2021, and a document to sign for the payment plan.
3. On or about June 2, 2022, the Board requested Respondent’s employment information.
4. On or about August 15, and August 18, 2022, the Board followed up with Respondent.

1 5. As of today, Respondent has not returned the payment plan document, responded to the
2 Board's request for information, or made any payments on the administrative citation.

3 **VIOLATIONS OF LAW**

4 **COUNT ONE**

5 6. By failing to comply with a written administrative citation issued pursuant to NRS
6 640C.755 within the time permitted for compliance set forth in the citation, Respondent
7 violated the provisions of NRS 640C.700(16) and/or (9). This is grounds for discipline
8 pursuant to NRS 640C.700(2).

9 **COUNT TWO**

10 7. By failing to provide information requested by the Board within 60 days after receiving
11 the request, Respondent violated the provisions of NRS 640C.700(8) and/or (9). This is
12 grounds for discipline pursuant to NRS 640C.700(2).

13 **PRAYER FOR RELIEF**

14 WHEREFORE, Executive Director, Sandra Anderson, prays as follows:

15 8. That the Board conduct a hearing on this complaint as provided by statute, and after such
16 hearing, that the Board impose upon Respondent the discipline permitted by NRS
17 640C.710, which may include the following, (a) the imposition of an administrative fine of
18 not more than \$5,000.00 per violation, (b) recovery of reasonable investigative fees and costs
19 incurred, (c) recovery of attorney fees pursuant to NRS 622.400, (d) licensee be publicly
20 reprimanded, (e) suspend, revoke or place conditions on the licensee's license, (f) place the
21 licensee on probation, and/or (g) such other impositions as may be permitted by Nevada law.

23 PLEASE TAKE NOTICE that a disciplinary hearing has been set to consider this
24 Administrative Complaint against the above-named Respondent in accordance with Chapters 233B,
25 622, 622A and 640C of the Nevada Revised Statutes.

26 THE HEARING WILL TAKE PLACE on **Wednesday, October 26, 2022, commencing at**
27 **9:00 a.m.** or as soon thereafter as the Board is able to hear the matter with video conferencing by
28 Zoom.

14 PURSUANT TO NRS 622A.320, Respondent may, but is not required to, file an answer to
15 this Complaint with the Board.

16 PURSUANT TO NRS 622A.330, Respondent may seek limited discovery from the Board.

17 As the Respondents, you are specifically informed that you have the right to appear and be
18 heard in your defense, either personally or through counsel of your choice. You have the right to
19 respond and to present relevant evidence and argument on all issues involved. You have the right to
20 call and examine witnesses, introduce exhibits, and cross-examine opposing witnesses on any matter
21 relevant to the issues involved.

22 You have the right to request that the Board issue subpoenas to compel witnesses to testify
23 and/or evidence to be offered on your behalf. In making this request, you may be required to
24 demonstrate the relevancy of the witnesses' testimony and/or evidence.

25 The purpose of the hearing is to determine if the Respondent has violated the provisions of
26 Chapter 640C of NRS and if the allegations contained herein are substantially proven by the evidence
27 presented to further determine what administrative penalty is to be assessed against the Respondent,
28 if any, pursuant to NRS 640C.710.

Should the Respondent fail to appear at the hearing, a decision may still be reached by the
Board. As the Respondent, you are further advised that you may be charged with the attorney's fees
and/or costs associated with the hearing pursuant to NRS 622.400.

Pursuant to NRS 233B.121(5), informal disposition of this case may be made by stipulation,
agreed settlement, consent order, or default. Any attempt to negotiate this case should be made by

1 Pursuant to NRS 241.033(2)(b), the Nevada State Board of Massage Therapy may, without
2 further notice, take administrative action against your license and/or certificate to practice within the
3 State of Nevada if the Board determines that such administrative action is warranted after considering
4 your character, alleged misconduct, professional competence, or physical or mental health.


