Ms. Qi failed to disclose she attended American International Vocational College in Monterey Park, California. Ms. Qi failed to answer section 6 of the application appropriately. Ms. Qi is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Board Meeting Application review: Yuqin Qi

02/11/2010: Arrested by Webster Police Department for prostitution while working in a massage establishment.

Statement provided by arrest record from Webster PD.

02/11/2010 11000 hrs:

Myself, Det. JL and Det. MP met with officers from the HPD Vice division identified as AL, SAR and VS. We discussed the investigation and decided that Officer AL would go in the massage establishment first and request a one-hour massage and then Officer SAR would go in a few minutes after and also request a massage with a second employee of the business. Officer R would be in his unmarked police vehicle, Officer AL would be driving his unmarked police vehicle. Officer S would be with me, and Det. L and P would be in another vehicle. Officer JL of the Webster Police patrol division also assisted and was the only uniformed officer that assisted in the investigation. All others, including myself, were in plain clothes.

We arrived at the location in a inconspicuous location while Officer AL entered the business. Officer SAR entered the business about 5 minutes later. After an hour or so, Officer S received a phone call from Officer L stating that no agreement for a sexual performance was made with subject that game him a massage. Officer S then received a subsequent call from Officer SAR stating that an agreement for a sexual performance in exchange for money was made with the female that massaged him.

We then proceeded to the business including Officer JL and made entry into the business. All parties involved were escorted out of the massage rooms and asked to sit in the lobby of the business. It was learned that female subject that made an agreement with SAR stated to him if he would like for her to massage genitals for a fee of \$40.00 by stating "You want me to massage down there" while pointing at his sexual organ. Officer SAR asked how much, and she stated \$40.00. She was identified as Yuqin Qi. Qi was arrested for prostitution (agreeing).

It was also discovered that the female subject that massaged Officer AL did not have a state license to work as a massage therapist. She was identified as YDY. YDY was arrested for said Texas occupation code violation.

The owner of the business, XZ was also present, and she was arrested for allowing a person to work in her business as a massage therapist without a license.

Charges were accepted Harris County ADA CC. All three defendants were transported to Webster Police Department jail where they were booked, fingerprinted and confined until being bonded or transported to the Harris County S.O. intake processing center located downtown Houston.

Synopsis:

On February 11, 2010, at approximately 1120 am, Detectives with the Webster Police Department and Investigators of the Houston Police Department Vice division conducted a prostitution investigation at the business establishment identified as Tender Massage located on 1047 E. Nasa Parkway, Webster, Texas, due to an adjacent business owner complaining that there was a large number of male subjects going in and out of the massage business throughout the day. Three Asian females were subsequently arrested after concluding the investigation. Yuqin Qi was arrested for prostitution, YDY was arrested for practicing as a massage therapist without a state license and XZ was arrested for having an unlicensed therapist without a state license working in her business.

During the investigation a white male identified as SC was also in the building. He stated that he was working on the business computer system. It was later discovered that he was an acquaintance XZ. The subject was identified as SC. A photo of the subject is in the photo case file under case #10-00383. It was also learned that SC lived with XZ at his residence located on Sunset Bay Ct., Seabrook, TX
