COMPLAINT AND NOTICE OF HEARING

The Nevada State Board of Massage Therapy (Board), by and through its Executive Director, Sandra Anderson, hereby notifies Guoli Song ("Respondent") of an administrative hearing, which is to be held pursuant to Chapters 233B, 622, 622A of the Nevada Revised Statutes (NRS) and 640C of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC). The purpose of the hearing is to consider the allegations stated below and to determine if the Respondent should be subject to an administrative penalty as set forth in NRS 640C.710, if the stated allegations are proven at the hearing by the evidence presented.

Respondent is currently and at all times mentioned herein, licensed as a massage therapist in the State of Nevada and is therefore, subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C.

18 IT IS HEREBY ALLEGED AND CHARGED AS FOLLOWS: 19 ALLEGED FACTS 20 1. On or about March 31, 2021, Respondent appeared before the Board for regarding her license application that by Board policy, could not be administratively approved. 21 2. The Board Order dated May 19, 2021, approved a four-year probationary license that 22 included: 23 a. No outcall services; 24 b. That she submit to annual background checks at her own expense, the first being 25 within one year of the date of the Order; and 26 That she cooperate with Board staff during probation. C. 27 3. As of today, Respondent: 28 a. Has not submitted to a background check;

The purpose of the hearing is to determine if the Respondent has violated the provisions of Chapter 640C of NRS and if the allegations contained herein are substantially proven by the evidence presented to further determine what administrative penalty is to be assessed against the Respondent,

if any, pursuant to NRS 640C.710. Should the Respondent fail to appear at the hearing, a decision may still be reached by the

Board. As the Respondent, you are further advised that you may be charged with the attorney's fees and/or costs associated with the hearing pursuant to NRS 622.400.
