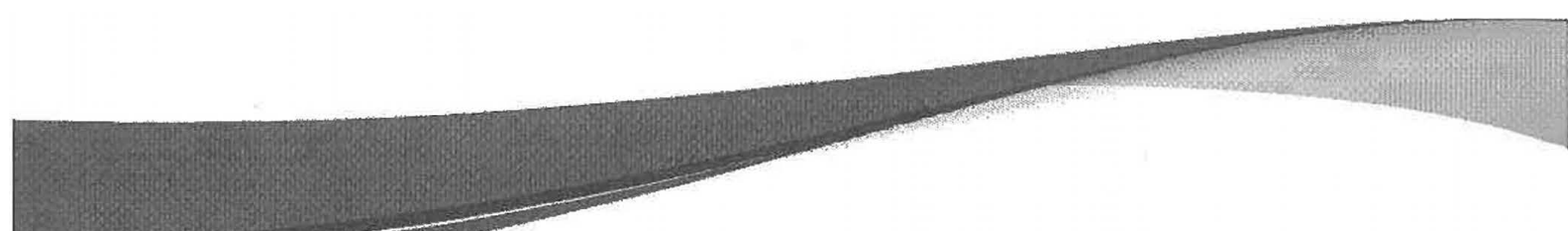

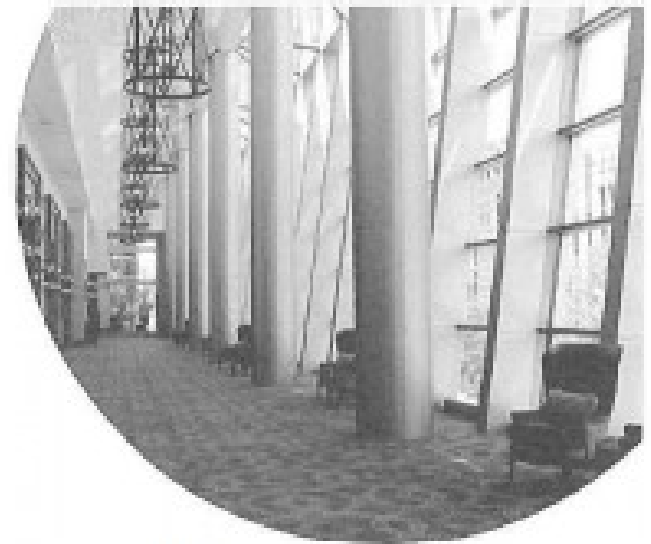

HOTEL DEADLINE

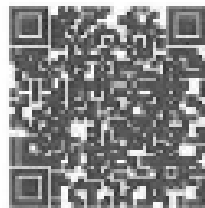
