Public comment was taken at the beginning and the end of the meeting. The Board may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person (NRS 241.030).

Public Comment Agenda Item: There was a time designated at the beginning and the end of the meeting for Public Comment. Members of the general public were able to bring matters not appearing on this Agenda to the attention of the Board or make comment on specific agenda items. Public comment also was taken at other such times as requested as long as the request for public comment did not interrupt ongoing Board business. The Board may have discussed the matters not on the agenda but did not act on the matters at this meeting. If the Board desired, the matters will be placed on a future Agenda for action. In consideration of others who wished to provide public comment, repetition was avoided. The Board limited public comment to three (3) minutes.

Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process rights of an individual, the Board may have refused to consider public comment (see NRS 233B.126). Please be aware that after the quasi-judicial Board rendered a decision in the contested case and, assuming this happened before adjournment, the Board may have entertained public comment on the proceeding.

1. Call to order and roll call of Board Members.

The meeting was called to order at 9:04 a.m. on August 10, 2022, by Chair Elisabeth Barnard. Board members in attendance included Vice Chair Deirdre Strunk, Lorna Benedict, Rebecca Dorangricchia, Bianca Smith, John Teng, Stephanie Tsanas, and Sgt. Aaron Fink with the Las Vegas Metropolitan Police Department. Additional attendees included Senior Deputy Attorney General Sophia Long, Board Counsel Colleen Platt, and Executive Director Sandy Anderson. Lorna Benedict left the meeting at 5:26 p.m.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Chair Barnard read the mission statement into the record.

 - a. Review Application Lei Wang. (For Discussion and Possible Action)

Ms. Wang was not present nor was legal counsel Kirk Kennedy. Mr. Kennedy Nevada State Bar #5032 provided a written request prior to the meeting to withdraw the application.

b. Review Application Edward T. Gao. (For Discussion and Possible Action)

Edward T. Gao was present and assisted by Jerry Xu.

Management Analyst VanHorn presented the application of Edward T. Gao to the Board. Mr. Gao's massage application is before you today for review that could not be approved administratively. Mr. Gao was previously before the Board for an application review on March 30, 2022. The application was denied based on NRS.640C.700(1), (2), (9) and/or (11) and NAC.640C.410 (1)(j), (p), (q), and (s). During the application review in March, Mr. Gao failed to disclose his previous license and citation issued by Utah Division of Occupational & Professional Licensing for allowing an unlicensed person to perform massage in his business and failed to disclose additional education. Mr. Gao was previously licensed with NSBMT from April 2007 to April 2010. Mr. Gao is requesting to be granted a license under NRS 640C.420 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to approve a probationary license for four (4) years, must report who his employer is and any changes in employment within forty-eight (48) hours, and report any contact with law enforcement within forty-eight (48) hours, seconded by Dierdre Strunk. Motion carried unanimously.

c. Review Application Ashley A. Pedraza. (For Discussion and Possible Action)

Ashley A. Pedraza was present.

Management Analyst VanHorn presented the application of Ashley A. Pedraza to the Board. Ms. Pedraza's massage application is before you today for review that could not be approved administratively. Ms. Pedraza was arrested by Willimantic Police Department on April 7, 2010, April 9, 2011, August 29, 2011, and October 26, 2011, for sale of narcotic or hallucinogenic and risk of injury to child. All cases were combined for ten years per count sentence for a total of 4 counts on May 14, 2013. Jail term was suspended and followed by probation until December 30, 2016. Ms. Pedraza is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Rebecca Dorangricchia to grant a probationary license for two (2) years, all contact with law enforcement must be reported within forty-eight (48) hours, report employer and any changes in employment within forty-eight (48) hours, and no outcall services, seconded by Bianca Smith. Motion carried.

Management Analyst VanHorn presented the application of Shi Sheng to the Board. Ms. Sheng's massage application is before you today for review that could not be approved administratively. Ms. Sheng was arrested on January 14, 2016, for prostitution by Indianapolis Metropolitan Police Department. Ms. Sheng accepted a plea agreement of guilty with a suspended jail sentence, fines/fees of \$183.00, and had to complete 24 hours of community service. Terms were completed on February 27, 2017. In reviewing the Indiana Massage Board licensee database, Ms. Sheng is not licensed to practice in Indiana. Ms. Sheng is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to deny based on NRS 640C.700(2), (3), (4), and/or (9) and NAC 640C.410 (1)(q), (r), and (x), seconded by Lorna Benedict. Motion carried unanimously.

Jasminemarie B. Soller was present.

Management Analyst VanHorn presented the application of Jasminemarie Soller to the Board. Ms. Soller's massage application is before you today for review that could not be approved administratively. Ms. Soller was arrested on July 22, 1993, for two counts of corporal punishment/injury of child and cruelty to child with great bodily injury or death by San Jose Police Department. Ms. Soller accepted a plea agreement by pleading no contest and was convicted of willful child cruelty possible injury/death. The sentence imposed was to serve not more than 3 years in jail and one year of probation. Ms. Soller was given credit for time served and 3 years' probation. Ms. Soller is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

August 17, 2021, Ms. Zhao's application was approved for reconsideration. The Board requested Ms. Zhao to resolve all business matters or claims then return for the Board to review. Ms. Zhao has re-applied as of March 1, 2022. Ms. Zhao's business address, email, or phone number can be linked to 1,553 illicit postings on several different websites; adultlook.com; renoskipthegames.com, and onebackpage.com. These illicit sites for massage have several ads with woman in lingerie across the United States. Ms. Zhao is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to deny based on NRS 640C.700(2), (9), (14); NRS.640C.910; NAC.640C.410(1)(z) and/or (bb), seconded by Rebecca Dorangricchia. Motion carried unanimously.

Board Counsel Platt explained the process for the Board moving forward regarding the alleged facts and the violations of law.

Motioned by Chair Barnard to accept the alleged facts as true with two changes first "on or about February 26" and secondly "receptionist" rather than "manager" as true, seconded by Stephanie Tsanas. Motion carried with Bianca Smith in opposition.

Motioned by Chair Barnard to accept the violations of law counts 1 and 2 did occur, seconded by Deirdre Strunk. Motion carried with Bianca Smith in opposition.

Mr. Buchanan shared that he and his client respect the decisions of the Board and asked the Board not to revoke his license but put him on probation with possibly a class or two.

Motioned by Bianca Smith to suspend the license of Luis Gonzalez for ninety (90) days to be followed by (two) 2 years of probation, continuing education of five (5) hours of continuing education units in professional ethics to be completed within ninety (90) days, fines of \$2,000 per violation of law, practice restricted to clothed clients, and costs incurred by the Board for the investigation and the hearing, seconded by Chair Barnard. Motion carried unanimously.

Vice Chair Strunk swore in Tereza VanHorn. Ms. VanHorn provided testimony regarding service.

Ms. Long presented the Complaint Notice of Hearing regarding Marcus Truman. Ms. Long requested that Exhibit 1 be submitted into evidence. Vice Chair Strunk accepted the exhibit.

Motioned by Bianca Smith to find that Mr. Truman was properly noticed, seconded by Rebecca Dorangricchia. Motion carried.

Board Counsel Platt swore in Robin Swift-Rohrer. Ms. Swift-Rohrer provided testimony regarding the incident.

Ms. Long requested that Exhibit 2, the docket from the criminal case, be submitted into evidence. Vice Chair Strunk accepted the exhibit.

Ms. Long asked the Board to accept the alleged facts contained in the complaint as true and that the violations of law Counts 1 through 4 did occur.

Motioned by Bianca Smith to accept the alleged facts contained in the complaint as true and that the four (4) violations of law did occur, seconded by Lorna Benedict. Motion carried.

Motioned by Vice Chair Strunk to revoke for ten (10) years, fines of \$2,000 per count, and costs associated with investigating the complaint and the hearing, seconded by Bianca Smith. Motion carried.

Motioned by Chair Barnard that Mr. Lisa was properly noticed, seconded by Bianca Smith. Motion carried.

Board Counsel Platt swore in Teresa Lopez. Ms. Lopez provided testimony regarding the incident.

Ms. Long asked the Board to accept the alleged facts as true and that the violation of law Count 1 did occur.

Motioned by Chair Barnard to accept the alleged facts as true and that the violation of law Count 1 did occur, seconded by Rebecca Dorangricchia. Motion carried unanimously.

Motioned by Bianca Smith to suspend the license of Frank Lisa for ninety (90) days with a \$500 fine, an anatomy class offered by FSMTB or an approved provider to be taken during the ninety (90) suspension prior to his license being reactivated, seconded by Chair Barnard. Motion carried unanimously.

16. Formal Hearing Bing An NVMT.10378 – Case Number NVMT-R-2213 (For Discussion and Possible Action)

Senior Deputy Attorney General Sophia Long presented the Settlement Agreement regarding Bing An NVMT.10378 – Case Number NVMT-R-2213 to the Board including five (5) classes offered by the Federation of State Massage Therapy Boards.

Motioned by Bianca Smith to approve the Settlement Agreement, seconded by Deirdre Strunk. Motion carried with no opposition.

17. Formal Hearing Sasha I. Wheelock NVMT.5878 – Case Number NVMT-R-2212 (For Discussion and Possible Action)

Sasha Wheelock was present and represented by Ronald Colquitt Nevada State Bar #4953.

Senior Deputy Attorney General Sophia Long presented a Settlement Agreement of five (5) continuing education classes within ninety (90) days on the FSMTB REACH platform and a two (2) year probation with background investigations each year.

Motioned by Bianca Smith to accept the Settlement Agreement, seconded Rebecca Dorangricchia. Motion carried.
