**ORDER FOR PROBATION**

Ashley A. Pedraza,  
Licensed Massage Therapist

IT APPEARING on August 10, 2022, ASHLEY A. PEDRAZA (“Pedraza”) appeared before the Nevada Board of Massage Therapy (“Board”) for disciplinary action.

The Board placed Pedraza’s license on probation for a period of two (2) years.

**ORDER**

IT IS HEREBY ORDERED:

1. Pedraza will attend probation orientation.
2. Pedraza must report all contact with law enforcement personnel within forty-eight (48) hours after such contact occurs.
3. Pedraza must report who her employer is and any changes in employment within forty-eight (48) hours.
4. Pedraza will refrain from outcall services.
5. Pedraza must cooperate fully with the Board staff to administrate terms of her probation.
6. Pedraza is responsible for all administrative fees incurred by the Board as a result of her probation compliance.
7. Pedraza is to comply with all laws governing massage therapy.
8. This order shall not be construed as excluding or reducing any criminal or civil penalties or sanction or other remedies that may be applicable under federal, state, or local laws.
9. Pedraza’s license shall be marked “Restricted” throughout the probationary period.
10. Pedraza shall meet with the Board or its representatives upon request and shall cooperate with representatives of the Board in her supervision and investigation of Pedraza’s compliance with the terms and conditions of this Order.
11. This Order will become part of Pedraza’s permanent record, will become public information, will be published with the list of disciplinary actions the Board has taken,

1 and may be reported to any national repository which records disciplinary action taken  
2 against licensees or holders of certificates or any agency or another state, which regulates  
3 the practice of massage therapy. The Board may use the Order in any subsequent hearings.

4 12. Pedraza acknowledges that if she violates one or more of the terms of this Order, the  
5 Board may revoke or invoke other appropriate discipline against her license to practice  
6 massage therapy; subject only to the requirement that the Board shall, prior to such  
7 disciplinary action, conduct a hearing in accordance with Chapters 233B, 622A, and 640C  
8 of the Nevada Revised Statutes for the limited purpose of establishing that there has, in  
9 fact, been a violation of the requirements of this Order. In the event that a violation of this  
10 Order is alleged, Pedraza agrees to surrender her license to the Executive Director, if so  
11 requested, and refrain from practicing as a massage therapist until an entry of a final order  
12 of the Board or a court of competent jurisdiction, whichever last occurs, regarding the  
13 potential violation. Pedraza agrees to waive her right to appeal the substantive legal basis  
14 of the disciplinary action. In the event an alleged violation of this Order is taken to hearing  
15 and the facts which constitute the violation are determined to be not proven, no disciplinary  
16 action shall be taken by the Board.

17 13. In the event other misconduct is reported to the Board, this Order may be used as evidence  
18 against Pedraza to establish a pattern of behavior and for the purpose of proving additional  
19 acts of misconduct.

20 14. Nevada State Board of Massage Therapy retains jurisdiction in this case until all  
21 condition have been met to the satisfaction of the Board.
