### NOTICE OF NONCRIMINAL JUSTICE APPLICANT'S RIGHTS

As an applicant who is the subject of a Federal Bureau of Investigation (FBI) fingerprint-based criminal history record check for a noncriminal justice purpose you have certain rights which are discussed below.

- 1. You must be notified by the **Nevada State Board of Massage Therapy** that your fingerprints will be used to check the criminal history records of the FBI and the State of Nevada.
- 2. If you have a criminal history record, the officials making a determination of your suitability for the job, license or other benefit for which you are applying must provide you the opportunity to complete or challenge the accuracy of the information in the record. You may review and challenge the accuracy of any and all criminal history records which are returned to the submitting agency. The proper forms and procedures will be furnished to you by the Nevada Department of Public Safety, Records Bureau upon request. If you decide to challenge the accuracy or completeness of you FBI criminal history record, Title 28 of the Code of Federal Regulations Section 16.34 provides for the proper procedure to do so:

**16.34 - Procedure to obtain change, correction or updating of identification records.** If, after reviewing his/her identification record, the subject thereof believes that it is incorrect or incomplete in any respect and wishes changes, corrections or updating of the alleged deficiency, he/she should make application directly to the agency which contributed the questioned information. The subject of a record may also direct his/her challenge as to the accuracy or completeness of any entry on his/her record to the FBI, Criminal Justice Information

Services (CJIS) Division, ATTN: SCU, Mod. D-2, 1000 Custer Hollow Road, Clarksburg, WV 26306. The FBI will then forward the challenge to the agency which submitted the data requesting that agency to verify or correct the challenged entry. Upon the receipt of an official communication directly from the agency which contributed the original information, the FBI CJIS Division will make any changes necessary in accordance with the information supplied by that agency.

- 3. Based on 28 CFR § 50.12 (b), officials making such determinations should not deny the license or employment based on information in the record until the applicant has been afforded a reasonable time to correct or complete the record or has declined to do so.
- 4. You have the right to expect that officials receiving the results of the fingerprint-based criminal history record check will use it only for authorized purposes and will not retain or disseminate it in violation of federal or state statute, regulation or executive order, or rule, procedure or standard established by the National Crime Prevention and Privacy Compact Council.
- 5. I hereby authorize Nevada State Board of Massage Therapy to submit a set of my fingerprints to the Nevada Department Public Safety, Records Bureau for the purpose of accessing and reviewing State of Nevada and FBI criminal history records that may pertain to me.

In giving this authorization, I expressly understand that the records may include information pertaining to notations of arrest, detainments, indictments, information or other charges for which the final court disposition is pending or is unknown to the above referenced agency. For records containing final court disposition information, I understand that the release may include information pertaining to dismissals, acquittals, convictions, sentences, correctional supervision information and information concerning the status of my parole or probation when applicable.

6. I hereby release from liability and promise to hold harmless under any and all causes of legal action, the State of Nevada, its officer(s), agent(s) and/or employee(s) who conducted my criminal history records search and provided information to the submitting agency for any statement(s), omission(s), or infringement(s) upon my current legal rights. I further release and promise to hold harmless and covenant not to sue any persons, firms, institutions or agencies providing such information to the State of Nevada on the basis of their disclosures. I have signed this release voluntarily and of my own free will.



My name is Kendal Priestly, and I am currently applying for a Massage Therapy License in Nevada. I was asked to write a narrative of my criminal background findings. Please find the details below for the following findings:

- 12/8/17 Misdemeanor Possession of drugs not for i-state commerce (Amended from 1 Misdemeanor and 3 Felony Charges on 12/4/15)
- PLEASE NOTE: The following charge did not result in a conviction 3/23/16 Misdemeanor Use/Possession of drug paraphernalia (Charge on 2/25/16)

First of all, I would like to say that I am an open book and am open to providing any additional documentation or information the Board needs to review my application. I am passionate about Massage Therapy and am hopeful to be granted a license to continue my journey towards a stable and meaningful career. At the time of my arrests, I was living a completely different life than I am today. I was homeless, directionless, and hanging out with the wrong crowd. I was doing drugs at the time, specifically methamphetamine, and regret that I made the decisions I made during this phase of my life. Since that time, I have become the mother of 2 wonderful children and have been focused on rehabilitating my life and doing everything I can to create a better life for them and myself. That journey started with joining the Massage Therapy program at Northwest Career College in October 2018 as well as gaining full-time employment as a Front Desk Customer Service Representative at European Wax Center, where I am currently employed. I have not had any additional issues with the law besides these two cases.

I am proud to say that I passed the MBLEx on my first try and graduated Northwest Career College with a 3.59 GPA. I have committed to my schooling and the practice of massage as much as I can. I have received 2 job offers upon graduation, 1 with a local day spa franchise, and 1 with a chiropractor. I appreciate the Board's continued consideration of my application and want to clarify any details about my past that might prevent me from being considered to be an upstanding member of the Massage community.

On December 4, 2015, I was hanging out with a group of friends at The Palms Hotel and Casino. My friends were checking out of a hotel room when we were all arrested. They were already being watched by the police for suspicious activity. I had offered to carry one of their bags for them as they were checking out of the room. The police searched me and found credit card information that my friends had collected illegally inside the bag I was carrying. They also found drugs on me (less than 2 grams methamphetamine) which I admitted were my own. The police charged me with 3 felony counts of credit card fraud, which the District Attorney dismissed upon trial, as well as 1 misdemeanor count of possession, which I was ultimately convicted of. The court ordered on 3/16/17 for me to complete the drug court program for 26 weeks, which included weekly random drug testing, weekly drug court counseling, monthly court status checks in front of a judge, and monthly fees for each appearance. I was doing very well with my weekly and monthly drug screenings from March 2017 to November 2017. I unfortunately relapsed in November 2017 after having my second child and was terminated from the drug court program 1 month before completion. As a result, I was required to complete a total of 6 months in county jail as a concurrent sentence with the second case on my record from February 2016. I was rewarded for good behavior and only had to serve 2 months in county jail with 1-month house arrest afterwards.

I knew that using drugs was the wrong thing to do at the time and that I was living the wrong life. I learned a hard lesson through this experience that you have to be careful with the types of people you hang out with and the influences you choose to prioritize. I know now that my role as a parent is the most important role I will play and that all things need to revolve around taking care of my kids.

On February 25, 2016, I was hanging out with my boyfriend at the time at a local Budget Suites. My boyfriend was on house arrest and for some reason did not think that he would be checked up on if he left the area he was restricted to. His house arrest officer came to the room to check on him and found drug paraphernalia. I admitted to some of it being mine because I did not want my boyfriend to take all of the blame and should have kept my mouth shut rather than try to be a hero. I was tried in the city municipal court system for this arrest who determined that the case would be bundled in with the sentencing for the December 2015 arrest sentencing which was tried in the county justice court system. Ultimately, I was not charged for use/possession of drug paraphernalia as a result of this arrest, but the arrest was taken into consideration for the final disposition of my previous case which did result in the misdemeanor drug conviction.

Since my jail time, I have not been in any additional trouble and have remained focused on my goal of creating a more stable and meaningful life for me and my children. I have worked hard to become a massage therapist and am very excited about starting my new career if given the opportunity. I am confident that the life you are seeing on paper is not my life now. I hope to be able to convince you that I am a very different person and am someone worth taking a chance on.





The Nevada State Board of Massage Therapy (Board), by and through its Executive Director, Sandra Anderson, hereby notifies Kendal L. - On or about January 8, 2020, Respondent's application to practice massage therapy was reviewed before the Board at a properly noticed board meeting. Respondent was granted a license to practice massage therapy with the condition of being placed on probation for two (2) years.


