Narrative			

On January 28th, 2022 at approximately 2005 hours, I, Detective Aliyev P#13950 was working in an undercover capacity investigating vice-related crimes and assigned to Investigate a massage parlor located at 6135 West Sahara Ave. #1, Las Vegas, NV 89146.

I entered the business as a customer and once inside the business I was greeted by an Asian female who was later identified as HongyIng Rode Rode escorted me to a private room and once inside the room she asked me if I wanted a 30 minute or an hour massage. I told roote that I only wanted a 30 minute massage and she then told me that it's going to cost me \$40. Once I paid \$40 to Rode, she told me to get undressed and lay on a bed. Rode then exited the room and returned approximately five minutes later. Rode then massaged my upper and lower body for approximately 20 minutes. Rode then massaged my buttocks and at one point she placed her hand on my testicles.

I then looked at Rode and asked if she could give me a "Blowjob." Rode nodded her head up and down in yes motion and then pointed at my penis and stated, "I want it In my mouth." I asked Rode how much money she wanted and she stated, "Two hundred." I asked Rode if I can have sex with her and she stated, "No sex" and then once again pointed at my penis with her finger, opened her mouth and pulled her tongue out. I agreed to pay Rode \$200 for a fellatio and then asked if she can give me a "Blowjob" without a condom. Rode stated that If I wanted without a condom then It would cost me \$400. I told Rode that I was "Ok" with \$200.

Once the agreement was made a gave a pre-determined bust out signal to Vice and SIS detectives. Vice and SIS detectives entered the room and safely took Rode into custody for Soliciting Prostitution, Ride was Issued a citation for Soliciting Prostitution and released.
