SUMMARY SUSPENSION OF LICENSE

This matter having been considered by ELISABETH BARNARD, Chairperson of the Nevada State Board of Massage Therapy (“Board”) and following investigation by the Board, and for good cause appearing, pursuant to the provisions of NRS 233B.127, the Administrator finds as follows:

FINDINGS OF FACT

1. MARCUS T. TRUMAN (“TRUMAN”) is licensed by the Board as a massage therapist, pursuant to the provisions of Nevada Revised Statutes and Nevada Administrative Code chapters 640C, license no. 10048.

2. TRUMAN is subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C and NAC Chapter 640C.

3. On or about May 25, 2022, while working at A Harmony Nail Spa located at 953 E. Sahara Rd, Ste 11A and 11B, Las Vegas, Nevada 89109, TRUMAN massaged RR and during the course of the massage touched her genitals, breasts and buttocks, and stated that he wanted to kiss her genitals. He lifted the drape to look at her vagina and smacked her buttocks.

4. On May 27, 2022, TRUMAN was arrested by the Las Vegas Metropolitan Police Department (“LVMPD”) and charged with three counts of Open/Gross lewdness related to the above incident.

5. As a result of the foregoing conduct, TRUMAN acted unprofessionally in violation of NRS 640C.700(2), (4), (9) and/or NAC 640C.340.

IT IS HEREBY ORDERED that MARCUS TRUMAN's license to act as a massage therapist in the State of Nevada is hereby immediately **SUMMARILY SUSPENDED**.

THE SUMMARY SUSPENSION HEREBY ORDERED is effective upon the Chairperson's execution of this Order. A hearing for revocation of TRUMAN'S license is scheduled **Wednesday, August 10, 2022, commencing at 9:00 a.m.** or as soon thereafter as the Board is able to hear the matter with video conferencing by Zoom.
