Dear Inspector,


My name is Hongyu Wang. I recently received a citation in mail indicating that I was practicing massage without a license. The date of violation was April 8, 2022 as written on the citation.

On April 8, 2022, I did indeed have a contact with Clark County and NV State inspectors at a spa location in late afternoon. I went to the XY Spa at the corner of Spring Mountain Rd and Wynn Rd after dinner on that day, looking for the owner. The owner had bought some masks for me earlier and waiting for me to pick them up on that day.

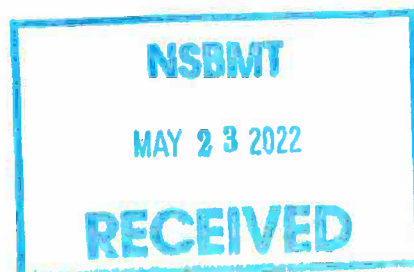
As soon as I entered the premise, I was greeted with a tall inspector. She asked me if I was working there. I told her what I was there for. She said okay. I went to the front desk to talk to the owner. Another inspector, shorter white female, near the front desk asked for my ID. She was later known as Vicky. I present my ID to Vicky. She immediately issued me a citation. I took the paper and approached the tall inspector who greeted me initially. She walked to the Vicky and told her that I did not work there. Later Vicky withdrew the citation from me. The tall inspector told me that there was no issue for me and I could leave. Due to the situation, I did not have a chance to talk to the owner, so I decided to leave.

All in all, I do not have a massage license and I have not practiced massage. I just happen to be at the inspection site. I thought the situation was cleared by both inspectors. I am not sure why I would be charged for a crime for doing nothing wrong. I hope that you can review this case to clear my name.

- 4) The amount of any order to reimburse the Board for the expenses incurred to investigate the violation; and
- 5) Whether any corrective action described in the citation is reasonable.

You may choose to have an attorney or other representative of your choosing present during the meeting, present written evidence, provide testimony, present witnesses relating to your character, alleged misconduct, professional competence, or physical or mental health.

If the Board determines it necessary, after considering your character, alleged misconduct, professional competence, or physical or mental health whether in a closed meeting or open meeting, it may take administrative action against you at this meeting. This informational statement is in lieu of any notice that may be required pursuant to NRS 241.034. This notice is provided to you under NRS 241.033. Please be aware you are one of many agenda items, and the Board may take items out of order. The meeting may last until 4:30 p.m.
