The Board may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person (NRS 241.030).

Public Comment Agenda Item: There was a time designated at the beginning and the end of the meeting for Public Comment. Members of the general public were able to bring matters not appearing on this Agenda to the attention of the Board or make comment on specific agenda items. Public comment also was taken at other such times as requested as long as the request for public comment did not interrupt ongoing Board business. The Board may have discussed the matters not on the agenda but did not act on the matters at this meeting. If the Board desired, the matters will be placed on a future Agenda for action. In consideration of others who may also wish to provide public comment, repetition was avoided. The Board limited public comment to three (3) minutes.

Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process rights of an individual, the Board may have refused to consider public comment (see NRS 233B.126). Please be aware that after the quasi-judicial Board rendered a decision in the contested case and, assuming this happened before adjournment, the Board may have entertained public comment on the proceeding.

1. Call to order and roll call of Board Members.

The meeting was called to order at 9:02 a.m. on March 30, 2022, by Chair Elisabeth Barnard. Board members in attendance included Vice Chair Deirdre Strunk, Secretary/Treasurer Richard Fields, Lorna Benedict, Rebecca Dorangricchia, Bianca Smith, John Teng, Stephanie Tsanas, and Sgt. Price with the Las Vegas Metropolitan Police Department. Additional attendees included Senior Deputy Attorney General Sophia Long, Board Counsel Colleen Platt, and Executive Director Sandy Anderson. Karen Kramberg joined the meeting at 1:20 p.m. and left the meeting at 5:00 p.m.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Chair Barnard read the mission statement into the record.

3. Public comment – Members of the public who wish to participate in a public meeting may do so by providing public comment during the two designated public comment periods. Additionally, public comment options may include, without limitation, telephonic or email comment. Action may not be taken on any matter brought up under public comment until scheduled on an agenda for action at a later meeting. The Board will not restrict comments based on viewpoint. The opportunity for public comment will be available at the beginning and ending of the meeting. (Discussion Only)

No public comment was provided by attendees.

Executive Director Anderson shared that there was only one written public comment submitted prior to the meeting and read the email received from Jayne Hydke.

Good morning,

It has come to my attention with the closures during the COVID 19 period came many issues relating to access to employment.

Not only did many therapists experience additional interference once the properties reopened. These additional experiences ranged from threatened violence increase to elevated expenses or thefts and financial damage to therapists' businesses and or personal property.

I am writing with these concerns and asking that the board take this into consideration with the fees involved for licensure.

I believe between the board and the therapists some alternative options can be created to assist with relief funds to keep all therapists active at all times.

Not only will this assist therapists with continued income this will allow the board to eliminate any decrease in collected renewal fees.

This action will create assistance to the public for access to alternative healthcare practices.

This action will assist the overall government with continuing worker stability.

I ask that the board make renewal fees with payment options ranging from Monthly, Pre Payment, Annually, and bi-annually.

With availability for instant renewal and digital copies of the license available if this would be possible.

When the board takes the public into consideration for this request, I ask that you see this request not only assists the public, but also assists the therapists which are part of the public interest.

 - a. Review Application Brian A. Bird. (For Discussion and Possible Action)

Brian Bird was present.

Management Analyst VanHorn presented the application of Brian A. Bird to the Board. Mr. Bird's massage application is before you today for review that could not be approved administratively. Mr. Bird was arrested on January 18, 1996, for criminal mischief and criminal endangerment by Billings Police Department with a conviction of assault with a sentencing term of suspended sentence of six (6) months; January 4,

1992, obstructing a peace officer or other public servant by Billings Police Department; July 29, 2000; for one count of battery by San Diego Sheriff's Office with a conviction of assault with a sentence term of 3-year probation with fines; and was cited by NSBMT for advertising without a license on March 16, 2020. Mr. Bird is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to issue a probationary license for two (2) years, report all contact with law enforcement within 48 hours, and submit fingerprints at respondent's expense at time of renewal. Motion withdrawn by Bianca Smith.

Motion by Bianca Smith to approve the application with no restrictions, seconded by Richard Fields. Motion carried.

b. Review Application Cierra D. Carter. (For Discussion and Possible Action)

Cierra Carter was present.

Management Analyst VanHorn presented the application of Cierra D. Carter to the Board. Ms. Carter's massage application is before you today for review that could not be approved administratively. Ms. Carter was arrested on March 17, 2019, for domestic battery by Sparks Police Department. Original charge was amended to disturbing the peace after a plea deal by Ms. Carter and the city attorney. Ms. Carter is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Chair Barnard to issue a probationary license for two (2) years, report contact with law enforcement personal within 48 hours after contact occurs and background investigation at renewal, seconded by Richard Fields. Motion carried unanimously.

c. Review Application Kelly G. Cerna-Rengifo. (For Discussion and Possible Action)

Kelly Cerna-Rengifo was present and represented by Dean Kajioka and assisted by paralegal Jacquelane Kopka.

John Teng shared that Ms. Cerna-Rengifo was one of his graduates and that he felt he could be impartial.

Management Analyst VanHorn presented the application of Kelly G. Cerna-Rengifo to the Board. Ms. Cerna-Rengifo's massage application is before you today for review that could not be approved administratively. Ms. Cerna-Rengifo was arrested on August 2, 2019, for pandering, act/encourage brothel, solicitation/engage in prostitution and live from earnings of prostitute by Las Vegas Metropolitan Police Department. During negotiations with the Clark County District Attorney's Office, Ms. Cerna-Rengifo entered a "Nolo Contendre (No Contest)" plea to amended charges to solicitation and disorderly conduct. Ms. Cerna-Rengifo is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to move to closed session per NRS.241.030, seconded by Elisabeth Barnard. Motion carried.

Motioned by Bianca Smith to return to open session per NRS.241.030, seconded by Richard Fields. Motion carried with no opposition.

Motioned by Bianca Smith to deny this application based on NRS 640C.700(1)(3)(4)(6)(9) and NAC 640C.410 (1)(a)(q)(r)(x), seconded by Lorna Benedict. Motion passed unanimously.

d. Review Application Dehua Duan. (For Discussion and Possible Action)

Dehua Duan was present and accompanied by her son Shijie Qin who served as a translator.

Management Analyst VanHorn presented the application of Dehua Duan to the Board. Ms. Duan's massage application is before you today for review that could not be approved administratively. Ms. Duan was previously licensed with NSBMT from August 2006 to August 2011. Her 2006 application with NSBMT listed Acupuncture and Massage Institute of America with a completion date of December 1999 and East-West Institute of Hand Therapy with a completion date in November of 2005. Ms. Duan has failed to disclose her previous license and establishment owner license by Florida Department of Health. Ms. Duan listed her 2021 application with education from Rosel School of Massage Therapy with a completion date of January 2013 and Fuzuba with a completion date of 2021. Additional education from other sources were not listed on recent application with NSBMT. Ms. Duan has failed to provide her previous Florida license and education from multiple massage programs. Ms. Duan currently has two business licenses listed with Clark County: Iris Day Spa and Li Ren Massage. Iris Day Spa has 108 reviews on Rubmaps.com with dates ranging from 2012 to 2021 and Li Ren Massage has 68 reviews on rubmaps.com with dates ranging from 2012 to 2021. Ms. Duan is requesting to be granted a license under NRS 640C.420 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to deny NRS 640C.700(1)(9) & NAC 640C.410(1)(j)(p) and/or (bb), seconded by Deirdre Strunk. Motion carried unanimously.

e. Review Application Edward T. Gao. (For Discussion and Possible Action)

Edward Gao was present.

Management Analyst VanHorn presented the application of Edward T. Gao to the Board. Mr. Gao's massage application is before you today for review that could not be approved administratively. Mr. Gao was previously licensed with NSBMT from April 2007 to April 2010. His 2007 application listed Acupuncture and Massage Institute of America with a completion date in July of 2005. Mr. Gao has failed to disclose his previous license and citation issued by Utah Division of Occupational & Professional Licensing for allowing an unlicensed person to perform massage in his business. Mr. Gao was the listed owner of the establishment where the unlicensed activity occurred. On September 5, 2012, Utah listed the citation on the National Practitioners Data Bank

(NPDB). Mr. Gao listed Acupuncture and Massage Institute of America and East-West Institute of Hand Therapy on his Utah license application. Mr. Gao has failed to provide his previous license, education from multiple massage programs and his citation. Mr. Gao is requesting to be granted a license under NRS 640C.420 and is before you today for review under NRS 640C.700.

Mr. Gao provided a statement to the Board that the omissions on his application were an honest mistake, and he would like to request to be able to add the information.

Motioned by Bianca Smith to deny the application based on NRS 640C.700(1)(2)(9) and/or (11) and NAC 640C.410(1)(j)(p)(q)(s), seconded by Richard Fields. Motion carried.

f. Review Application Joleen Y. Kwan. (For Discussion and Possible Action)

Joleen Kwan was present.

John Teng shared that Ms. Kwan was one of his graduates and that he felt he could be impartial.

Management Analyst VanHorn presented the application of Joleen Y. Kwan to the Board. Ms. Kwan's massage application is before you today for review that could not be approved administratively. Ms. Kwan was arrested for multiple drug related charges by San Jose Police Department or Chowchilla Women's Detention Center on different dates over a twelve (12) year period resulting in several convictions with sentences including prison for no more than sixteen (16) months, prison for no more than eight (8) months and no less than ninety (90) days in jail, sixteen (16) months in prison and a probation term of two (2) years with fines. Drug related charges include use/under influence of controlled substance, possession of controlled substance/sale, possession of controlled substance, possession of paraphernalia, and resisting/delaying or obstructing. Ms. Kwan is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700

Motioned by Bianca Smith to issue a probationary license for two (2) years under NRS 640C.700(3), report contact with law enforcement within 48 hours, a background check at the respondent's expense at the time of renewal, and random drug testing at the respondent's expense, seconded by Chair Barnard. Motion carried unanimously.

John Teng shared that Mr. Lonardo was one of his graduates and that he could be impartial.

Management Analyst VanHorn presented the application of Domenico R. Lonardo to the Board. Mr. Lonardo's massage application is before you today for review that could not be approved administratively. Mr. Lonardo was previously before the Board on January 12, 2022, and his application was tabled. The Board requested a report from

Mind/Brain Institute. Mr. Lonardo was arrested on June 5, 1999, for Assault 3rd degree by Rochester Police Department; September 12, 1999, for DUI by Rochester/Henrietta Police Department; September 18, 2001, for Possession of Marijuana by Hillsborough Sheriff's Office; May 6, 2010, for Conspiracy Marijuana of Domestic Origin by DEA-Rochester Division; person of interest for domestic battery on August 4, 2021, and arrested on August 17, 2021, for domestic battery by Las Vegas Metropolitan Police Department. Mr. Lonardo is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to issue a probationary license for 4 years based on NRS 640C.700(2)(3) and/or (9), report contact with law enforcement within 48 hours, quarterly reporting to the Executive Director, background investigations at renewal at the respondent's expense, seconded by Richard Fields. Motion carried.

h. Review Application Brandon L. Romeo. (For Discussion and Possible Action)

Brandon Romeo was present.

John Teng shared that Mr. Romeo was one of his graduates and that he could be impartial.

Management Analyst VanHorn presented the application of Brandon L. Romeo to the Board. Mr. Romeo's massage application is before you today for review that could not be approved administratively. Mr. Romeo was arrested on August 4, 2016, for Battery by Los Angeles Sheriff's Office; November 24, 2018, for attempted murder with a deadly weapon by Las Vegas Metropolitan Police Department, additional charge added on November 28, 2018 for destroy property of another by Nye County Sheriff's Office; March 14, 2020 for DUI by Las Vegas Metropolitan Police Department; March 19, 2020 for probation violation (DUI arrest) by Nevada Department of Public Safety Parole and Probation; and listed as a person of interest from an incident on June 5, 2021 by Las Vegas Metropolitan Police Department. Mr. Romeo is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Chair Barnard to deny based on NRS 640C.700(3) and/or (9) and NAC.640C.410 (1)(t), seconded by Bianca Smith. Motion carried.

i. Review Application Aylin D. Sanchez-Perez. (For Discussion and Possible Action)

Aylin Sanchez-Perez was not present.

John Teng shared that Ms. Sanchez-Perez was one of his graduates and that he could be impartial.

Management Analyst VanHorn presented the application of Aylin D. Sanchez-Perez to the Board. Ms. Sanchez-Perez' massage application is before you today for review that could not be approved administratively. Ms. Sanchez-Perez was arrested on June 17, 2016, for burglary, forgery, and attempted theft by Las Vegas Metropolitan Police Department. Ms. Sanchez-Perez accepted a plea deal and pled guilty to attempted forgery. Resulting in a conviction of petit larceny. Ms. Sanchez-Perez is requesting to

be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Karen Kramberg to deny based on NRS 640C.700(3), seconded by Richard Fields. Motion carried with no opposition.

j. Review Application Kitty H. Schlup. (For Discussion and Possible Action)

Kitty Schlup was present and represented by Joseph Gersten. Translation services provided by Yue "Lori" Teffs. The applicant's spouse David Schlup assisted Ms. Schlup with communication as well.

Management Analyst VanHorn presented the application of Kitty H. Schlup to the Board. Ms. Schlup's massage application is before you today for review that could not be approved administratively. Ms. Schlup has failed to disclose her previous certificate with California Massage Therapy Council (CAMTC) and disciplinary action for multiple violations with a final resolution of a revoked certificate by CAMTC. Ms. Schlup was the listed owner of the establishment where two undercover operations occurred, and sexual activity was solicited by two therapists certified by CAMTC. Ms. Schlup failed to provide her previous education, including previous disciplinary action. Ms. Schlup is requesting to be granted a license under NRS 640C.420 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to move to closed session per NRS.241.030, seconded by Chair Barnard.

Motioned by Bianca Smith to return to open session per NRS.241.030, seconded by Chair Barnard. Motion carried.

Motioned by Chair Barnard to deny based on NRS 640C.700(1)(9) and/or (11) and NAC 640C.410 (1)(j)(p)(q), seconded by Bianca Smith. Motion carried unanimously.

k. Review Application Deshawn R. Wilson. (For Discussion and Possible Action)

Deshawn Wilson was present.

Management Analyst VanHorn presented the application of Deshawn R. Wilson to the Board. Ms. Wilson's massage application is before you today for review that could not be approved administratively. Ms. Wilson was arrested on November 17, 2004, for petit larceny by New York City Police Department. Ms. Wilson was convicted of petit larceny with a requirement to complete 12 days of community service. After the completion of community service, the case was dismissed. Ms. Wilson is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to approve with no restrictions, seconded by Deirdre Strunk. Motion carried.

5. Early Termination of Probation Raeann M. Rigirozzi license number NVMT.10452 (For Discussion and Possible Action)

Management Analyst VanHorn presented the termination of probation application of Raeann M. Rigirozzi to the Board. Ms. Rigirozzi is requesting to be granted early termination of probation. Probation approval was issued by the Board on June 10, 2020, with a four (4) year term. Ms. Rigirozzi appealed the June 10th decision and was before the Board again on August 19, 2020. The original probation terms were upheld. Ms. Rigirozzi completed the required 12 hours of ethics and completed one background check review. Ms. Rigirozzi is requesting to be granted a non-restricted license under NRS 640C.420 and is before you today for termination of probation under NRS 640C.700.

The Board and Ms. Rigirozzi discussed her reasons for requesting early termination of probation.
