Narrative

On August 22, 2023, your affiant, Detective [Redacted], utilized the investigative resource called Rubmaps.com, and discovered a review for the White Lilly Spa, located at 5785 West Tropicana Avenue Las Vegas, Clark County Nevada 89103. The review which was posted yesterday on August 21, 2023 stated that subject entered into the business and received sex for payment.

On August 22nd 2023 at approximately 1700 hours, your affiant, Detective [Redacted], conducted follow up undercover operation in regards to soliciting and engaging in prostitution at White Lilly Spa located at 5785 West Tropicana Avenue Las Vegas, Clark County Nevada 89103.

During the operation, Undercover Detective [Redacted] entered the White Lilly Spa and was greeted by Wei Bal DOB [Redacted]/75. Wei Bal directed Detective [Redacted] into one of the massage rooms and directed him to undress. Detective [Redacted] did as instructed and Bal began to conduct the requested massage. Detective [Redacted] inquired about the cost for sex with Bal. Bal then stated to Detective [Redacted] that it would cost \$400 for sex with no condom. Detective [Redacted] advised surveillance detectives that he received a good deal for sexual intercourse from Bal. Surveillance Detectives entered the premises and Bal was taken into custody.
