1. Call to order and roll call of Board Members.

The meeting was called to order at 9:04 a.m. on August 8, 2023, by Chair Elisabeth Barnard. Board members in attendance included Vice Chair Deirdre Strunk, Secretary/Treasurer Rebecca Dorangricchia, Lorna Benedict, Christine Garvey, Rosemarie Mueller, Bianca Smith, John Teng. Additional attendees included Senior Deputy Attorney General Sophia Long as Prosecutor, Colleen Platt as Board Counsel, and Executive Director Sandy Anderson. Board member Stephanie Tsanas and Sgt. Fink were excused.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Chair Barnard read the mission statement into the record.

3. Public comment – Members of the public who wish to participate in a public meeting may do so by providing public comment during the two designated public comment periods. Additionally, public comment options may include, without limitation, telephonic or email comment. Action may not be taken on any matter brought up under public comment until scheduled on an agenda for action at a later meeting. The Board will not restrict comments based on viewpoint. The Chair shared how to make public comments.

No public comment was provided.

The Executive Director advised the Board that no written public comments were submitted prior to the meeting.

4. Election of officers (For Discussion and Possible Action)

Chair Barnard disclosed that she has applied for the position of Executive Director and turned the election of officers over to Vice Chair Strunk.

Christine Garvey requested information from legal counsel regarding the process of election of officers and if Ms. Barnard could be elected as chair. Legal counsel explained the election process and informed the Board that Ms. Barnard could still serve as Chair. If she is selected to appear before the Board as an applicant, she would have to recuse from the process at that time.

- a. Chair Lorna nominated Deirdre Strunk. Ms. Strunk declined due to professional commitments. Deirdre Strunk nominated Elisabeth Barnard, seconded by Lorna Benedict. Vice Chair Strunk asked if there were any other nominations. There being none. Motion carried. Bianca Smith wanted the record to reflect that she hopes that Ms. Barnard does make it through the selection process.
- b. Vice Chair Chair Barnard opened nominations for Vice Chair. Chair Barnard nominated Deirdre Strunk, seconded by Lorna Benedict. Chair Barnard called for any other nominations. There were none. Motioned by Elisebeth Barnard to retain Ms. Strunk as vice chair, seconded by Christine Garvey. Motion carried.
- c. Secretary-Treasurer Bianca Smith nominated Rebecca Dorangricchia, seconded by Vice Chair Strunk. Chair called for another nominations. There were none. Motioned by Bianca Smith to approve Rebecca Dorangricchia as Secretary-Treasurer for the Board, Deirdre seconded. Motion carried.

Motioned by Bianca Smith for probationary license for four (4) years, refrain from outcall services, report any contact with law enforcement within forty-eight (48) hours, employer report quarterly to the Board, within ninety (90) days takes two (2) ethics courses provided by the Federation of State Massage Therapy Boards REACH platform Human Trafficking and Sexual Boundaries, and submit to the board a complete set of finger prints annually at the licensees expense, seconded by Christine Garvey. Motion carried no opposition.

Management Analyst VanHorn presented the application of Aimin Zhang to the Board. Ms. Zhang's massage application is before you today for review that could not be approved administratively. Ms. Zhang is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Ms. Zhang provided a statement and asked the Board to grant her a license with a two (2) year probation.

Motioned by Bianca Smith to deny the application based on NRS 640C.700(4) and (9) and NAC 640C.410(1)(bb), seconded by Lorna Benedict. Motion carried.

    - i. Inspection Team calendar year-to-date key indicators

Director Anderson introduced Ryan Huffman to the Board as the newest team member. Becky SanGregorio was also introduced as the key employee for getting the Establishment Certificate applications generated, processed and certificates issued to licensees.

- b. Other topics
  - i. Status of the Jurisprudence Exam The exam is completed and available through the Federation of State Massage Therapy Board. We can add this to any disciplinary actions.
  - ii. Update from Nick Vander Poel of Flynn Guidici Government Affairs regarding the legislative session. Vander Poel provided a report to Director Anderson regarding the session. The report captured all aspects of the industry. In total 1234 Bill drafts requests, of those 1096 bills were introduced, 535 were signed by Governor Lombardo and 75 were vetoed by Governor Lombardo. Those 75 bills will be reconsidered in the next Legislative Session scheduled in 2025 depending on what happens in 2024. 295 bills did not make it through the process. For agency specific, we tracked 25 bills, 2 bills were vetoed that we will monitor for future Legislation. AB 153 regarding the Naprapathy Industry was under the Board of Health for regulation. SB 431 was the reorganization to oversee complaints and disputes in relation to Boards. It is new and we are going to watch and see how it operates. The final one, was the success story where the language from SB 270 was amended and placed into SB 161 for the Interstate Massage Compact during the final ten (10) seconds of the special

session and was approved. Nevada is officially first in the Nation to adopt the Interstate Compact.
