The application review for Ms. Zhongqiong Yang is set for August 8. The matter was previously continued for me to attempt to obtain records from her two previous California criminal cases. Please add this information to her pending application:

- 1. Ms. Yang was arrested in 2018 in the City of Anaheim under citation number AN1651380 with a single charge or prostitution. The citation was never prosecuted by the Anaheim authorities, as it was not formally filed as criminal case in the Anaheim court. I did send a records request to the Anaheim Police Department to obtain any records of the event, however, the Anaheim Police denied my records request as apparently California law does not allow a suspect to obtain police investigatory records. See Exh. 1, Anaheim Police letter attached.
- 2. In 2022, Ms. Yang was arrested regarding a domestic violence incident with her husband. On July 26, 2023, the Rancho Cucamonga Superior Court entered an order dismissing both charges in the matter due to insufficient evidence. Exh. 2, Minute Order, attached. Based on this Order, the 2022 criminal case is now dismissed with no convictions.

Please supplement Ms. Yang's existing application documents with this information. Thank you.
