Public comment was taken at the beginning and the end of the meeting. The Board may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person (NRS 241.030).

Public Comment Agenda Item: There was a time designated at the beginning and the end of the meeting for Public Comment. Members of the general public were able to bring matters not appearing on this Agenda to the attention of the Board or make comment on specific agenda items. Public comment also was taken at other such times as requested as long as the request for public comment did not interrupt ongoing Board business. The Board may have discussed the matters not on the agenda but did not act on the matters at this meeting. If the Board desired, the matters will be placed on a future Agenda for action. In consideration of others who wished to provide public comment, repetition was avoided. The Board limited public comment to three (3) minutes.

Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process rights of an individual, the Board may have refused to consider public comment (see NRS 233B.126). Please be aware that after the quasi-judicial Board rendered a decision in the contested case and, assuming this happened before adjournment, the Board may have entertained public comment on the proceeding.

1. Call to order and roll call of Board Members.

The meeting was called to order at 9:03 a.m. on October 26, 2022, by Chair Elisabeth Barnard. Board members in attendance included Secretary-Treasurer Rebecca Dorangricchia, Lorna Benedict, Christine Garvey, Bianca Smith, John Teng (left the meeting at 5:45 p.m.), Stephanie Tsanas, and Sgt. Aaron Fink with the Las Vegas Metropolitan Police Department. Additional attendees included Senior Deputy Attorney General Sophia Long (joined the meeting at 10:30 a.m.), Board Counsel Colleen Platt, and Executive Director Sandy Anderson. Vice Chair Deirdre Strunk was excused.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Chair Barnard read the mission statement into the record.

3. Public comment – Members of the public who wish to participate in a public meeting may do so by providing public comment during the two designated public comment periods. Additionally, public comment options may include, without limitation, telephonic or email comment. Action may not be taken on any matter brought up under public comment until scheduled on an agenda for action at a later meeting. The Board will not restrict comments based on viewpoint. The opportunity for public comment will be available at the beginning and ending of the meeting. (Discussion Only)

Morgan Blackwell requested that the Board address NAC 640C regarding the draping wording used stating that the current language would not protect transgender males.

Elizabeth Benion, AMTA Nevada Chapter President, read the Governor's Proclamation proclaiming October 23<sup>rd</sup> through 29<sup>th</sup>, *Massage Therapy Awareness Week in Nevada*.

*Whereas*, massage therapy is beneficial to overall health, and is increasingly part of integrated healthcare; and

Whereas, physicians are prescribing massage to complement traditional medical treatment for illness, injury, and pain; In 2021, 63% of consumers who got a massage for health and wellness reasons stated it was part of a treatment plan from a doctor or medical provider and pain relief or pain management was a top concern when consumers discussed massage with a doctor; 83% eighty-three percent of Americans believe massage therapy should be considered a form of health care; and

*Whereas*, massage therapy has become an important part of work-related stress relief and recovery from sports-related injuries; and

Whereas, significant evidence supports the inclusion of massage therapy to achieve many important, positive patient health outcomes, including for those people in various stages of recovery from chronic medical conditions, like low back pain, neck and shoulder pain, and headache; acute medical conditions, like post-operative pain and lymphatic drainage, and behavioral health conditions, like anxiety and stress, depression, PTSD, and; substance use disorder; and

Whereas, a 2017 economic modeling analysis indicates that as many as 5 million people in the United States could potentially benefit from massage therapy for pain relief while reducing the number of people with addiction disorder by over 100,000 per year; and Whereas, e market size of the massage therapy industry is estimated to be \$16.6 Billion in 2022, and more than 350 massage therapists were employed in the United States in 2021, an increase of 14% over the last decade, and employment numbers projected to increase by over 20% by 2031; and

*Whereas*, in the Silver State thousands of licensed massage therapists provide a variety of treatment options for Nevadans as part of their overall health and wellness plans; *NOW, THEREFORE, I, STEVE SISOLAK, GOVERNOR OF THE STATE OF NEVADA*, do hereby proclaim the week of October 23 – 29, 2022 as **MASSAGE THERAPY AWARENESS WEEK IN NEVADA** 

Executive Director Anderson shared that former board member Robert "Bob" Oliver passed away on Thursday, October 20, 2022. Mr. Oliver and his wife ran the Ralston School of Massage from 1988 to 2011 training over 2000 students. They also provided services at the Ralston Massage Center from 1999-2020. A moment of silence in honor of Mr. Oliver was observed.

The Executive Director advised the Board that no written public comments were submitted prior to the meeting.

Chair Barnard introduced Christine Garvey and welcomed her to the Board.

b. Introduction of Board Member representing Washoe County

The vacancy was not filled at the time of the meeting.

5. Probation Review Anthony B. Gilyard Jr. license number NVMT.9083. (For Discussion and Possible Action)

Anthony Gilyard was present. He completed the terms of the probation and appeared before the Board as required in the Order.

Motioned by Chair Barnard to terminate Mr. Gilyard's probation, seconded by Bianca Smith. Motion passed unanimously.

6. Probation Reconsideration Request Ashley A. Pedraza. license number NVMT.11597. (For Discussion and Possible Action)

Ashley Pedraza was present. She requested that the Board remove the restriction for performing outcall services so that she can do post operative care for client's that have had Brazilian Butt Lifts.

Motioned by Chair Barnard to deny the request for reconsideration of probation, seconded by Lorna Benedict. Motion carried unanimously.

7. Request for Reinstatement Kendal L. Priestly. (The Board may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person.) (For Possible Action)

Kendal L. Priestly was present.

Management Analyst VanHorn presented the Request for Reinstatement of Kendal L. Priestly to the Board. Ms. Priestly was previously licensed by NSBMT in January of 2020 with probationary restrictions. In September of 2020, Ms. Priestly failed a random drug test, resulting in a violation of her probation terms. During a probation hearing on November 4, 2020, Ms. Priestly was found guilty of the violations and was revoked for a term of one year. Ms. Priestly is requesting to be granted a reinstatement license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Ms. Preistly made a statement to the Board.

Motioned by Bianca Smith to reinstate Ms. Priestly's license with a 2-year probation, drug testing, background check, refrain from providing outcall services, report any contact with law enforcement within forty- eight (48) hours, notify the Board of any changes in residence or employment in fifteen (15) days, submit to random drug testing, seconded by Rebecca Dorangricchia. Motion carried unanimously.

  - a. Review Application Jajuane D. Fisher. (For Discussion and Possible Action)

Jajuane D. Fisher was present.

Management Analyst VanHorn presented the application of Jajuane Fisher to the Board. Mr. Fisher's massage application is before you today for review that could not be approved administratively. Over a twenty-six (26) year period, Mr. Fisher had multiple convictions including four (4) DUI convictions, and twenty-two (22) traffic or moving violations. Mr. Fisher is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Chair Barnard explained the process to Mr. Fisher. Mr. Fisher made a statement to the Board regarding his history and his experience at Northwest Career College.

Application tabled to allow for the outcome of the most recent arrest.

b. Review Application Svetlana N. Harding. (For Discussion and Possible Action)

Svetlana N. Harding was present.

Management Analyst VanHorn presented the application of Svetlana Harding to the Board. Ms. Harding's massage application is before you today for review that could not be approved administratively. Ms. Harding was arrested on February 1, 2003, for battery on spouse/ex-spouse by Santa Ana Police Department. Ms. Harding plead guilty to battery resulting in a three (3) year term of probation. Probation completed on or around April 30, 2010. Arrested on March 4, 2003, for three (3) counts of willful cruelty to a child by San Bernardino Sheriff's Office. Ms. Harding plead guilty to three (3) counts of cruelty to a child and was granted four (4) years of probation. Probation completed on or around June 14, 2010. Arrested on March 13, 2008, for one (1) count of burglary by San Bernardino's Sheriff's office. The burglary charge was amended to petit theft and Ms. Harding accepted a "Nolo contendere" plea deal. Ms. Harding was sentenced to 36 months of probation with additional terms of violate no law other than minor traffic, pay \$100.00 to victim restitution fund, pay \$20.00 surcharge, 10% administrative fee, serve 1 day in jail facility with credit for time served of one day and stay away from Sears. Ms. Harding is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to issue a license with no restrictions, seconded by Stephanie Tsanas. Motion carried unanimously.

c. Review Application Elena A. Irivboje. (For Discussion and Possible Action)

Elena A. Irivboje was present.

Management Analyst VanHorn presented the application of Elena Irivboje to the Board. Ms. Irivboje's massage application is before you today for review that could not be approved administratively. Ms. Irivboje was arrested on April 10, 2017, for inflict corporal injury to spouse/cohabitant and assault with a deadly weapon other than firearm by Bakersfield Police Department. Inflict corporal injury charge was dismissed during negotiations. Ms. Irivboje plead nolo contender and was sentenced to jail for 90 days with credit/time served followed by five (5) years of probation with community service of 720 hours and fines of \$870.00. All sentencing requirements have been completed as of October 15, 2021. Ms. Irivboje is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Chair Barnard to grant a probationary license for two (2) years with report all contact with law enforcement within forty-eight (48) hours, reports from employer every six (6) months, report any changes in employment to the Board within fifteen (15) days, and no outcall massage, seconded by Bianca Smith. Motion carried unanimously.

d. Review Application Chaquita R. Kelly. (For Discussion and Possible Action)

Chaquita R. Kelly was present.

Management Analyst VanHorn presented the application of Chaquita R. Kelly to the Board. Ms. Kelly's massage application is before you today for review that could not be approved administratively. Over a fifteen (15) year period, Ms. Kelly had multiple convictions including three (3) burglary convictions, one (1) theft conviction, one (1) soliciting prostitution conviction, and eight (8) trespassing convictions one of which was an arrest for prostitution. Ms. Kelly is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Stephanie Tsanas to move to closed session, seconded by Chair Barnard. Motion carried.

Motioned by Bianca Smith to return to open session, seconded by Stephanie Tsanas. Motion carried.

e. Review Application Hiu H. Tse. (For Discussion and Possible Action)

Hiu H. Tse was present and assisted by her son Michael Mak.

Management Analyst VanHorn presented the application of Hiu Tse to the Board. Ms. Tse's massage application is before you today for review that could not be approved administratively. Ms. Tse failed to disclose her previous license in Florida and the disciplinary action of a voluntary surrender of licensed invoked by the Florida Board of Massage Therapy. Ms. Tse is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to deny application based on NRS 640C.700(9) and/or (11) and NAC 640C.410(1)(q), seconded by Rebecca Dorangricchia. Motion carried.

f. Review Application Aihua Yuan. (For Discussion and Possible Action)

Aihua Yuan was present with interpreter Baoqin Wang.

Ms. Yuan failed to disclose her previous citation issued on August 20, 2021, by Utah Division of Occupational & Professional Licensing for offering to perform a massage at Angel Massage without possessing a State of Utah massage license. A fine amount of \$500.00 was referred to collections for nonpayment until paid on March 2, 2022. Ms. Yuan is requesting to be granted a license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to deny based on NRS 640C.700(9) and/or (11) and NAC 640C.410(1)(q), seconded by Rebecca Dorangricchia. Motion carried unanimously.

Motioned by Bianca Smith to accept the settlement agreement, seconded by Rebecca Dorangricchia. Motion carried unanimously.

Senior Deputy Attorney General Sophia Long presented the case regarding Shekiara Pettway NVMT.11360 – Case Number NVMT-B-2221 to the Board. Ms. Pettway was not present.

Ms. Long advised the board regarding NRS 622A.350 and the requirements for notification.

Board Counsel Platt swore in Tereza VanHorn. Ms. VanHorn provided testimony that Ms. Pettway was provided sufficient legal notice per NRS 622A.350 and was served notice at the last known address on file with the Board. Ms. Pettway had not responded to the notice.

Bianca Smith disclosed that she knows this person but does not believe the relationship will have any impact on her decision.

Motioned by Chair Barnard that Shekiara Pettway had been properly noticed, seconded by Bianca Smith. Motion carried.

Ms. Long presented the Complaint Notice of Hearing regarding Shekiara Pettway. Ms. Long requested that an exhibit packet be accepted into evidence. Chair Barnard accepted the packet.

Motioned by Chair Barnard to accept the alleged facts as true and violations of law Counts 1 and 2 did occur, seconded by Bianca Smith. Motion carried with no opposition.

Motioned by Stephanie Tsanas to revoke for one (1) year, seconded by Lorna Benedict. Motion carried unanimously.

19. Formal Hearing Guoli Song NVMT.10890 – Case Number NVMT-P-2220. (For Discussion and Possible Action)

This item was tabled to allow the Department of Public Safety time to process the background.

Prior to hearing the reconsiderations, Board Counsel Platt advised the Board regarding NRS 622A.390 and the grounds for reconsideration.

5. A motion requesting a rehearing or reconsideration may be based only on one of the following grounds: (a) Newly discovered or available evidence.

(b) Error in the hearing or in the findings and recommendations or the decision that would be grounds for reversal of the findings and recommendations or the decision.

(c) The need in the public interest for further consideration of the issues or evidence, or both.

In looking at the items, you would likely need to find that the grounds for the new action is (c). Here are the things you can do:

6. The regulatory body or hearing panel or officer shall enter an order ruling on the motion requesting a rehearing or reconsideration not later than 25 days after the date on which the motion is filed. A copy of the order must be served on each party. The regulatory body or hearing panel or officer may:

- (a) Deny the motion;
- (b) Order a rehearing or partial rehearing;
- (c) Order reconsideration of the findings and recommendations or the decision; or
- (d) Direct other proceedings as the regulatory body or hearing panel or officer deems appropriate.

#### And a limit on the rehearing:

7. If the regulatory body or hearing panel or officer orders a rehearing, the rehearing must be confined to the issues upon which the rehearing was ordered.

## 20. Reconsideration Hong Lu NVRF.0112 – Case Number NVMT-C-22005. (For Discussion and Possible Action)

Ms. Lu was present and represented by legal counsel Kirk Kennedy Nevada State Bar #5032.

Mr. Kennedy provided information regarding why the case should be reconsidered since had he represented Ms. Lu, he would have negotiated a settlement agreement or voluntary surrender for three (3) years.

Motioned by Bianca Smith to deny the reconsideration of Case Number NVMT-C-22005 regarding Hong Lu, seconded by Lorna Benedict. Motion carried.

21. Formal Hearing Hong Lu NVRF.0112 – Case Number NVMT-C-22005 (For Discussion and Possible Action)

Reconsideration denied. This item was not heard.

Senior Deputy Attorney General Sophia Long advised the Board regarding the history of this case.

Ms. Xu-Rode was present and represented by legal counsel Yoa "Kelvin" Wen Nevada State Bar #14299.

Mr. Wen provided a statement regarding why the fines should be vacated due to Ms. Xu-Rode's health issues.

Motioned by Bianca Smith to deny the reconsideration of Case Number NVMT-C-22040 regarding Hongying Xu-Rode, seconded by Chair Barnard. Motion carried unanimously.

23. Request that the final decision of the Board Case Number NVMT-C-22036 regarding Frank Lisa NVMT.10366 be vacated and a request for a rehearing of Case Number NVMT-C-22036. (For Discussion and Possible Action)

Mr. Lisa was present.

Senior Deputy Attorney General Sophia Long advised the Board regarding the history of this case. Ms. Long requested that Mr. Lisa's license be reinstated as of October 26, 2022.

Motioned by Rebecca Dorangricchia to grant the reconsideration and reduce the suspension to 64 days for Case Number NVMT-C-22036 regarding Frank A. Lisa, seconded by Bianca Smith. Motion carried.

24. Citation Appeal Jingjing Yang NVMT.10956 – Citation 22019. (For Discussion and Possible Action)

Jingjing Yang was present and was assisted by Jerry Xu. Ms. Yang shared why she felt the citation should be dismissed.

Motioned by Bianca Smith to deny the citation appeal, seconded by Lorna Benedict. Motion carried unanimously.

25. Citation Appeal Mario Hawkins – Citation 22035. (For Discussion and Possible Action)

Mario Hawkins was present representing the Massage Envy.

Bianca Smith recused because she is employed by Mr. Hawkins as a massage therapist.

Board Counsel Platt swore in Vicki-Lynne Kitzman and Mario Hawkins.

Inspector Kitzman provided information regarding the issuance of the citation including requesting that the inspection forms be admitted as exhibits. Mr. Hawkins had no objection to the exhibits being admitted into evidence. Chair Barnard accepted the exhibits.

Mr. Hawkins provided a statement regarding their processes and that he thought he had until September 20<sup>th</sup> to come into compliance and that he was unaware of the previous out of compliance inspections. He informed the Board that he has processes in place to ensure notification going forward.

Motioned by Stephanie Tsanas to deny the appeal, seconded by Lorna Benedict. Motion carried unanimously.

26. Continuing education review for hours submitted by Sandra F. Atcheson NVMT.2626. (For Discussion and Possible Action)

Sandra Atcheson was not present.

Motioned by Bianca Smith to deny, seconded by Stephanie Tsanas. Motion carried unanimously.

The Board issued 394 new licenses and renewed 1,549 licenses resulting in a total of 5,178 licensees as of September 30, 2022. She also shared that after attending the FSMTB Annual Meeting that licensing is down across the country.

ii. Inspection Team calendar year-to-date key indicators

Investigator Brunner advised the Board that the new position had been filled by Becky SanGregorio who will be starting on October 31, 2022.

The team has addressed 362 outcall licensees with 192 reporting that they do not practice outcall. They also completed 777 establishment inspections or 87% completion.

iii. Complaints and investigations calendar year-to-date key indicators

Investigator Brunner shared that 67 investigations have been closed in 2022 and that there are 11 investigations pending as of October 26, 2022.

Counsel recommended at the very least the Board provide fillable PDF forms for download, completion, and submission.

Motioned by Chair Barnard to approve the forms as presented, seconded by Bianca Smith. Motion carried.

35. Discussion and possible action regarding possible changes to NRS 640C, including, without limitation, the adoption of the IMpact (Compact for Massage Therapy). (For Discussion and Possible Action)

The Board discussed possible changes to NRS 640C.

Motion by Chair Barnard to have Board Counsel draft language for a Bill Draft Request including enabling language for the compact, revise NRS.640C.750 to allow the Executive Director to sign subpoenas, revise citation statute to allow citations for outcall inspections, and licensee can request a waiver of continued education units for licensees in practice for twenty years with clean disciplinary record and have been active and in good standing, seconded by Bianca Smith. Motion carried unanimously.

- 36. Discussion and possible action regarding possible changes to NAC 640C including without limitation: (For Discussion and Possible Action)
  - a. Revise NAC 640C.050 to allow only the Massage and Bodywork Licensing Examination administered by the Federation of State Massage Therapy Boards.
  - b. Revise NAC 640C.052 to adopt the Entry Level Analysis Project (ELAP) working group sponsored by 7 national massage therapy organizations recommendation of six hundred twenty-five (625) hours of education for entry level competency including
  - c. Revise NAC 640C.052 to increase regulation as it relates to education and standardizing education beyond the hours and the programs possibly with a limit on the number of hours per day in the foundational education program. Limiting the number of hours per day in an education program, to 8 clock hours with clock hour defined as 60 minutes with 50 minutes instruction and 10 minutes of break and require that students be given a 30-minute continuous break after either 4 or 6 hours of instruction. Other possibilities include limiting the time frame for completion of a program to no less than 4-6 months. (Info: full time is considered 160 hours per month 4 months would equal 640 hours maximum.)

  - f. Revise NAC 640C.100 add approved by FSMTB or provided through CE Registry.
  - g. Add sexual harassment in the workplace to unethical conduct as defined in NAC 640C.410.
  - h. Revise NAC 640C.450 to:
    - i. Include fines for not being properly licensed as a Nevada business with the Office of the Secretary of State and/or municipalities. (For Discussion and Possible Action).
    - ii. Include fines for failure to comply with inspections including outcall inspections.
    - iii. Include fine for failure to notify the Board of change in work location within 30 days or 45 days. (For Discussion and Possible Action)
