Peng Li's Statement Regarding the Previous Arrest Record

My name is Peng Li. I have been a circus performer for over twenty years. In 2012, I was involved in a serious car crash and suffered a long-term spinal injury. It caused a lot of pain and took me over four years to slowly recover from the spinal problems. During that period of time, I used a lot of steroid injections to help my back pain during the treatment. The doctors also prescribed pain medication many times. In 2015 and 2016, I ran into problems with multiple teeth and suffered serious tooth-ache. Due to lack of dental insurance, I could not afford getting treatments from a dentist. So I had to ask for my medical doctors for medication to alleviate my tooth pain. Within that period of time, I was prescribed pain medication about two dozen times and I used all the medication to cope with my pain. Because I was travelling with the circus team, I saw many doctors at different location as we toured the country.

In 2016, I was questioned by a special agent regarding my prescribed medication. The agent suspected that I was in a crime group that cooped up all the controlled medication and dealt them on the black market. I explained my situations. But I was told that it was illegal to obtain the controlled medication too often from multiple prescriptions. I did not know that before and had no intention to do anything illegal. I thought that was the only way for me to get out the pain. At the time when I was arrested, I was charged with two dozens of counts of crimes. After my explanation and further investigation, the court dropped the charges into one and sentenced me to two-year probation.

From this event, I learned a lot about the laws in controlled medications. I was not supposed to obtain the similar prescriptions from different medical doctors. I should have showed all my previous prescriptions to every doctor I saw, so that the doctors could've help me avoiding this serious issue. Ever since that, I have carefully followed all the laws and regulations and never had any trouble with the law.

I realized my mistake and learned a hard lesson from what happened. I hope that I can move on with more knowledge and wisdom. As I become older, I am not longer fit to be a circus performer. Because my experience with the physical trainer and therapists during my performance career, I have learned a lot about manual therapy and treatment techniques. I would love to further my study in this area and become a sport massage <u>therapist myself</u>
