Public comment was taken at the beginning and the end of the meeting. The Board may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person (NRS 241.030).

Public Comment Agenda Item: There was a time designated at the beginning and the end of the meeting for Public Comment. Members of the general public were able to bring matters not appearing on this Agenda to the attention of the Board or make comment on specific agenda items. Public comments also were taken at other such times as requested as long as the request for public comment did not interrupt ongoing Board business. The Board may have discussed the matters not on the agenda but did not act on the matters at this meeting. If the Board desired, the matters would be placed on a future Agenda for action. In consideration of others who wished to provide public comment, repetition was avoided. The Board limited public comment to three (3) minutes.

Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process rights of an individual, the Board may have refused to consider public comment (see NRS 233B.126). Please be aware that after the quasi-judicial Board rendered a decision in the contested case and, assuming this happened before adjournment, the Board may have entertained public comment on the proceeding.

1. Call to order and roll call of Board Members.

The meeting was called to order at 9:01 a.m. on March 22, 2023, by Secretary-Treasurer Rebecca Dorangricchia, Board members in attendance included Lorna Benedict, Christine Garvey, Rosemarie Mueller, Bianca Smith, John Teng, Stephanie Tsanas, and Sgt. Aaron Fink with the Las Vegas Metropolitan Police Department. Additional attendees included Senior Deputy Attorney General Sophia Long as Prosecutor and Deputy Attorney General Joel Bekker as Board Counsel. Chair Elisabeth Barnard and Executive Director Sandy Anderson joined the meeting at 10:01a.m. Vice Chair Deirdre Strunk was excused.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Secretary-Treasurer Dorangricchia read the mission statement into the record.

3. Public comment – Members of the public who wish to participate in a public meeting may do so by providing public comment during the two designated public comment periods. Additionally, public comment options may include, without limitation, telephonic or email comment. Action may not be taken on any matter brought up under public comment until scheduled on an agenda for action at a later meeting. The Board will not restrict comments based on viewpoint. The opportunity for public comment will be available at the beginning and ending of the meeting. (Discussion Only)

Elizabeth Benion read the American Massage Therapy Association Nevada Chapter letter of support for SB 270 into the record (copy attached as Exhibit B).

Management Analyst Tereza VanHorn advised the Board that no additional written public comments were submitted prior to the meeting.

4. Request for Early Termination of Probation Chantal Roybal license number NVMT.10713. (For Discussion and Possible Action)

Chantal Roybal present.

Management Analyst VanHorn presented the early termination of probation of Chantal Roybal to the Board. Ms. Roybal's early probation termination application is before you today for review. In January of 2021, Ms. Roybal was granted a probationary license with a four-year term. Ms. Roybal has maintained a satisfactory probation over the two (2) years since her approval and is requesting to be granted an un-restricted massage license under NRS 640C.580 and is before you today for review under NRS 640C.700.

Motioned by Bianca Smith to deny early termination of probation, seconded by Stephanie Tsanas. Motion carried.
