### COMPLAINT AND NOTICE OF HEARING

The Nevada State Board of Massage Therapy ("Board"), by and through its Executive Director, Sandra Anderson, hereby notifies Anthony P. Miera ("Respondent") of an administrative hearing, which is to be held pursuant to Chapters 233B, 622, 622A of the Nevada Revised Statutes (NRS) and 640C of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC). The purpose of the hearing is to consider the allegations stated below and to determine if the Respondent should be subject to an administrative penalty as set forth in NRS 640C.710, if the stated allegations are proven at the hearing by the evidence presented.

Respondent is currently and at all times mentioned herein, licensed as a massage therapist in the State of Nevada and is therefore, subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C.

# IT IS HEREBY ALLEGED AND CHARGED AS FOLLOWS:

## ALLEGED FACTS

- On or about January 13, 2023, Respondent, while working at Tony's Vegas Massage located at 8751 W. Charleston Blvd., Las Vegas, Nevada 89117, massaged V.C.'s breasts and touched her nipples during the course of massage.
- 2. V.C. was presented with a breast massage consent form prior to the massage and V.C. did not give Respondent consent to massage her breasts during the massage.
- 3. During the massage, Respondent further placed his mouth on each of her areola as he licked her nipples with his tongue.

4. Respondent is the owner of Tony's Vegas Massage.

5. Respondent falsely advertised on his website that he was NCBTMB (National 1 Certification Board for Therapeutic Massage and Bodywork) certified; he is not. 2 6. As of today, Respondent advertises on his website, tonysvegasmassage.com, that he 3 performs outcall services. 4 5 **VIOLATIONS OF LAW** 6 **COUNT ONE** 7 7. By touching V.C.'s nipples during the course of a massage, Respondent violated the 8 provisions of NRS 640C.700(4) and/or (9). This is grounds for discipline pursuant to NRS 640C.700(2). 9 **COUNT TWO** 10 8. By massaging V.C.'s breasts without consent during the course of a massage, Respondent 11 violated the provisions of NRS 640C.700(4) and/or (9). This is grounds for discipline 12 pursuant to NRS 640C.700(2). 13 **COUNT THREE** 14 9. By putting his mouth on each of V.C.'s areolas and licking her nipples during the course 15 of a massage, Respondent violated the provisions of NRS 640C.700(9) and/or NAC 16 640C.340. This is grounds for discipline pursuant to NRS 640C.700(2). **COUNT FOUR** 17 10. By advertising that Respondent is NCBTMB certified when he is not, Respondent 18 violated the provisions of NRS 640C.930(2), NRS 640C.700(14) and/or (9). This is 19 grounds for discipline pursuant to NRS 640C.700(2). 20 21 PRAYER FOR RELIEF 22 WHEREFORE, Executive Director, Sandra Anderson, prays as follows: 23 11. That the Board conduct a hearing on this complaint as provided by statute, and after such 24 hearing, that the Board impose upon Respondent the discipline permitted by NRS 25 640C.710, which may include the following, (a) the imposition of an administrative fine of 26 not more than \$5,000.00 per violation, (b) recovery of reasonable investigative fees and costs 27 28 incurred, (c) recovery of attorney fees pursuant to NRS 622.400, (d) licensee be publicly

licensee on probation, and/or (g) such other impositions as may be permitted by Nevada law. PLEASE TAKE NOTICE that a disciplinary hearing has been set to consider this Administrative Complaint against the above-named Respondent in accordance with Chapters 233B, 622, 622A and 640C of the Nevada Revised Statutes. THE HEARING WILL TAKE PLACE on Wednesday, March 22, 2023, commencing at 9:00 a.m. or as soon thereafter as the Board is able to hear the matter with video conferencing by Zoom. You have the right to request that the Board issue subpoenas to compel witnesses to testify and/or evidence to be offered on your behalf. In making this request, you may be required to demonstrate the relevancy of the witnesses' testimony and/or evidence.

The purpose of the hearing is to determine if the Respondent has violated the provisions of Chapter 640C of NRS and if the allegations contained herein are substantially proven by the evidence presented to further determine what administrative penalty is to be assessed against the Respondent, if any, pursuant to NRS 640C.710.

Should the Respondent fail to appear at the hearing, a decision may still be reached by the Board. As the Respondent, you are further advised that you may be charged with the attorney's fees and/or costs associated with the hearing pursuant to NRS 622.400.

Pursuant to NRS 233B.121(5), informal disposition of this case may be made by stipulation, agreed settlement, consent order, or default. Any attempt to negotiate this case should be made by contacting Sandra Anderson, (775) 687-9951 or sjanderson@lmt.nv.gov.

Pursuant to NRS 241.033(2)(b), the Nevada State Board of Massage Therapy may, without further notice, take administrative action against your license and/or certificate to practice within the State of Nevada if the Board determines that such administrative action is warranted after considering your character, alleged misconduct, professional competence, or physical or mental health.
