**SUMMARY SUSPENSION OF LICENSE**

This matter having been considered by ELISABETH BARNARD, Chairperson of the Nevada State Board of Massage Therapy (“Board”) and following investigation by the Board, and for good cause appearing, pursuant to the provisions of NRS 233B.127, the Administrator finds as follows:

**FINDINGS OF FACT**

1. ANTHONY P. MIERA (“MIERA”) is licensed by the Board as a massage therapist, pursuant to the provisions of Nevada Revised Statutes and Nevada Administrative Code chapters 640C, license no. 9622.

2. MIERA is subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C and NAC Chapter 640C.

3. On or about January 13, 2023, MIERA, while working at Tony’s Vegas Massage located at 8751 W. Charleston Blvd., Las Vegas, Nevada 89117, massaged V.C.’s breasts and touched her nipples during the course of massage.

4. V.C. was presented with a breast massage consent form prior to the massage and V.C. did not give MIERA consent to massage her breasts during the massage.

5. During the massage, MIERA further placed his mouth on each of her areola as he licked her nipples with his tongue.

6. MIERA is the owner of Tony’s Vegas Massage.

1 7. MIERA falsely advertised on his website that he was NCBTMB (National  
2 Certification Board for Therapeutic Massage and Bodywork) certified; he is not.

3 8. As of today, MIERA advertises on his website, tonysvegasmassage.com, that he  
4 performs outcall services.

5 9. As a result of the foregoing conduct, MIERA acted unprofessionally in violation of  
6 NRS 640C.700(2), (4) and/or (9).

8 **CONCLUSION**

9 10. Emergency circumstances exist which pose a risk to public welfare, which require  
10 immediate action on the part of the Board.

12 **ORDER**

13 IT IS HEREBY ORDERED that ANTHONY MIERA's license to act as a massage therapist  
14 in the State of Nevada is hereby immediately **SUMMARILY SUSPENDED**.  
15 THE SUMMARY SUSPENSION HEREBY ORDERED is effective upon the Chairperson's  
16 execution of this Order. A hearing for revocation and/or other administrative penalty as set forth in  
17 NRS 640C.710 of MEIRA'S license is scheduled for **March 22, 2023, commencing at 9:00 a.m., or**  
18 **as soon thereafter as the Board is able to hear the matter, with video conferencing by Zoom.**
