6	NRS 640C.700(2), (4) and/or (9).

13	IT IS HEREBY ORDERED that ANTHONY MIERA's license to act as a massage therapist		
14	in the State of Nevada is hereby immediately SUMMARILY SUSPENDED.

16	execution of this Order. A hearing for revocation and/or other administrative penalty as set forth in		
17	NRS 640C.710 of MEIRA'S license is scheduled for March 22, 2023, commencing at 9:00 a.m., or
