## **MINUTES**

**Please Note:** The Nevada State Board of Massage Therapy may: 1) take agenda items out of order; 2) combine two or more items for consideration; or 3) remove an item from the agenda or delay discussion related to an item at any time. Reasonable efforts were made to assist and accommodate individuals with disabilities who wished to attend the meeting by contacting Sandy Anderson at 775.687.9951 (sjanderson@lmt.nv.gov), in advance, so that arrangements could be made. Public comment was taken at the beginning and the end of the meeting. The Board may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person (NRS 241.030).

Public Comment Agenda Item: There was a time designated at the beginning and the end of the meeting for Public Comment. Members of the general public were able to bring matters not appearing on this Agenda to the attention of the Board or make comment on specific agenda items. Public comments also were taken at other such times as requested as long as the request for public comment did not interrupt ongoing Board business. The Board may have discussed the matters not on the agenda but did not act on the matters at this meeting. If the Board desired, the matters would be placed on a future Agenda for action. In consideration of others who wished to provide public comment, repetition was avoided. The Board limited public comment to three (3) minutes.

Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process rights of an individual, the Board may have refused to consider public comment (see NRS 233B.126). Please be aware that after the quasi-judicial Board rendered a decision in the contested case and, assuming this happened before adjournment, the Board may have entertained public comment on the proceeding.

1. Call to order and roll call of Board Members.

The meeting was called to order at 9:01 a.m. on June 7, 2023, by Chair Elisabeth Barnard. Board members in attendance included Secretary/Treasurer Rebecca Dorangricchia, Lorna Benedict, Christine Garvey, Rosemarie Mueller, Bianca Smith, and Sgt. Aaron Fink with the Las Vegas Metropolitan Police Department. Additional attendees included Board Counsel Colleen Platt and Executive Director Sandy Anderson. Stephanie Tsanas joined the meeting at 9:30 a.m. Vice Chair Deirdre Strunk and John Teng were excused. Secretary Treasurer Rebecca Dorangricchia was excused at 12:42 p.m.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Chair Barnard read the mission statement into the record.

3. Public comment – Members of the public who wish to participate in a public meeting may do so by providing public comment during the two designated public comment periods. Additionally, public comment options may include, without limitation, telephonic or email comment. Action may not be taken on any matter brought up under public comment until scheduled on an agenda for action at a later meeting. The Board will not restrict comments based on viewpoint. The opportunity for public comment will be available at the beginning and ending of the meeting. (Discussion Only)

No public comment was provided.

The Executive Director advised the Board that no written public comments were submitted prior to the meeting.

  - a. Strategic Plan Key Indicators

Licensure and renewals - Management Analyst VanHorn provided information regarding the Licensing Teams activity during 2022. The Board issued 210 new licenses and renewed 1555 licenses.

Inspection Team calendar year-to-date key indicators – The inspection team has completed inspections at 38.7% of the establishments statewide.

Investigations – Staff has opened 55 investigations year-to-date and closed 54. The average processing time is 33 days.

b. Other topics

The IMpact was adopted by the Legislature as part of SB 161.

The Executive Director advised the Board that she will be retiring during fiscal year 2024 after she completes her obligation to serve on the Board of Directors for the Federation of State Massage Therapy Boards which will be complete on September 30, 2023 and finalizing the annual audit.

as well as the appropriate adjustments for the Public Employees Retirement System contributions, seconded by Stephanie Tsanas. Motion passed.

The Executive Director advised the Board that the funds have not been deposited into a CD at this time. The current interest rate on the account is 4.1%. If a certificate of deposit that meets the state standards and is short term becomes available, the funds will be transferred at that time.

The Board's budget was built to allow for two (2) attendees. The Board selected Chair Barnard and Board Counsel Platt to attend.

Motioned by Bianca Smith to designate Elisabeth Barnard as the delegate and for Bianca Smith to attend, seconded by Elisabeth Barnard. Motion carried.

13. Discussion and possible action regarding developing a succession plan for the employment of a new Executive Director including, without limitation, identifying how recruitment for the position will be completed. (For Discussion and Possible Action)

Motioned by Bianca Smith to implement Sandy and Colleen as the recruitment committee; they shall post the job recruitment for 30 days; they will make the initial cuts; and they shall select not less than three nor more than 5 individuals to appear before the board, seconded by Rosemarie Mueller. Motion carried with no opposition.

14. Discussion and possible action regarding defining sexual misconduct. (For Discussion and Possible Action)

Board Counsel Platt reviewed the sexual misconduct regulations for the State of Washington medical providers as compared to NAC 640C.410 and shared the findings with the Board.
