I know that with the proper training and the granted privilege of a license I will not only be able to help heal people. but also to restart and rebuild my life in a career that I am passionate about. Please grant me the opportunity to not only rebuild my life but to do it through one of my passions as a career. If I am able to go before the board and provide you with a detailed account of my past and the diligent work and education I have completed in the time I was incarcerated it would be appreciated.
