Ms. He never received notice of the hearing. In her attached Declaration in Support of Motion for Reconsideration, Ms. He informs the Board that her now ex-husband intercepted the Notice of Hearing and deliberately did not inform her it had been sent to her. Ms. He's now ex-husband had forced her to work at the Ste. Rose Day Spa, and had committed acts of domestic violence upon her for not making enough money on a daily basis to keep him from having to work himself. When got arrested, her ex-husband committed an act of domestic Ms. He violence upon her and she then went to stay with a friend for some time. Eventually, she returned to their home. However, her ex-husband attempted to insist that she continue to work and to prostitute herself, so Ms. He left him. Ms. He moved out of the home to stay with friends. Mr. Wang retained the mailbox key and would not allow her to access her mail. When the Notice of Hearing was sent, her ex-husband kept it himself. When Ms. He received the Order of Revocation, she confronted her ex-husband, who then showed her the Notice of Hearing he had withheld.

Upon receiving the Order, Ms. He contacted her attorney, who immediately contacted Ziwei Zheng at the Attorney General's office, who represents the NVBMT. Counsel explained the situation, and asked Ms. Zheng if he could get the matter on calendar to seek reconsideration of

the Board's decision. Counsel informed Ms. Zheng that, had he been aware of the hearing, he would have advised his client that he would have attempted to execute a voluntary surrender of her massage license for a period of three years, with no fine, which is a negotiation counsel has executed many times previous with the Massage Board. Ms. He indicated she would have accepted counsel's advice and surrendered her massage license.

Li Hui He now requests that the NVBMT place this matter on calendar for reconsideration of the Board's decision made without Ms. He receiving actual notice of the hearing and therefore not participating in the hearing. Ms. He asks the Board to reconsider the 10 year revocation and allow her to voluntarily surrender her license for a period of three years. Also, Ms. He requests that the Board reconsider the imposition of the \$5000 fine and \$1000 fee, as she has no way to pay those amounts.

DECLARATION OF LI HUI HE

I, LI HUI HE, hereby do swear and affirm under penalty of perjury that the following is true and correct:

1. I am the person named in the above- encaptioned matter. I applied for and was licensed by the Nevada Board of Massage Therapy, Massage License Number 10915.

2. I was previously married to a man named Wang Lingyun. We are now divorced. We had a difficult marriage, and he forced me to work in several Asian massage businesses. As part of that work, my ex-husband forced me to make money by engaging in prostitution. I was arrested for soliciting prostitution on two occasions while working at those massage businesses.

3. I was the victim of domestic violence on several occasions as a result of my ex-husband demanding that I make money by engaging in prostitution.

4. After the last act of domestic violence, I moved out of our shared home. I was staying temporarily with friends. The Nevada Board of Massage Therapy apparently sent Notice of Hearing during this time period. My ex-husband did not notify me that he had received the Notice of Hearing, and in fact he hid it from me.

5. As a result of my not receiving notice, I did not attend the hearing at which my license was revoked and I was fined a total of \$6,000 in fines and investigative fees.
