SUMMARY SUSPENSION OF LICENSE

This matter having been considered by REBECCA DORANGRICCHIA, Chairperson of the Nevada State Board of Massage Therapy ("Board") and following investigation by the Board, and for good cause appearing, pursuant to the provisions of NRS 233B.127, the Chairperson finds as follows:

FINDINGS OF FACT

1. ALFRED E. SMITH IV ("SMITH") is licensed by the Board as a massage therapist, pursuant to the provisions of Nevada Revised Statutes and Nevada Administrative Code chapters 640C, license no. 12368.

2. SMITH is subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C and NAC Chapter 640C.

3. On or about February 8, 2025, while working for BigToeYoga, SMITH performed an in-room massage in the hotel room of client L.E. During said massage, SMITH improperly draped L.E.'s body leading to multiple instances of breast exposure. SMITH further entered L.E.'s underwear and forcefully digitally penetrated her vagina.

4. During the above referenced massage, SMITH told female client L.E. that he wanted to have sex with her. After L.E. rejected this offer, SMITH continued to make sexual advances including trying to kiss her.

5. As a result of the foregoing conduct, SMITH acted unprofessionally in violation of NAC 640C.410(1)(b)(13), (18), (21) and/or (28) and NRS 640C.700(2), (4) and/or (9).

1 CONCLUSION

2 6. SMITH's conduct referenced in the above facts demonstrates that his continued practice
3 of massage therapy poses a threat to the public health, safety, and/or welfare of the public such that
4 emergency action is required.

5 7. SMITH's license, NVMT.12368, is hereby summarily suspended pending proceedings
6 for revocation or other action, pursuant to NRS 233B.127.

8 ORDER

10 IT IS HEREBY ORDERED that ALFRED E. SMITH IV's license to practice as a massage
11 therapist in the State of Nevada, NVMT.12368, is hereby immediately **SUMMARILY SUSPENDED**
12 pursuant to NRS 233B.127. THE SUMMARY SUSPENSION HEREBY ORDERED is effective upon
13 the Chairperson's execution of this Order. A hearing for revocation and/or other administrative penalty
14 as set forth in NRS 640C.710 of SMITH'S license is scheduled for **May 7, 2025, commencing at 9:00**
15 **a.m., or as soon thereafter as the Board is able to hear the matter, with video conferencing by**
16 **Zoom.**
