2	reporting to all appropriate agencies and becomes part of her permanent record.
3	10. Hadfield shall complete 24 hours of ethics courses provided by the Federation of State
	Massage Therapy Boards in addition to required continuing education.
4	11. Hadfield shall come before the Board in person every two (2) years at time of renewal.
5	12. Hadfield must cooperate fully with the Board staff to administrate terms of her probation.
6	13. Hadfield is responsible for all administrative fees incurred by the Board as a result of her
7	probation compliance.
8	14. Hadfield is to comply with all laws governing massage therapy.
9	15. This order shall not be construed as excluding or reducing any criminal or civil penalties or
10	sanction or other remedies that may be applicable under federal, state, or local laws.
11	16. Hadfield's license shall be marked "Restricted" throughout the probationary period.
12	17. Hadfield shall meet with the Board or its representatives upon request and shall cooperate
13	with representatives of the Board in her supervision and investigation of Hadfield's
	compliance with the terms and conditions of this Order.
14	18. This Order will become part of Hadfield's permanent record, will become public
15	information, will be published with the list of disciplinary actions the Board has taken,
16	and may be reported to any national repository which records disciplinary action taken
17	against licensees or holders of certificates or any agency or another state, which regulates
18	the practice of massage therapy. The Board may use the Order in any subsequent hearings.
19	19. Hadfield acknowledges that if she violates one or more of the terms of this Order, the
20	Board may revoke or invoke other appropriate discipline against her license to practice
21	massage therapy; subject only to the requirement that the Board shall, prior to such
22	disciplinary action, conduct a hearing in accordance with Chapters 233B, 622A, and 640C
232-202	of the Nevada Revised Statutes for the limited purpose of establishing that there has, in
23	fact, been a violation of the requirements of this Order. In the event that a violation of this
24	Order is alleged, Hadfield agrees to surrender her license to the Executive Director, if so
25	requested, and refrain from practicing as a massage therapist until an entry of a final order
26	of the Board or a court of competent jurisdiction, whichever last occurs, regarding the
27	potential violation. Hadfield agrees to waive her right to appeal the substantive legal basis
28	of the disciplinary action. In the event an alleged violation of this Order is taken to hearing
