(NRS 640C.320, 640C.330) A massage establishment, reflexology establishment or structural integration establishment shall ensure that the massage establishment, reflexology establishment or structural integration establishment is:

1. Kept clean and free of litter or rubbish;
2. Maintained in a neat and orderly manner;
3. Not used to facilitate sexual activity during the course of practicing massage therapy, reflexology or structural integration; and
4. Not used to facilitate unlicensed activity.

2. You may submit a written request to the Board for approval of a fine payment schedule.

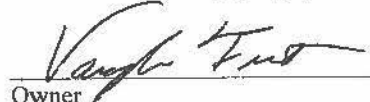
