Dear Establishment owner:

It has been brought to our attention that your establishment was used to facilitate sexual activity during the course of practicing massage by Yu Feng Chen on June 25, 2025. Therefore, enclosed you will find a citation for a violation of NAC 640c.310(3):

NAC 640C.310 Duties of establishment: Maintenance of establishment; ensuring no sexual or unlicensed activity occurs at establishment. (NRS 640C.320, 640C.330) A massage establishment, reflexology establishment or structural integration establishment shall ensure that the massage establishment, reflexology establishment or structural integration establishment is:

1. Kept clean and free of litter or rubbish;
2. Maintained in a neat and orderly manner;
3. Not used to facilitate sexual activity during the course of practicing massage therapy, reflexology or structural integration; and
4. Not used to facilitate unlicensed activity.

You may comply with the citation in one of the following three ways:

1. You may remit a copy of the citation and a cashier's check or money order in the amount of the fine stated on the citation to our address listed above.
2. You may submit a written request to the Board for approval of a fine payment schedule.
3. You may appeal the issuance of the citation by submitting a written request to the Board at the address listed above.
