Narrative

On 11/13/2024, Rebecca White came into the Northwest Area Command to report the following:

Rebecca advised that on 11/12/2024 at approximately 1000 hours, she went to the Massage Well, located at 5300 West Sahara avenue, for a scheduled two hour massage. Rebecca stated that she has visited this location in the past with no issues. Rebecca advised that she filled out the massage questionnaire that asks her which pressure she would like, and which areas she would like the massage therapist to focus on. Rebecca stated that she was walked to a room by a massage therapist that she had previously been assigned, but realized later that this was not the person who ended up giving her a massage.

Rebecca advised that after undressing, a male knocked on the door and then entered the room and started the massage with her lying face down, naked underneath a sheet. Rebecca stated that the massage therapist, whose name tag said "Mike", began massaging her shoulders, neck, and bag. Mike then moved to Rebecca's legs and buttocks area. Rebecca advised that she was still covered during this portion of the massage, and Mike proceeded to the hot oil and stones, which is what she booked.


Rebecca stated that Mike then pulled her arms behind her in order to stretch her shoulders, and this caused her breasts to rise off of the table and be exposed to Mike. Rebecca advised that she has never experienced being exposed like that, but it happened so quickly that she did not say anything about it. Rebecca stated that Mike then wiped the oil off and continued to massage her arms and legs. Rebecca advised that it was at this point that Mike got very close to her vagina, but he didn't touch there during the massage.

Rebecca stated that it was then time for her to turn over on her back, at which point she still had a sheet covering her body. Rebecca advised that Mike began massaging her collar bone while the sheet was placed at the start of her breasts. Rebecca stated that it was at this point, Mike began stroking her breasts, while cupping and massaging them. Rebecca advised that Mike then began twisting and massaging both of her nipples in his hands simultaneously. Rebecca stated that she moved her arms from her side and pulled the sheet up to her chin and told Mike to stop and move on.

Rebecca advised that Mike continued to stroke her nipples, which left her frozen in fear on the table, unable to move her arms. Rebecca stated that Mike did eventually stop, at which point she covered her chest with her arms. Mike then pulled Rebecca's arms aside and proceeded to wipe off the massage oil with a warm, wet towel. Rebecca advised that she didn't want Mike to touch her anymore, but she didn't know how to tell him to stop. Rebecca stated that Mike continued to massage her legs and arms, and eventually ended the massage.

Rebecca advised that when she checked out, she didn't feel comfortable speaking to the Manager because Mike was standing uncomfortably close to her, maybe only two or three feet away. Rebecca stated that the whole time she was checking out, Mike had a creepy smile on his face and kept saying, "thank you! thank you!". Rebecca advised that once she left, she spoke with the Manager regarding her experience and told them everything that had happened. Rebecca stated that the Manager advised her that Mike's wife also works at the business, and also advised her that he is going to be firing Mike.

DETAILS:

On Tuesday November 12, 2024, I arrived at Massage Well at 5300 W Sahara Ave for a scheduled 2 hour massage. I have visited this location in the past. I filled out the massage questionnaire related to pressure I would like, areas of focus and payment agreement. I was walked to my room by a masseuse I previously had, although I later realized this individual did NOT conduct my massage. After being led to the first massage room, I was left to undress and lay under the sheet on the massage table. The masseuse (male) knocked on the door after a few minutes - I was already under the sheet, naked - the massage started with me face down. The male masseuse started focusing on my shoulders and back with the sheet covering my entire body. After ~~me~~ massaging my shoulders, neck and back, he proceeded to my legs and buttocks. I was still relatively covered during this portion of the massage. Next, the massage moved on to hot oil and stones - all part of what I booked. The male masseuse then pulled my arms behind me to stretch my shoulders and in the process, my breasts rose off the table, exposing them in front of him. I have never

experienced being exposed like this but did not say anything at that time as it lasted approximately 5-10 seconds. I was uncomfortable being exposed with my breasts off the table in front of the male masseuse. After the stretch, the masseuse wiped the oil off, placed hot towels on my back and massaged my arms and legs. He got very close to my vagina but did not touch there while massaging. All oil was then wiped off. It was then time to turn over onto my back. He held the sheet somewhat modestly while I turned over. He began massaging my neck/shoulders from the front. It was then that he started massaging my collar bone area. At first I did not notice his hands move beneath the sheet. The sheet was placed at the start of my breasts as I was laying face up. His hands moved beneath the sheet and began stroking my breasts, cupping them and massaging them. I froze immediately and did not know what to do. His hands continued to stroke me and he began twisting and massaging my nipples in his hands, both sides simultaneously. I was incredibly uncomfortable and told him "stop, move on". I moved my arms from my side, and pulled the sheet all the way to my chin and told him again "move on stop!" as he was continuing to stroke my nipples. I was frozen in fear on the table. unable to move more than my arms. He did eventually stop, after what felt like an eternity. I blocked my chest with my arms, he pulled my arms aside and then proceeded to wipe massage oil away with a warm, wet towel. I didn't want him to touch me anymore but I didn't know how to tell him to stop - I felt paralyzed. He continued massaging my legs, arms and eventually it ended. I rushed to get dressed. He ~~is~~ When he completed the massage I saw his name tag said MIKE - I've never had this masseuse before and I never want his hands on me again. my heart was racing as I wanted to escape out of there as fast as possible. He lingered right outside the room as I got dressed and used the restroom, and stood only 2-3 feet away from the manager + myself as I checked out. He had this creepy smile the entire time I was paying and kept saying "thank you, thank you!" with a ~~huge~~ smile that makes me sick to my stomach. The manager asked me how everything was and I couldn't tell him to his face with MIKE right there lingering, but I called the massage parlor right after leaving and spoke with the manager, regarding my experience. I told the manager everything - I can't stop replaying how his hands were touching me where they shouldn't have been and how fearful I was that more could have happened.
