SUMMARY SUSPENSION OF LICENSE

This matter having been considered by REBECCA DORANGRICCHIA, Chairperson of the Nevada State Board of Massage Therapy ("Board") and following investigation by the Board, and for good cause appearing, pursuant to the provisions of NRS 233B.127, the Chairperson finds as follows:

FINDINGS OF FACT

1. MAUNG T. MYINT ("MYINT") is licensed by the Board as a massage therapist, pursuant to the provisions of Nevada Revised Statutes and Nevada Administrative Code chapters 640C, license no. 12355.

2. MYINT is subject to the jurisdiction of the Board and the provisions of NRS Chapter 640C and NAC Chapter 640C.

3. On or about October 12, 2024, MYINT, while working at Imperial Spa located at 1070 E Sahara Ave, Las Vegas, Nevada 89104, during the course of providing a massage to a female client, C.J., did intentionally move her underwear to the side, where he proceeded to make contact with her vagina along with grabbing her right hand and placing it over his erect penis, which was covered in clothing.

4. MYINT was arrested and criminally charged as a result of the foregoing activities (LLV2410000046279).

5. On or about March 24, 2025, MYINT pleaded guilty, as part of a plea agreement, to charges of misdemeanor engaging in lewd conduct in a public place and misdemeanor engaging in an

1 obscene/indecent/immoral act. As part of this plea agreement, MYINT was given a 180-day suspended
2 jail sentence and ordered to "stay out of trouble" for one (1) year. (Case No. 25-CR-007433)

3 6. As a result of the foregoing conduct, MYINT acted unprofessionally in violation of NRS
4 640C.700(2), (4) and/or (9).

5 CONCLUSION

6 7. MYINT's conduct referenced in the above facts demonstrates that his continued practice
7 of massage therapy poses a threat to the public health, safety, and/or welfare of the public such that
8 emergency action is required.

9 8. MYINT's license, NVMT.12355, is hereby summarily suspended pending proceedings
10 for revocation or other action, pursuant to NRS 233B.127.

14 IT IS HEREBY ORDERED that MAUNG T. MYINT's license to practice as a massage
15 therapist in the State of Nevada, NVMT.12355, is hereby immediately **SUMMARILY SUSPENDED**
16 pursuant to NRS 233B.127. THE SUMMARY SUSPENSION HEREBY ORDERED is effective upon
17 the Chairperson's execution of this Order. A hearing for revocation and/or other administrative penalty
18 as set forth in NRS 640C.710 of MYINT'S license is scheduled for **May 7, 2025, commencing at 9:00**
19 **a.m., or as soon thereafter as the Board is able to hear the matter, with video conferencing by**
20 **Zoom.**
