Public Comment Agenda Item: There was a time designated at the beginning of the meeting and the end of the meeting for Public Comment. Members of the general public may bring matters not appearing on this Agenda to the attention of the Board or make comment on specific agenda items. Public comment may also be taken at other such times as requested as long as the request for public comment will not interrupt ongoing Board business. The Board may discuss the matters not on the agenda but may not act on the matters at this meeting. If the Board desired, the matters may be placed on a future Agenda for action. In consideration of others who may also wish to provide public comment, please avoid repetition. The Board limits public comment to three (3) minutes.

1. Call to order and roll call of Board Members.

The Meeting was called to order 9:14 a.m. on May 28, 2025, by Chair Rebecca Dorangricchia. Board members in attendance included Vice Chair Paula Wilber, Secretary-Treasurer Jenn Ty, Lorna Benedict, Rosemarie Mueller, Bill Schoen, John Teng, Stephanie Tsanas, and Sgt. Evan Fincher with the Las Vegas Metropolitan Police

Department participated telephonically. Additional attendees included Board Counsel Colleen Platt and Executive Director Elisabeth Barnard.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Dorangricchia read the mission statement into the record.

3. Public comment – Members of the public who wish to participate in a public meeting may do so by providing public comment during the two designated public comment periods. Additionally, public comment options may include, without limitation, telephonic or email comment. Action may not be taken on any matter brought up under public comment until scheduled on an agenda for action at a later meeting. The Board will not restrict comments based on viewpoint. The opportunity for public comment will be available at the beginning and ending of the meeting. (Discussion Only)

No attendees at the meeting offered any public comment. No written public comment was received prior to the meeting.

The application of Ms. Williams was presented for review by the Board. Williams was present.

Williams answered questions from Board members.

Schoen motioned to approve Williams application. Seconded by Tsanas. Motion carried, none opposed.

Ms. Lin was present with legal counsel Kirk Kennedy. Wei Mai Borgel was present as Mandarin interpreter.

The application of Lin was presented for review by the Board.  
Kennedy made a statement on Lin's behalf. The Board asked clarifying questions.

Wilber motioned to approve the application and immediately place the license on probation for two (2) years. Licensee to not perform outcall massage, report contact with law enforcement within 48 hours, must work at an establishment, take three hours of ethics courses in each year of probation. Seconded by Benedict. Motion passed with Schoen opposed.

Dorangricchia motioned to approve the consent agenda as presented. Seconded by Mueller. Motion carried with none opposed.

Barnard reviewed the current numbers of licenses: Total 5,648 licenses. As of May 27, there are 5,605 massage licenses, 26 reflexologists, and 18 structural integration practitioners. There have been 105 new applications received in April and through May 25 which is an increase from our average.

Compliance Investigator Brunner gave the Board an update on inspections, complaints, and investigations for the year to date. 493 establishment inspections have been completed of 908 for the year. Giving a completion rate of 53% at almost halfway through the calendar year. Follow-up inspections are currently at 90%, although follow-up inspections are a fluid number. 260 of 325 outcall inspections have been completed, an 80% completion rate.

Investigations for the calendar year to date there are 7 open cases, 49 cases have been closed.

Barnard let the Board know that the Counsel for Licensure and Regulation (CLEAR) will be offering a virtual attendance option for their Annual Education Seminar in September if any Board members are interested.

Barnard stated that she plans to update the FY26 budget with some increasing costs that are showing up. She hopes to proceed with the approved computer equipment upgrades in August.
