participated telephonically. Additional attendees included Executive Director Elisabeth Barnard and Board Counsel Colleen Platt.

2. Mission Statement of the Nevada State Board of Massage Therapy – To protect the public health, safety, and welfare through effective massage therapy regulation. Insuring that qualified, competent, ethical practitioners are licensed.

Dorangricchia read the mission statement for the record.

Schoen motioned to revoke Silu Liu's license, NVMT. 12234, for five (5) years, impose fines of \$5,000 per count, totaling \$20,000 in fines, and costs to the Board not to exceed \$1,000. Fines and fees to be paid within five (5) years. Seconded by Wilber. Motion carried unanimously.

Deputy Attorney General Joseph Ostunio called Heather Thompson as witness. Platt swore Thompson in. Thompson provided testimony regarding the event.

Exhibits 2 and 3 were admitted by Dorangricchia.

The Board discussed the case.

Motioned by Schoen that the allegations are fact and did occur. Seconded by Wilber. Motion carried unanimously.

Motioned by Mueller that the violations of law, counts 1 through 5, as stated in the complaint and notice of hearing did occur. Seconded by Wilber. Motion carried with none opposed.

Schoen motioned to revoke Montanari's license, NVMT. 11589, for ten (10) years, impose fines of \$5,000 per count, totaling \$25,000 in fines, and costs to the Board not to exceed \$2,000. Additionally, to impose a public reprimand upon the respondent. Fines and fees to be paid within five (5) years. Seconded by Mueller. Motion carried with none opposed.

Barnard reviewed the current number of licenses as of Monday, August 11, 2025: Total 5,655 licenses. There are 5,613 massage licenses, 26 reflexologists, and 16 structural integration practitioners. Renewals were current as of August 7.

679 establishment inspections have been completed of 917 for the year. 103 of 112 follow-up inspections have been completed. 782 inspections in total have been completed.

561 establishment certificates have been issued.

293 of 325 outcall inspections have been completed.

77 complaints have been received for the year. 74 complaints have been closed. 7 complaints remain open.

Board members asked questions regarding the Executive Director Report.

Barnard will be attending the Board of Directors meeting for the Federation of State Massage Therapy Boards. The Federation will be celebrating 20 years at their Annual Meeting in Kansas City in October.

Barnard also noted that it is the 20th anniversary of the Nevada State Board of Massage Therapy.

The card and ID printer is down for maintenance. New computers will be purchased this year.
